With ref. to above-referred RTI, Para wise replies of questions raised by the applicant are as under (For CP-201):

Name of the applicant	Questions raised by the applicant	Remarks
Rahul Thakur	Provide copies of all certified Requests for Inspection (RFI) submitted by the CP 201 and CP 202 Contractor for inspection of track fitment between entire chainages in 5km chainage wise.	It is not mandatory that RFIs be generated strictly on a 5 km basis; the length may vary depending upon the actual execution at site.
	Provide copies of inspection/approval notes issued by DFCCIL/Engineer corresponding to these RFIs, indicating speed certification (e.g., track fit for 10 kmph, 20 kmph, 30 kmph, 100 kmph, etc.) and date of such certification covering the CP 201 and CP 202 entire chainages in 5 Km chainage wise.	The Contractor raised the RFIs in accordance with the approved methodology, and the PMC/DFCCIL, after due consideration of the actual site conditions, either approved or rejected the same. Any remarks or notes, wherever applicable, were duly recorded in the respective RFIs.
	Provide the date-wise records of when the track section in CP 201 and CP 202 was first certified fit for movement at restricted speed (10 kmph / 20 kmph) chainage wise or preferably 5 km chainage wise.	Track fitness for various locations/stretches under CP-201 was certified by PMC/DFCCIL from time to time, based on the RFIs submitted by the Contractor.
	Provide copy of certification when it was subsequently certified for higher operational speed, after distressing/stabilization.	Certification for operational speed of 100 kmph was recorded in the respective RFIs for the corresponding locations/stretches.
	If no such RFI/inspection records are available for any section or partial non availability of such records, kindly confirm in writing that no RFI was submitted or no certification was granted for that section during the above period.	All RFIs related to the matter are available.

Note: Supporting Document for all above queries are about approximately 1.25 lakhs pages which includes A1 size paper. Total Cost comes approximately Rs 2,50,000/- (1,25,000x2). Applicant may confirm the deposit amount so that DFCCIL may take further necessary action. This cost is purely in approximate basis and may increase/ decrease as per the actual execution. Further this cost is only for CP-201 only.
