The Entitlement Matrix in accordance with new Land Acquisition Act, 2013 was issued vide ref (iii) above. Regarding option of employment with the affected family, following has been prescribed in the Entitlement Matrix (Item 4 of Second Schedule):

"Suitable provisions will be made and disclosed in line with the extant LawfRules as obtaining in lie concerned States at the lime of acquisition".

- DFCCIL vide letter at ref (i) has furnished the status of Law/Rules in nine States through which DFC alignment is passing. Out of the nine States, only in Maharashtra, the State rules prescribe policy guidelines for employment, which have not been implemented by the State so far. Further as per DFCCIL letter at ref (i), in West Bengal, Bihar, Iharkhand, Uttar Pradesh and Rajasthan: as per the rules notified by the States, employment will not be provided. In Haryana, Punjab and Gujarat also, there are no guidelines of the State for employment as on date.
- As per DFCCIL letter at ref (ii), the maximum land has to be acquired in the State of Uttar Pradesh as per new Land Acquisition Act, 2013 where provision of one time payment in lieu of employment has been proposed.
- In view of the above position of no provision of employment in the States concerned, DECCIL may take further action in accordance with extant Law / Rules as obtaining in the concerned States and Entitlement Matrix issued vide rel (iii) above.
