The information/relevant document have been sought by Applicant Sh. Anupam Mukherjee vide RTI Registration No. DFCCIL/R/E/23/00559 dated 12.08.2023. Accordingly reply was sent to JGM/Admn(CPIO) vide this office letter no. KKK /EN /RTI /4 / Pt.-III/1330 dated 23.08.2023.

Aggrieved by the reply, the applicant has raised RTI Appeal no. DFCCIL/A/E/23/00066 dated 10.09.2023. The appeal of the applicant has been gone through by the Competent Authority. The comments against the points raised by the applicant in its appeal (1st table) as well as modified information against RTI application no. DFCCIL/R/E/23/00559 dated 12.08.2023 (2nd table) is produced as below:

Appeal raised by the applicant (Appeal no. DFCCIL/A/E/23/00066 dated 10.09.2023)	Remarks by DFCCIL
In reference of the RTI appeal no. DFCCIL/A/E/23/00066 dated 10.09.2023 the reply of the original RTI is resubmitted sl. no. wise as below-I had posed six questions to the CPIO. The first two questions were as follows:- 1. Site Map disclosing the area that is hit by the acquisition. 2. Detailed calculation of the area of the structure that is hit by the acquisition. The information as to the above two questions is held by the DFCCIL, as DFCCIL is the requisitioning body. It is the DFCCIL that has finalised the acquisition plan and come up with the idea how much land in which plot is required. Jurisdictional District Magistrate is only an executing authority of that acquisition plan. So, the information as to the above two questions is held by the DFCCIL and it has no escape from giving the information by pointing out that the information is rather available with the jurisdictional District Magistrate. But, in the instant case, the CPIO of DFCCIL has escaped giving information as to the second question mentioned above, and has referred the same to the jurisdictional District Magistrate saying that information is only available with that	Earlier this office has informed vide reply of RTI no. DFCCIL/R/E/23/00559 that calculation of the area of structure is available with Competent Authority & Additional District Magistrate (Land Acquisition), Paschim Bardhaman". Now details available in this office have been scrutinized and modified reply is given under Sl. no. 2 of second table.

District Magistrate. I am aggrieved with such reply of the CPIO and hence prefer this First Appeal.

Secondly, I have been provided a scan of the site map. The scan is so poor that it is unreadable. The scan gives a hazy and blurred image of the relevant site, with no information given therein being readable even by use of a high-powered magnifying glass.

Moreover, the scan has been done in a manner that most of the information appearing on the right side and at the bottom of the Site Map has not been captured. Those pieces of information have been left out in the scan of the site map that has been sent by the CPIO.

Sir, "providing information" under the RTI Act means providing information in a manner that the same is at least readable and complete, and not half being captured and the rest being left out.

Giving information in a manner that the same turns out to be unreadable, or providing a scan of the Site Map wherein any information appearing at the bottom or at any other part of the Site Map is not captured and is let out, is not at all a compliance of the RTI Act.

Sir, compliance of the RTI Act means real and effective compliance of the same, and not farcical or illusory compliance of the same. In the instant case, the compliance by the CPIO has been only farcical and illusory. This is another reason why I am constrained to prefer this First Appeal.

Kindly provide me a legible and readable copy of the complete Site Map, with no portion of the same being left out, and also provide me the detailed calculation of the area of my structure that is hit by the acquisition plan that has been finalised by the DFCCIL.

The Applicant aggrieved that he has provided with an unreadable copy of site plan under reply of RTI no. DFCCIL/R/E/23/00559. Soft copy of scanned land plan approved by Competent Authority & Additional District Magistrate (Paschim Bardhaman) was provided to applicant. However, if applicant desires to get hard copy of the approved site plan, it will be provided after deposition of Rs.300/- (for A3 size colour printing).

Modified reply is given under Sl. no. 2 of second table.
