1. Since the plot no. 1236 and 1238 in falling in Dumra mouza which is under rural area, 2 times of land rate determined as per Section 20F of Railway Act 1989 has been considered in determining the land compensation and over that land compensation additional solatium @100% is also given to land loser.
2. Compensation for rural houses (Pakka Makan) have been determined by Competent Authority-cum-Land Acquisition Officer Gaya.
3. The Govt. rate determined by Competent Authority-cum-Land Acquisition Officer for acquisition of Plot No.1238 and plot no. 1236 is Rs.11,64,305/- per acre.
4. Since valuation was done by Competent Authority-cum-Land Acquisition Officer Gaya, so value list is not available with this office.
