Sub: Commencement date of Commercial Operation of New Khurja to New Bhaupur section over EDFC and Madar (IR) to New Rewari section over WDFC.

Vide circulars under reference (1), Station details and other information were notified for commissioning of New Khurja to New Bhaupur over EDFC and Madar (IR) to New Rewari section over WDFC. In continuation of these circulars, the commencement date of commercial operation for these sections are as under:

- 1. Railway Board conveyed the approval for opening of New Khurja to New Bhaupur section of EDFC over DFC network in terms of provisions of clause 15.1 (b) of the Concession Agreement vide letter dt. 28.12.2020 under reference (2). New Khurja to New Bhaupur section was inaugurated by Hon'ble Prime Minister on 29.12.2020. The commencement of commercial operation of this section will be treated as 29.12.2020.
- 2. Railway Board conveyed the approval for opening of Madar (IR) to New Rewari section of EDFC over DFC network in terms of provisions of clause 15.1 (b) of the Concession Agreement vide letter dt. 06.01.2021 under reference (2). Madar (IR) to New Rewari section was inaugurated by Hon'ble Prime Minister on 07.01.2021. The commencement of commercial operation of this section will be treated as 07.01.2021.
