On the basis of your performance in the Computer Based Test and on being found medically "FIT" in the medical fitness test, the Competent Authority is pleased to offer you an appointment in DFCCIL for the post of **Executive (Operations and Business Development) in Grade E0 Scale of Pay Rs 30000-120000 (IDA) plus admissible allowances subject to the following terms and conditions.**

- i. You will be governed by DFCCIL's Service Rules, Conduct, Disciplinary & Appeal Rules etc. and administrative orders as issued/amended from time to time.
- ii. You are liable to be posted/ transferred, to any part of India as per administrative requirement. In the normal course, you will be posted in the Offices/project Sites of the Company.
- iii. As per DFCCIL's (Conduct, Discipline & Appeal) Rules, you will not be eligible for an appointment, if
  - a. You have entered into or contracted a marriage with a person having a spouse living,  
**OR**
  - b. You have a spouse living, having entered into or contracted a marriage with any person.

- iv. - vi.
