However; Railway Board has provided mandate to DFCCIL for undertaking and preparing Detailed Project Reports (DPR), for the three new DFCs –(i) Package-1-East-Coast Corridor - Section- Kharagpur to Vijayawada (ii) Package-2-East-West Sub Corridor comprised of sub Corridors-Bhusaval-Nagpur-Kharagpur- Dankuni and sub Corridor -Rajkharswan-Kalipahari-Andal & (iii) Pacakge-3-North-South sub Corridor comprised of Section- Vijayawada- Nagpur – Itarsi. In this direction & in addition, It is conveyed that, the Consultant for the preparation of DPRs for the aforesaid new DFCs [Package-1, 2 &3, above] has been engaged and the work of DPR Preparation has been taken up.
