2.	2		There is Government land (Khata No. 208 Plot no. 914) on east side of Khata No. 102, Plot No. 1224. Some part of this Govt. land was encroached (for cultivation) by adjacent land owner. After demarketing the exact boundary of Govt. land, land acquisition process for Khata No. 102, Plot No. 1224 started.
3.	3		Encroachment wae done by owners of Khata No. 102, Plot No. 1224. As per revenue record, land was under name of Punit Tiwari. As Punit Tiwari is dead, the ownemhip decided by DLAO/Aurangabad office is with Sri Raghuvansh Tiwari & Sri Harivansh Tiwari S/o Late Punit Tiwari and Smt. Kanti Devi W/o Yaduvansh Tiwari, Village -Pauthu, Thana- Jamhor, District -Aurangabad.

Point-wise reply to query raised under above referred RTI registration no. MORLY/E/2020/09203 dated 13.09.2020 is as under: -

1.	Construction of Railway Bridge my land having khata no. 102, Plot no. 1224 was not listed anywhere in the aforesaid approved Map & plan.	Due to error in measurement, Khata No. 102, Plot No. 1224 was not included in the first land plan developed for acquisition.
2.	Further, the aforesaid Map & Plan Khata No. 208, 145, 101, 145, 129, thana No. 106 of Village -Pauthu were supposed to be acquired by Govt. of India for the construction of aforesaid railway bridge.	Some more plots which were not included in the first lot of land to be acquired, were included in forthcoming Gazette of India vide CG-DL-E-07032020-218561 dated 05.03.20 and CG-DL-E-22102020-222646 dated 22.10.2020.
3.	Therefore, it is clear from the facts I had taken photograph and video of the spot as a proof of illegal work on 02 January 2020 at 4:59pm where illegal construction was going on. Photographs are attached herewith and video will be shown whenever ask for the same.	Work was done on Government Land (Khata No. 208, Plot no. 914 only in December'2019 and no work was done on Khata No. 102, Plot no. 1224. Due to error in measurement, part of the land of Khata No. 102, Plot no. 1224 which was required for construction of ROB at LC32 was not included in first lot of land acquired

		After receiving the complaint from the owners of Khata No. 102, Plot no. 1224, remeasurement was done and the requisite land was acquired later on for ROB work at LC32.
4.	All of sudden, I received a notice Hence I have a serious apprehension in my mind that they will falsely implicate me and my family in any false case.	The notice issued by DLAO/Aurangabad was in the process of land acquisition of part of the land of Khata No. 102, Plot no. 1224 for construction of ROB at LC no. 32.
5.	Therefore, you are requested to take Otherwise I will left with only option to file writ petition before honourable High Court Patna.	The construction work of ROB at LC32 is being done as per approved plan and is a legal work. The officials at site are responsible persons and are not involve in any wrong practice.
6.	I will be thankful to you for your favourable action.	DFCCIL will be thankful to you, if as a responsible citizen of country, you cooperate DFCCIL in completion of the ROB work at LC32.
