1. Approval of engagement of Works Engineer(Civil) on outsource basis(through contract) by Kolkata office has been approved by Corporate office of DFCCIL as a special case as communicated vide letter no HQ/HRORECT(MISC)/1/2021-HR/RECT DATED 15.06.2021(copy enclosed). Based on this approval, this office has processed for engagement of Works Engineer(Civil) by outsourcing through the process of open tendering.

2) This office does not have answer to this question.

3. As approved by DFCCIL Corporate office in its letter referred to in (1) above Kolkata office has been permitted to engage Works Engineer through outsourcing agency in terms of SOP/ G2.4. This process has been followed by this office.

4. This has been replied to at (3) above.

5. The reasons for the process adopted has been given at (3) above.

6. During the process of tender finalization, Tender committee member give a declaration.

At Kolkata office, no such declaration is taken in any contract including manpower contract. For overall DFCCIL, this office is not in a position to answer.
