However, based on query raised, matter have been referred to Corporate Office for advising appropriate similar nature of work as per the actual scope of subject tender work. Meanwhile, subject tender called with opening on 25.09.2024 has been cancelled and fresh tender will be reinvited as per advise from Corporate Office.
