It has been commented vide Para I that Accounts is not in a position to comment on this issue and in Para vi that Accounts department is not in apposition to comment on this issue as some aspects are needed to be chased with other departments concerned up for better appreciation. In this context, I have included the responses form the Railways pertaining to my RTI request made in 2013, along with form No 16 issued by the Railways. This documentation explicitly outlines the amounts of Income Tax that were deducted from my salary during the fiscal year 200809. It is kindly requested that the relevant officials, whether from the Accounts department or any other pertinent departments, be instructed to consider the evidence I have provided. This is particularly important if they are unable to offer comments on this matter. Such action will facilitate the resolution of the issue, allowing for (a) the clearance of the Income Tax department notices issued in my name, and (b) the reimbursement of the amounts deducted from me by the Income Tax department due to the underpayment of tax by the Railways.
