As per the current contract, salary of skilled person for maintenance of General Power Supply (E&M) items for DFCCIL stations, IMD, IMSD, Staff Quarters, RHs and CGM office etc. is Rs. 953.36+7.70% per day.
2.	What is the provision to remove the technician and operator from their post who is posted on the contract base.	As per current contract, the Contractor shall at once remove from the works any agents, permitted sub-contractor, supervisor, workman or laborer who shall be objected to by the Engineer and if and whenever required by the Engineer, he shall submit a correct return showing the names of all staff and workmen employed by him.
3.	How much salary of these posts is paid in the month of November.	The present contract is operated since May-2024. Hence the reply to this question does not arise.
