From the query, it is not clear as to which Notification the RTI applicant is talking about. In view of the non-specificity attached with the query, DFCCIL is not in a position to provide any information.
2)	Procurement Process: I) Share a digital copy of the complete tender/notice for procuring consultancy services or both types mentioned above	The query does not specify any Tender notification to which the query pertains to; DFCCIL has not issued any tender notice for procuring Consultancy Services from empaneled /shortlisted (by the DFCCIL) Consultants. As such, DFCCIL is not in a position to provide any information.
3)	- Project Assignment Process: I) Explain how empaneled consultants are selected for specific project post empan	The query does not specify any Tender notification to which the query pertains to; It is not clear as to what the term “Post empan” means. In case, the term is assumed to mean “Post empanelment”, the DFCCIL response would be same as previous above.
