1	<p>As per old policy No. HQ/HR/E2/Pt.I/201501794 dt 10.02.2016 PARA 3.4.4(ii) it has been stated that initially any shortfall of vacancies will be filled by absorption, deputation or direct recruitment keeping in view the promotional aspects of existing employees in these scales with the approval of MD after which (a) 50% by Direct recruitment. (b) 50% normally by promotion, shortfall if any, by absorption or Deputation. By seeing above policy para it is well clear that since 10.02.2016 provision was there to maintained the DRQ and DPQ quota as 50%-50%. The above policy was revised in the year 2020. As per new policy, DFCCIL Circular: 640/2020, (Letter No. HQ-HROCOPO(HRP)/1/2020-HR-COORD AND POLICY dated 16.10.2020). Refer para 4. Mode of filling the vacancies at various levels, According to this para for Cluster -D, 50% post shall be filled by Direct Recruitment and 50% post shall be filled by promotion from eligible E0/E1 grade. Kindly reply that, above mentioned paras (regarding filling of 50% post through promotion) has been followed during promotion through department CBT exam on 01.01.2021 &amp; 01.01.22 from Cluster -C to Cluster - D promotion in Electrical department.</p>	<p>Yes, All term and conditions apply for open market recruitment and Departmental promotion Examination.</p>
