


Sub: Provision of Employment to land losers affected by land acquisition for DFCCIL project.

References are frequently received from PAPs for providing appointment to one of the family members in terms of Railway Board letter no. E (NG)II/2010/RC-5/1 dated 16.07.2010.

2. In this connectin Railway Board vide letter no. 2014/Infra/17/5 daed 05.03.2014 has already clarified to North Western Railway that policy of providing appointment to land losers circulated vide Railway Board letter no. E (NG)II/2010/RC-5/1 dated 16.07.2010 is applicable to Railway and Production Units and not to Railway Public Sector Undertakings and hence not applicable to DFCCIL (copy enclosed).

3. References from PAPs on the aforesaid issue may therefore be dealt accordingly without referring the matter to Corporate Office. To maintain uniformity among different project units, if required, the reply may be given on the following lines:-

"Railway Board policy circulated vide letter no. E (NG)II/2010/RC-5/1 dated 16.07.2010 regarding appointment of land losers affected by land acquisition for railway projects is applicable only to Railway/Production Units and not to Railways Public Sector Undertakings (PSUs) and other Units. As such, this policy is not applicable to Dedicated Freight Corridor Corporation of India Limited (DFCCIL) as it is Public Sector Undertaking (PSU)".

As earlier clarified, Policy No. E(NG)II/2010/RC-5/1 dated 16.7.2010 regarding appointment of land losers affected by land acquisition for railway projects is applicable only to Railway/Production Units and not to Railways Public Sector Undertakings (PSUs) and other Units. This policy is not applicable to Dedicated Freight Corridor Corporation of India Limited (DFCCIL) as it is Public Sector Undertaking (PSU).

The above case may suitably be dealt on behalf of Ministry of Railways under intimation to this office.
