02	Jilla Magistrate has asked to build service road on both side of DFCC Railway track in immediate time manner, kindly provide me reasons of delay.	There is no provision to construct additional road on both side of Railway track & DFCC has not encroached the existing road portion except bridge location where RUB 7A with similar width has been constructed by DFCCIL.
03	Kindly provide me reason of not taking action since 31.07.2020, because letter was issued on 31.07.2020	The Village Road (Kachha Road) has already been repaired.
