

Accordingly, he was advised vide HR letter no. HQ/HR/4/Perma./Engg./2017 (201702255) dated 09.07.18 through CPM/MGS.</p> <p>His representation dated 25.07.2018 (SN.170/3) has referred to in the RTI application regarding review of his case of Permanent Absorption in DFCCIL not received in this office. However, there is no such provision in the rule for review of cases of such candidates who was found not suitable for Permanent Absorption by the Committee. Further the above employee has already been repatriated from DFCCIL.</p>
