1)	Please provide detailed information on land acquisition as per record.	From details made available, it appears that the applicant has sought information related to land acquisition at Mankar mouza, J.L. No.- 37, PS-Galsi under Purba Bardhaman District. The remarks is being submitted related to Mankar Mouza as,below  1st time notification u/s 20A of RAA, 2008 on 13.05.2013 lapsed as notification u/s 20E could not be done within due date due to public agitation.  Again, 2nd time notification u/s 20A of RAA, 2008 on 05.05.2015 lapsed as notification u/s 20E could not be done within due date due to public agitation.  To avoid such agitation, the ROW of DFCCIL has been critically reviewed and revised so that land requirement is minimized. After review, there is no requirement of land at present to be acquired in Mankar mouza.
