1	Item (I)	The provision mentioned under quote in applicant's letter is applicable for land, which forms part of any house, manufactory or other building within the meaning of Section 94.
2	Item (II)	DFCCIL has no such communication. However, DFCCIL is committed to implement all provisions of approved Entitlement Matrix as per RFCT-LARR Act 2013.
3	Item (III)	There is no exact definition of plot rendered uneconomic or has been severed due to land acquisition in the Act. The Competent Authority may use his wisdom as per approved State Government Policy to declare balance land as explained in (i) above as uneconomical and award compensation for the same.
