

The information as sought by Shri Shyama Prasad Sadhu r/o 179, Kalna Road, Pirpukur East, P.O. Bardhaman, Dist-Purba Bardhaman, West Bengal-713101 vide above subject and reference is furnished below:

'Intention to acquire 0.23 acres of plot no 442(RS) at Nari mouza, JL no 70, PS: Burdwan, the then Burdwan District, now Purba Bardhaman was declared by Central Government for the public purpose namely Dedicated Freight Corridor vide SO no722(E), dated 10.03.2014 in Gazette of India & same was published in Newspaper on 06.05.14 as per provision u/s 20A of Railways Act, 1989.

Thereafter, notification u/s 20E of Railways Act, 1989 was not published. Hence, the acquisition proceedings lapsed. As of now, there is no proposal to acquire 0.23 acres of plot no 442(RS) at Nari mouza, JL no 70, PS: Burdwan, Purba Bardhaman District'.
