BoD has approved in its 65th meeting held on 13/8/2018, the following revision of travel entitlements of employees of DFCCIL while on tour;

- 2. The travel entitlements for other categories of employees will remain the same.
- 3. In case employee uses his/her own vehicle to travel on duty by road, he/she will eligible for the following;

Mode of Journey	Rate	
For journeys performed by own car/taxi	Rs. 24/- per KM	
For journeys performed by Auto rickshaw, own	Rs. 12/- Per KM.	
scooter, etc	Note: The rate per Km. will further rise by 25 percent, whenever IDA increases by 50 Percent.

With reference to the above, para-wise remarks / clarifications are given:-

Item no	Issue raised:	Remarks
Para -2 (1)	Road travel entitlement will remain the same in accordance with the provision mentioned in the HR manual para (II) Chapter IX (page 152)	Road travel entitlement are as per the table mentioned in the HR manual para (II) Chapter IX (page 152)
(2)	Claim for vehicle charge on use during duty by road shall be considered at either end of movement from Rail head to Rail head	There is no such restriction for taking up the journey by rail only; full journey can be taken up by road.
(3)	In all those places where the official vehicle is available, the same shall be utilized at optimum level rather availing the local journey only, by the mode of transport as per entitlement as mentioned in para-1 above.	Agreed.
(4)	In case, places are not connected with the Railway head, efforts should be made to use public transport like bus and if the same is not available, then efforts should be made to hire vehicle with the prior approval of the competent authority, well before commencement of the journey without infringing C.O. instructions over the matter. Such hiring is to be planned in advance.	In case official vehicle is not available, the employee can travel by the entitled mode of transport.
(5)	Even if hired vehicle is approved prior to planned journey, the official vehicle is to be utilized, if available.	Agreed.

Further, para-03 of Circular No-46/2018 dtd 26.09.2018 allows travel by own car/Taxi/auto rickshaw at specified rates to those whose travel entitlements allow travel by taxi/auto/scooter, as the case may be. The rates given therein are not universal and are to be applied only for places where no specified rates have been prescribed by the Directorate of Transport of concerned State or neighbouring State as has been clarified in para-5(c) of Circular No-49 of 2018 dtd 28.09.18. Units are advised to devise their own procedures viz certificate of non-availability of official vehicle, proof of travel by own car (ie documentary evidence of ownership of 4-wheeler or 2-wheeler as per entitlement) and proof of journey (viz petrol receipts, toll tax invoices, etc) for settlement of cases.
