Ref:	1. Your original RTI application dt 26.01.17 received on 06.02.17 replied on 19.04.17. 2. Your (Reminder) 1 st Appeal letter dt 23.04.17 received on 05.06.17 in this office (no appeal prior to this was received in DFCCIL). 3. Your another email letter dt 18.07.17.

This office has examined your above-mentioned appeal and the reply to appeal is as follows:-

1. This office is given to understand that you were an employee of PMC at Tundla office. It is not understood why you have demanded information from Railway Board which is always available with PMC where you were working. This shows your negligent attitude towards the information and it seems that you wish to mislead the organization without seeking information from appropriate organization.
2. In your appeal, you have mentioned in most of the paras that the information is created by Shri Tejpal Chawla, PIO. In this connection, it may please be noted that Sh. Tejpal Chawla, PIO has furnished you the information based on the inputs received from the concerned office of DFCCIL only.
3. You have alleged the organization by using outrageous words like 'information created by CPIO or misleading which is not a good official practice'. You also seem to have intentionally alleged CPIO for carrying out duties in very irresponsible manner and requested administrative action against CPIO which shows that you are least concerned with information provided to you but only interested in prolonging the issues and alleging the organisation.
4. You have challenged the authority of CPIO/DFCCIL that PIO has no authority to direct an applicant (in this case yourself, Sh. R.K. Jain) to visit Public authority which is contrary to RTI act provisions. In fact, this is a amicable provision under **2(j)(i) (Inspection of Work, Documents, Records) of RTI Act, 2005** between the Applicant and the Public Authority whereby the applicant can go and inspect the documents for obtaining the information. Accordingly, a prior communication and agreement are always needed between the two parties to seek convenience of both and to serve the purpose.
5. CPIO has been repeatedly requesting you to visit the place of information at source. Previously also, you were asked to visit DFCCIL office at Agra but you have not turned up though your are a resident of Agra. Again you have been advised to visit the PMC Tundla office for information but you have not turned up and sent the subject appeal against RTI reply. This shows that as an appellant you are not interested in getting the information. As per the RTI Act provisions, you, the appellant, are once again requested to visit PMC office or DFCCIL office on a pre-defined date and time for collecting information as demanded/sought by you, if you are not in agreement with the reply given.
6. No appeal of yours dated 06.04.2017 is received in this office.
