

The information as sought by Shri Yash Kedia r/o Karunamoyee Ghat Road, Kolkata-700082, West Bengal vide above subject and reference is furnished below:

- a) *The entire proceedings for acquisition of land as per previous notification u/s 20A vide SO 2704(E), dated 06.09.13 & u/s 20E vide SO no 2482(E), dated 23.09.2014 and Newspaper publication u/s 20F on 01.01.2015 under the Railways Act, 1989 in Raniganj mouza, JL no 24, PS: Raniganj in the then Burdwan District (Now Paschim Bardhaman District) lapsed as the award was not declared within the statutory time limit.*
Fresh acquisition proposal with revised DFC alignment in the Raniganj mouza, JL no 24 is under process. Hence the requirement of plots mentioned by the applicant can be confirmed only after finalisation of acquisition proposal.
- b) *As stated above fresh acquisition proposal is under process. Moreover DFCCIL is not concerned with personal use of land. Applicant may be requested to approach concerned State Authority.*
