2.1 **The Psycho Test of the above candidates shall be done at DFCCIL's Corporate Office 5<sup>th</sup> Floor Pragati Maidan Metro Station Building Complex New Delhi 110001.** The candidates will also be informed through individual e-mail.

2.2 In case, the Psycho Test cannot be completed on the specified date and time, it will be rescheduled on the next available date at the same time and venue. You are requested to come prepared accordingly. No hotel charges and other incidental expenses incurred, if any, will be reimbursed.

**3. GENERAL INSTRUCTIONS FOR THE CANDIDATES -**

- (a) The candidate must bring the following for Psycho Test failing which shall render the candidature of the candidate as cancelled.
- This original letter
  - The E-Admit Card issued to the candidates for the Computer Based examination conducted on 17.04.2016.
  - Five Passport Size Photographs.
- (b) DFCCIL will not entertain any request for change of date and time schedule of Psycho Test.
- (c) In case, the Psycho Test could not be completed on the specified date and time, it will be rescheduled on the next available date at the same time and venue. You are requested to come prepared accordingly. No hotel charges and other incidental expenses incurred, if any, will be reimbursed.
- (d) No travelling Allowance will be paid to the candidates for attending the Psycho Test. However, outstationed SC/ST candidates found eligible will be paid second class sleeper rail/bus fare by shortest route from Railway Station/ Bus Station nearest to their home/place of residence or from where they should actually perform the journey to the place of Psycho Test and back to the same station provided the first 30 km. for both ways are borne by the candidates himself/herself. However, reimbursement will be restricted to the fare in respect of the balance distance only, which should be exceeding 30 km. both for onward and return Journey.
- (e) Your candidature is **"purely provisional"** subject to subsequent verification of original documents and also fulfilling the eligibility conditions as advertised.

- (f) The candidates are advised to make necessary arrangements for his/her travel/stay well in advance, so as to reach the specified venue on time.
  - (g) The candidate shall ascertain themselves before proceeding for Psycho Test that they are meeting all the eligibility criteria/conditions as stipulated in the advertisement. Candidates, who do not satisfy the eligibility conditions, will be liable to be disqualified at any stage of recruitment/selection.
  - (h) If any of the particulars stated by you in the application on verification is found to be incomplete or incorrect, or if you are found to have willfully suppressed any material fact/information relevant to the consideration of your case without prejudice to any other action that may be taken in consequence thereof, your candidature will be summarily rejected.
  - (i) DFCCIL reserves the right of postponing or deferring the date(s) of Psycho Test for which necessary intimation will be sent to you in this case.   - (l) You will be required to undergo Psycho Test and will be considered for appointment only if you are eligible in Psycho Test, document verification and found medically fit, in addition to other criteria.
  - (m) Canvassing in any form by or on behalf of a candidate will be disqualification to the stated post.
  - (n) DFCCIL at its discretion reserves the right to postpone/cancel the Psycho Test.
