Result for the post of Junior Manager (Operations & BD) against Advt No. 04/2021

1. Based on the performance in the Computer Based Test (CBT) held from 27th to 30th September 2021 and interviews held in Aug/Sep'22 for the post of Junior Manager (Operations & BD), candidates as per annexure –I have been provisionally empanelled.
2. The final merit list is drawn only from amongst the candidate's appeared in the interview, with 85% weightage of the marks obtained in the CBT and 15% weightage for the marks obtained in interview.
3. Based on above, candidates are shortlisted equal to the number of notified vacancies strictly as per merit and extant reservation Rules. Highest & Lowest (Cut-off) Marks of the Main Panel candidates is given below:
