The Government of India, Dedicated Freight Corridor Corporation of India Ltd. (DFCCIL) has applied for a *loan* from the International Bank for Reconstruction and Development (IBRD) towards the cost of *Eastern DFC Project- 3* and intends to apply part of the proceeds towards payments under the contract for *Design and Construction of Civil, Structures and Track Works, involving Formation in Embankment /Cutting, Ballast on Formation, Track Works, Bridges, Structures, Buildings, Yards & Integration with Indian Railway's Existing Railway System and Testing & Commissioning on Design-Build Lump Sum Basis of Khurja-Pilkhani Section (approximately 222 Route Km of Single Line) of Eastern Dedicated Freight Corridor (Contract Package 303)*. The Dedicated Freight Corridor Corporation of India Ltd. intends to prequalify contractors and/or firms for *contract packages 303* as per details given above. It is expected that invitations for bid will be made in mm, 2015.

Prequalification will be conducted through the procedures as specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits, January 2011, Revised July 2014* and is open to all eligible bidders as defined in the guidelines.

Interested eligible applicants may obtain further information, and inspect the prequalification documents, from the *office of Dedicated Freight Corridor Corporation of India Ltd.* at the address below during office hours, i.e. *0930 to 1800 hours*. A complete set of prequalification documents in English may be purchased by interested Applicants on the submission of a written application to the address below and upon payment of a non refundable fee of *INR 10000/- or USD 200 (Including VAT)*. The method of payment will be through demand draft or Banker's

cheque drawn in favor of *Dedicated Freight Corridor Corporation of India Limited*, payable at *New Delhi*. The pre-qualification document can be obtained from the office of DFCCIL in person on any working day. If the applicant desires the document be sent by post/courier service, then an additional charge of INR 1000/- for inland delivery and INR 5000/- or USD 100 for overseas delivery shall also be paid along with the fee stated above. DFCCIL shall not be responsible for any postal delay. The pre-qualification document can also be downloaded from DFCCIL website [www.dfccil.gov.in](http://www.dfccil.gov.in). If the document is downloaded from website, the applicant must deposit the non-refundable fee of INR 10000/- or USD 200 in favour of *Dedicated Freight Corridor Corporation of India Limited*, payable at *New Delhi* along with application. In case of any discrepancy between the documents downloaded by the prospective bidder and the Bid Documents (hard copy) of DFCCIL, the latter shall prevail.
