

1.3.1 Introduction

(i) General

Dedicated Freight Corridor Corporation of India Ltd. (DFCCIL), a public sector under taking under Ministry of Railways (MOR), has been set up under the Indian Companies Act, 1956 for implementation of Dedicated Freight Corridor Project. Government of India is the sole shareholder of the DFCCIL for construction and operation of Dedicated Freight Corridor (DFC). The coverage of Eastern Corridor is from Ludhiana to Sonnagar and Western Corridor is from Jawaharlal Nehru Port, Mumbai to Dadri near Delhi with linkage at New Dadri.

DFFCIL have procured the RGM formation from M/s Loram, USA consisting of RGM (72 Stone (model No. RGI-11 with Front Car, 3 Grinding Cars, 1 Water Wagon and 1 Camp Coach. DFFCIL have also procured the Rail Inspection Vehicle (Model No. RIV -121) from M/S Loram, USA. The RGM formation and RIV was commissioned on 16 Nov,2023.

(ii) Name of Work

Operation & Maintenance of DFCCIL's RGM Formation and RIV Machine including supply of spares and other items for 12 years within DFCCIL Network.

(iii) Scope of Work

The scope of work covers Operation & Maintenance of RGM Formation and RIV Machine for 12 years including supply of Machine spare parts, Griding stones for rail grinding and consumables required for Operation and maintenance of RGM Formation and RIV. The scope also included the following items:

1.3.22 Site Inspection:

Tenderers are requested to inspect the Machine which is offered for O & M and carry out careful examination of the same to satisfy them as to the nature of work involved and facilities available at the DFCCIL sites. They should note carefully all the existing structures and those under construction through other agencies. They should also study the suitability of utilizing the different equipment and the machinery that they intend to use for the execution of the work. 1.3.30 Employment/Partnership etc. of Retired Railway/DFCCIL Employees:

(a) Should a tenderer

- (i) be a retired Engineer of the Gazetted rank or any other Gazetted officer working before his retirement, whether in the executive or administrative capacity or whether holding a pensionable post or not, in the Engineering or any other department of any of the railways owned and administered by the President of India for the time being, OR
- (ii) being partnership firm / joint venture (JV) / registered society / registered trust etc have as one of its partners a retired Engineer of the Gazetted rank or any other Gazetted officer working before his retirement, OR
- (iii) being an incorporated company have any such retired Engineer of the Gazetted rankor any other Gazetted officer working before his retirement as one of its directors, AND

in case where such Engineer or officer had not retired from government service at least 1 year prior to the date of submission of the tender, Then the tenderer will give full information as to the date of retirement of such Engineer or Gazetted officer from the said service and as to whether permission for taking such contract, or if the Contractor be a partnership firm or an incorporated company, to become a partner or director as the case may be, has been obtained by the tenderer or the Engineer or officer, as the case may be from the President of India or any officer, duly authorized by him in this behalf, shall be clearly stated in writing at the time of submitting the tender.

- (b) In case, upon successful award of contract, should a tenderer depute for execution of the works under or to deal matters related with this contract, any retired Engineer of gazette rank or retired Gazetted officer working before his retirement in the Engineering or any other department of any of the railways owned and administered by the President of India for the time being, and now in his employment, then the tenderer will ensure that retired Engineer or retired Gazetted officer had retired from government service at least 1 year prior to the date of his employment with tenderer and in case he had retired from service within a year then he possesses the requisite permission from the President of India or any officer, duly authorized by him in this behalf, to get associated with the tenderer.

All notices/correspondence with respect to the contract would be sent only to this authorized member of the JV.
- 1.3.31.14 No member of the Joint Venture shall have the right to assign or transfer the interest right or liability in the contract without the written consent of the other members and that of the DFCCIL in respect of the said tender/contract.

Such "Power of Attorney" shall be notarized / registered and submitted along with the tender.
- 1.3.32.8 On issue of Letter of Acceptance (LOA) to the partnership firm, all the guarantees like Performance Guarantee, Guarantee for various Advances to the Contractor shall be

Any change carried out by partners in the constitution of the firm without the permission of DFCCIL, shall constitute a breach of the contract, liable for determination of the contract under Clause 62 of the General Conditions of Contract.
 - c) Governing laws: The partnership firm agreement shall in all respect be governed by and interpreted in accordance with the Indian laws.
 - d) No partner of the firm shall have the right to assign or transfer the interest right or liability in the contract without the written consent of the other partner/s and that of the DFCCIL.
- 1.3.32.11 The tenderer shall clearly specify that the tender is submitted on behalf of a partnership firm. The following documents shall be submitted by the partnership firm, with the tender:

CHAPTER - IV

General Conditions of Contract

DEFINITIONS AND INTERPRETATION

- 1.(1). **Definition:** In these General conditions of Contract for O & M phase, the following terms shall have the meaning assigned hereunder except where the context otherwise requires:
 - (a) "**DFCCIL**" shall mean the Managing Director/Dedicated Freight Corridor Corporation of India Limited or the Administrative Officers of the DFCCIL or of the Successor authorized to deal with any matter which these presents are concerned on his behalf.
 - (b) "Managing Director/ Director of DFCCIL" shall mean the officer in-charge of the General Superintendence and Control of the DFCCIL and shall mean and include their successors, of the successor DFCCIL and shall also include.
 - (c) "Chief General Manager/ General Manager" shall mean the officer in-charge of the Engineering Department of DFCCIL. and shall also include GGM of DFCCIL.
 - (d) "Executive Director" shall mean the Officer in-charge of a DFCCIL corridor and shall also mean any officer nominated by "DFCCIL" and shall mean and include their successors of the successor DFCCIL.
 - (e) "Engineer" and Employer's Engineer shall mean the General Manager (Civil)/Dy. Chief Project Manager/Project (Civil) of DFCCIL/PMC appointed by DFCCIL.
 - (f) "Engineer's Representative" shall mean the DPM/APM /JPM./Sr. Executive/ Executive (Civil) of DFCCIL in direct charge of the work and shall mean and include the Engineer's Representative of the PMC appointed by DFCCIL.
 - (g) "Contractor/O & M Contractor" shall mean the person/Firm/ Company/JV whether incorporated or not who enters into the contract with the DFCCIL and shall include their executors, administrators, and successors and permitted assigns.
 - (h) "Contractor's authorized engineer" shall mean a graduate engineer having more than 3 years' experience in the relevant field of O & M of track machines involved in the contract, duly approved by Engineer.
 - (i) "Contract/ O & M Contract" shall mean and include the Agreement, the accepted schedule of rates for items of O & M work quantified, General Conditions of Contract, Special Conditions of Contracts Drawings, Specifications, Terms of Reference, Operation and Maintenance Provisions of RGM Formation & RIV any any other tender provisions and all other documents included as part of contract.
 - (j) "Works" shall mean the Operation and Maintenance of DFCCIL RGM Formation and RIV for its intended use/ works to be executed in accordance with the contract.
 - (k) "**Specifications**" shall mean the Specifications for goods, materials and works referred / mentioned in tender documents.
 - (I) "**Temporary Works**" shall mean all temporary works of every kind required for the execution completion and/or maintenance of the RGM Formation and RIV Machines

- (m) "Site" shall mean the track machine and DFCCIL track/land and other places on, under, in or through which the works are to be carried out and any other lands or places provided by the DFCCIL for the purpose of the Contract.
- (n) "Period of Maintenance" shall mean the Defect liability period/ warranty for the Machine parts supplied by the contractor.
- (9) "Bid" or "Tender", "Bidder" or "Tenderer" or "contractor" wherever appearing in this tender document shall have the same and interchangeable meaning.
- 1.(2). Singular and Plural: Words importing the singular number shall also include the plural and vice versa where the context requires.
- 1.(3). Headings & marginal headings: -The headings and marginal headings in these general conditions are solely for the purpose of facilitating reference and shall not be deemed to be part thereof or be taken into consideration in the interpretation or construction thereof or the contract.

GENERAL OBLIGATION

- 2.(1). Execution Co-relation and intent of contract Documents: -The contract documents shall be signed in triplicate by DFCCIL and the Contractor. The contract documents are complementary, and what is called for by anyone shall be as binding as if called for by all, the intention of the documents is to include all labor and materials, equipment and transportation necessary for the proper execution of work. Materials or work not covered by or properly inferable from any heading or class of the specifications shall not be supplied by the DFCCIL to the contractors unless distinctly specified in the contract documents. Materials or works described in words which so applied have a well-known technical or trade meaning shall be held to refer to such recognized standards.
- 2.(2). If a work is transferred from the jurisdiction of one DFCCIL unit to another DFCCIL unit or to a Project Authority/DFCCIL or vice versa while contract is in subsistence, the contract shall be binding on the Contractor and the Successor DFCCIL unit/Project in the same manner & take effect all respects as if the Contractor and the Successor DFCCIL unit/Project were parties there to from the inception and the corresponding officer or the Competent Authority in the Successor DFCCIL unit/Project will exercise the same powers and enjoy the same authority as conferred to the Predecessor DFCCIL unit/Project under the original contract/agreement entered into.
- 2.(3). If for administrative or other reasons the contract is transferred to the Successor DFCCIL unit/Successor Project Authority of DFCCIL the contract shall not withstanding any things contained herein contrary there to, be binding on the Contractor and the Successor DFCCIL unit /Project Authority/ DFCCIL in the same manner and take effect in all respect as if the Contractor and the Successor DFCCIL unit/ successor Project Authority of DFCCIL had been parties thereto from the date of this contract. The contract shall be Administered/Managed by GGM/CGM/GM/CPM/nominated by DFCCIL.
- 3.(1). Law governing the contract: This agreement and the relationship between the parties shall be governed construed and interpreted in accordance with applicable laws of India. Applicable laws shall mean all laws, bye-laws, statutes, rules, regulations, orders, ordinances, codes, guidelines, notices, directions, judgements, decrees or other requirements or official directives and/or of any statutory authority in the Republic of India."
- 3.(2). **Compliance to regulations and bye-laws:-**The contractor shall conform to the provision of any statute relating to the works and regulations and by-laws of any location authority and of any water

and lighting companies or undertakings, with whose system the work is proposed to be connected and shall before making any variation from the drawings or the specifications that may be necessitated by so confirming give to the Engineer notice specifying the variation proposed to be made and the reasons for making the variation and shall not carry out such variation until he has received instructions from the Engineer in respect thereof. The contractor shall be bound to give all notices required by statute, regulations or bye-laws as aforesaid and to pay all fees and taxes payable to any authority in respect of this.

- 4. Communications to be in writing: All notices, communications, reference and complaints made by the DFCCIL or the Engineer or the Engineer's representative or the contractor inters concerning the work shall be in writing and no notice, communication, reference or complaint not in writing shall be recognized.
- 5. Service of Notices on Contractor:-The contractor shall furnish to the Engineer the name designation and address of his authorized agent and all complaints, notices, communications and references shall be deemed to have been duly given to the contractor if delivered to the contractor or his authorized agent or left at or posted to the address so given and shall be deemed to have been so given in the case of posting on day on which they would have reached such address in the ordinary course of post or on the day on which they were so delivered or left. In the case of contract by partners, any change in the constitution of the firm shall be forthwith notified by the contractor to the Engineer.
- 6. Occupation and use of land: No land belonging to or in the possession of the DFCCIL shall be occupied by the Contractor without the permission of the DFCCIL. The Contractor shall not use, or allow to be used, the site for any purposes other than that of executing the works. Whenever non-railway bodies / persons are permitted to use DFCCIL premises with competent authority's approval, conservancy charges as applicable from time to time may be levied.
- 7. **Assignment** or **subletting of contract**: Not applicable for this work.
- 8. Assistance by DFCCIL for the Stores to be obtained by the Contractor: Owing to difficulty in obtaining certain materials (including Tools & Plant) in the market, the DFCCIL may agree without any liability therefore to endeavor to obtain or assist the contractor in obtaining the required quantities of such materials as may be specified in the tender. In the event of delay or failure in obtaining the required quantities of the aforesaid material the contractor shall not be deemed absolved of his own responsibility and shall keep in touch with day to day positions regarding their availability and accordingly adjust progress of works including employment of labour and the DFCCIL shall not in any way be liable for the supply of materials or for the non-supply thereof for any reasons whatsoever nor for any loss or damage arising in consequence of such delay or no supply.
- 9. Deleted
- 10. Carriage of materials: No forwarding orders shall be issued by the DFCCIL for the conveyance of contractor's materials, tools and plant by Rail which may be required for use in the O & M works and the contractor shall pay full freight charges at public tariff rates therefore.
- 11. **Deleted**
- 12. Representation on O & M works:-The contractor shall, when he is not personally present on the site of the O & M works place and keep a responsible agent at the O & M works during working hours who shall on receiving reasonable notice, present himself to the Engineer and orders given by the Engineer or the engineer's representative to the agent shall be deemed to have the same force as if they had been given to the Contractor. Before absenting himself, the contractor shall furnish the name and address of his agent for the purpose of this clause and failure on the part of

the Contractor to comply with this provision at any time will entitle the DFCCIL to rescind the contract under clause 62 of these conditions.

- 13. **Relics and Treasures: -**Not Applicable to this contract.
- 14. **Excavated material: -** Not Applicable to this contract.
- 15. Indemnity by Contractors: The contractor shall indemnify and save harmless the DFCCIL from and against all actions, suit proceedings losses, costs, damages, charges, claims and demands of every nature and description brought or recovered against the DFCCIL by reason of any act or omission of the contractor, his agents or employees, in the execution of the works or in his guarding of the same. All sums payable by way of compensation under any of these conditions shall be considered as reasonable compensation to be applied to the actual loss or damage sustained, and whether or not any damage shall have been sustained. Notwithstanding any provision herein to the contrary, the Contractor's total cumulative liability for any or all claims arising out of this agreement due to this indemnification clause shall not exceed the 3% of the total awarded value of Schedule-A of SOR
 - 16.(1) Security Deposit: The Security Deposit shall be 5% of the contract value. The Bid Security submitted by the Contractor with his tender will be retained/uncashed by the DFCCIL as part of security for the due and faithful fulfillment of the contract by the Contractor. Provided further that, if Contractor submits the Cash or Term Deposit Receipt issued from a Scheduled commercial bank of India or irrevocable Bank Guarantee Bond from a Scheduled commercial bank of India, either towards the Full Security Depositor the Part Security Deposit equal to or more than Bid Security, the DFCCIL shall return the Bid Security, to the Contractor.

Balance of Security Deposit may be deposited by the Contractor in cash or Term Deposit Receipt issued from Scheduled commercial bank of India or irrevocable Bank Guarantee bond issued from Scheduled commercial bank of India, or may be recovered at the rate of 6% of the bill amount till the full Security Deposit is recovered. Provided also that in case of defaulting Contractor, the DFCCIL may retain any amount due for payment to the Contractor on the pending "on account bills" so that the amounts so retained (including amount guaranteed through Performance Guarantee) may not exceed 10% of the total value of the contract.

The Irrevocable Bank Guarantee submitted towards Security deposit shall be initially valid up to the stipulated date of Maintenance period plus 60 days and shall be extended from time to time, depending upon extension of contract granted in terms of Clause 17A of the General Conditions of Contract.

Note: Security Deposit deposited in cash by the Contractor or recovered from the running bills of a Contractor or submitted by contractor as Term Deposit Receipt(s) can be refunded/returned to the contractor, in lieu of irrevocable Bank Guarantee bond issued from scheduled commercial bank of India, to be submitted by him, for an amount equal to or more than the already available Security Deposit, provided however that, in a contract of value less than Rs. 50 Crore, such refund/return of the already available Security Deposit is permitted up to two times and in a contract of value equal to or more than Rs. 50 Crore, such refund / return of the already available Security Deposit is permitted up to three times.

- **16.(2)** (i) Refund of Security Deposit: Security Deposit mentioned in sub clause (1) above shall be returned to the Contractor along with or after, the following:
 - (a) Final Payment of the Contract as per clause 51.(1) and
 - (b) Execution of Final Supplementary Agreement or Certification by Engineer that DFCCIL has No Claim on Contractor.
- **16.(2)** (ii) Forfeiture of Security Deposit: Whenever the contract is rescinded under clause 62 (1) of these conditions, the Security Deposit already with DFCCIL under the contract shall be forfeited.

16.(3) No interest shall be payable upon the Bid Security and Security Deposit or amounts payable to the Contractor under the Contract, but Government Securities deposited in terms of Sub-Clause 16.(4)(b) of this clause will be payable with interest accrued thereon.

16.(4) Performance Guarantee

The procedure for obtaining Performance Guarantee is outlined below:

(a) The successful bidder shall have to submit a Performance Guarantee (PG) within 21 (Twentyone) days from the date of issue of Letter of Acceptance (LOA). Extension of time for submission of PG beyond 21 (Twenty-one) days and upto 60 days from the date of issue of LOA may be given by the Authority who is competent to sign the contract agreement. However, a penal interest of 12% per annum shall be charged for the delay beyond 21(Twenty-one) days, i.e. from 22ndday after the date of issue of LOA. Further, if the 60thday happens to be a declared holiday in the concerned office of the DFCCIL, submission of PG can be accepted on the next working day.

In all other cases, if the Contractor fails to submit the requisite PG even after 60 days from the date of issue of LOA, the contract is liable to be terminated. In case contract is terminated DFCCIL shall be entitled to forfeit Bid Security and other dues payable to the contractor against that particular contract, subject to maximum of PG amount. In case a tenderer has not submitted Bid Security on the strength of their registration as a Startup recognized by Department of Industrial Policy and Promotion (DIPP) under Ministry of Commerce and Industry, DIPP shall be informed to this effect.

The failed Contractor shall be debarred from participating in re-tender for that work.

As a facilitative measure, the bidder shall be required to submit, in case he chooses to do so, submit Performance Bank Guarantee (PBG) of the amount expressed above, having validity, initially, for a period of three years from the date of LOA. Subsequently, in each case of PBG Validity extension, the contractor, upto 30 days prior to expiry of the preceding aforesaid 03-year validity of the PBG, shall extend the validity of Performance Security BG, further for a period of three years. The contractor shall keep on extending the validity of the PBG at each aforesaid three year interval [in all, Contractor shall be required to, seamlessly without any interruption, extend the validity of the PBG at three year interval, three times after initial submission of the PBG, the last extension, being normally for a period of three years plus sixty days] till expiry of 144 month contract Period plus sixty days or sixty days after the conclusion of the contract (as agreed by the parties) whichever is the later.

- (b) The successful bidder shall submit the Performance Guarantee (PG) in any of the following forms, amounting to 5% of the original contract value:
 - (i) A deposit of Cash;
 - (ii) Irrevocable Bank Guarantee;
 - (iii) Government Securities including State Loan Bonds at 5% below the market value;
 - (iv) Pay Orders and Demand Drafts tendered by any Scheduled Commercial Bank of India;
 - (v) Guarantee Bonds executed or Deposits Receipts tendered by any Scheduled Commercial Bank of India;
 - (vi) Deposit in the Post Office Saving Bank;
 - (vii) Deposit in the National Savings Certificates;
 - (viii) Twelve years National Defence Certificates;
 - (ix) Ten years Defence Deposits;

- (x) National Defence Bonds and
- (xi) Unit Trust Certificates at 5% below market value or at the face value whichever is less. Also, FDR in favour of GGM/Finance/DFCCIL(free from any encumbrance) may be accepted.
- (c) The Performance Guarantee shall be submitted by the successful bidder after the Letter of Acceptance (LOA) has been issued, but before signing of the contract agreement. This P.G. shall be initially valid upto the stipulated date of completion plus 60 days beyond that. In case, the time for completion of work gets extended, the Contractor shall get the validity of P.G. extended to cover such extended time for completion of work plus 60 days.
- (d) The value of PG to be submitted by the Contractor is based on original contract value and shall not change due to subsequent variation(s) in the original contract value.
- (e) The Performance Guarantee (PG) shall be released after physical completion of the work based on 'Completion Certificate' issued by the competent authority stating that the Contractor has completed the work in all respects satisfactorily.
- (f) Whenever the contract is rescinded, the Performance Guarantee already submitted for the contract shall be encased.
- (g) The Engineer shall not make a claim under the Performance Guarantee except for amounts to which the DFCCIL is entitled under the contract (not withstanding and/or without prejudice to any other provisions in the contract agreement) in the event of:
 - (i) Failure by the Contractor to extend the validity of the Performance Guarantee as described herein above, in which event the Engineer may claim the full amount of the Performance Guarantee.
 - (ii) Failure by the Contractor to pay DFCCIL any amount due, either as agreed by the Contractor or determined under any of the Clauses/Conditions of the Agreement, within 30 days of the service of notice to this effect by Engineer.
 - (iii) The Contract being determined or rescinded under clause 62 of these conditions.
- 17 Force Majeure Clause:- If at any time, during the continuance of this contract, the Performance in whole or in part by either party of any obligation under this contract shall be prevented or delayed by reason of any war, hostility, acts of public enemy, civil commotion, sabotage, serious loss or damage by fire, explosions, epidemics, strikes, lockouts or act of God (hereinafter, referred to events) provided, notice of the happening of any such event is given by either party to the other within 30 days from the date of occurrence thereof, neither party shall by reason of such event, be entitled to terminate this contract nor shall either party have any claim for damages against the other in respect of such non-performance of delay in performance, and works under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist, and the decision of the Engineer as to whether the works have been so resumed or not shall be final and conclusive, PROVIDED FURTHER that if the performance in whole or in part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 120 days, either party may at its option terminate the contract by giving notice (notice period of 60 days) to the other party.
- 17-A. **Extension of time in Contracts:** If required extension of time of O & M contract may be given if both parties agrees for the same at original terms and condition of contract and at original rates.
- 17-B. Deleted.
- 17-C. Bonus for Early Completion of Work: Not applicable to this contract.
- 18.(1). Illegal Gratification:- Any bribe, commission, gift or advantage given, promised or offered by or

on behalf to the contractor or his partner, agent or servant or, anyone on his behalf, to any officer or employee of the DFCCIL, or to any person on his behalf in relation to obtaining or execution of this or any other contract with the DFCCIL shall, in addition to any criminal liability which he may incur, subject contractor to the rescission of the contract and all other contracts with the DFCCIL and to the payment of any loss or damage resulting from such decision and the DFCCIL shall be entitled to deduct the amounts so payable from any moneys due to the Contractor(s) under this contract or any other contracts with the DFCCIL.

18.(2). The contractor shall not lend or borrow from or have or enter into any monitory dealings and transactions either directly or indirectly with any employee of the DFCCIL and if he shall do so, the DFCCIL shall be entitled forthwith to rescind the contract and all other contracts with the DFCCIL. Any question or dispute as to the commission or any such offence or compensation payable to the DFCCIL under this clause shall be settled by the GGM/GM /CGM of the DFCCIL, in such a manner as he shall consider fit and sufficient and his decision shall be final and conclusive. In the event of rescission of the contract under this clause, the contractor will not be paid any compensation whatsoever except payments for the work done up to the date of rescission.

EXECUTION OF WORKS

- 19.(1). **Contractor's understanding:-** It is understood and agreed that the contractor has, by careful examination, satisfied himself as to the nature and location of the work, the conformation of the ground, the character, quality and quantity of the materials to be encountered, the character of equipment and facilities needed preliminary to and during the progress of the works, the general and local conditions, the labour conditions prevailing therein and all other matters which can in any way affect the works under the contract.
- 19 (2) Commencement of works: The contractor shall commence the works within 15 days from the date of issue of Letter of Acceptance (LOA) in writing to this affect from the Engineer and shall proceed with the same with due expedition and without delay. The DFCCIL and Contractor shall prepare advance 15 days advance program of Grinding work duly factoring the traffic block periods and maintenance schedule of machines.
- 19.(2). **Setting out of works:** The existing sectional features/GMT data etc of track will be provided by DFCCIL. Rail profile is to be recorded by O & M Contractor by RIV and analyses of recorded data to be done by O & M Contractor and accordingly rail grinding has to be done with aim to achieve 80% GQI value as mentioned in this tender. The contractor provides all facilities like labour and instruments and shall co- operate with the Engineer's representative to check the quality of work done. Such checking shall not absolve the contractor of his own responsibility of maintaining accuracy in the work.
- 20.(1). **Compliance to Engineer's instructions: -**The Engineer shall direct the order in which the several parts of the works shall be executed and the contractor shall execute without delay all orders given by the Engineer from time to time but the contractor shall not be relieved thereby from responsibility for the due performance of the works in all respects.
- 20.(2). Alterations to be authorized: No alterations in or additions to or omissions or abandonment of any part of the works shall be deemed authorized, except under instructions from the Engineer, and the contractor shall be responsible to obtain such instructions in each and every case in writing from the Engineer.
- 20.(3). **Extra works:** Any works over and above those included in the contract require to be executed, the contractor shall have no right to be entrusted with the execution of such works which may be carried out by another contractor or contractors or by other means at the option of the DFCCIL.
- 20.(4). Separate contracts in connection with works: The DFCCIL shall have the right to let other

contracts in connection with the works. The contractor shall afford other contractors' reasonable opportunity for the storage of their materials and the execution of their works and shall properly connect and coordinate his work with theirs. If any part of the contractor's work depends for proper execution or result upon the work of another contractor(s), the contractor shall inspect and promptly report to the Engineer any defects in such works that render it unsuitable for such proper execution and results. The contractor's failure so-to inspect and report shall constitute an acceptance of the other contractor's work as fit and proper for the reception of his work, except as to defects which may develop in the other contractor's work after the execution of his work.

- 21. **Instruction of Engineer's Representative: -** Any instructions or approval given by the Engineer's representative to contractor in connection with the works shall bind the contractor as though it had been given by the Engineer provided always as follows:
 - a. Failure of the Engineer's representative to disapprove any work or materials shall not prejudice, the power of the Engineer thereafter to disapprove such work or material and to order the removal or breaking up thereof.
 - If the Contractor shall be dissatisfied by reason of any decision of the Engineer's representative, he shall be entitled to refer the matter to the Engineer who shall there upon confirm or vary such decision.
- 22.(1) Adherence to specifications: The whole of the works shall be executed in perfect conformity with the specifications of the contract. If the contractor performs any works in a manner contrary to the specifications and without such reference to the Engineer he shall bear all the costs arising or ensuing therefore and shall be responsible for all loss to the DFCCIL.
- 22.(2) **Specifications of the works:** The contractor shall keep one copy of Contract Agreement/ specifications at the site, in good order, and such contract documents as may be necessary available to the Engineer or the Engineer's representative.
- 22.(3) Ownership of specifications: All specifications and copies thereof furnished by the DFCCIL to the Contractor are deemed to be the property of the DFCCIL. They shall not be used on other works and with the exception of the signed contract set, shall be returned by the contractor to the DFCCIL on completion of the work or termination of the contract.
- 22.(4) **Compliance with Contractor's request for details: -** The Engineer shall furnish with reasonable promptness, after receipt by him of the contractor's request for the same, additional instructions, necessary for the proper execution of the works or any part thereof. All such instructions shall be consistent with the contract Documents and reasonably inferable there from.
- 22.(5) **Meaning and intent of specification:-** If any ambiguity arises as to the meaning and intent of any portion of the specifications or as to execution or quality of any work or material, or as to the measurements of the works the decision of the Engineer thereon shall be final subject to the appeal (within 7 days of such decision being intimated to the contractor) to the CGM/GM who shall have the power to correct any errors, omissions, or discrepancies in aforementioned items and whose decision in the matter in dispute or doubt shall be final and conclusive.
- **23. Working during night:** The Contractor have to arrange lightning arrangement for night working of track machines. If the Engineer decides for night working as per availability of blocks, he may order the same without confirming any right on the Contractor for claiming any extra payment for the same.
- 24. Damage to DFCCIL property or private life and property: The contractor shall be responsible for all risk to the work and for trespass and shall make good at his own expense all loss or damage whether to the works themselves or to any other property of the DFCCIL or the lives, persons or property of others from whatsoever cause in connection with the works and this although all

reasonable and proper precautions may have been taken by the contractor, and in case the DFCCIL shall be called upon to make good any costs, loss or damages, or to pay an compensation, including that payable under the provisions of the Workmen's Compensation Act or any statutory amendments thereof to any person or persons sustaining damages as aforesaid by reason of any act, or any negligence or omissions on the part of the contractor the amount of any costs or charges including costs and charges in connection with legal proceedings, which the DFCCIL may incur in reference thereto, shall be charged to the contractor. The DFCCIL shall have the power and right to pay or to defend or compromise any claim of threatened legal proceedings or in anticipation of legal proceedings being instituted consequent on the action or default of the contractor, to take such steps as may be considered necessary or desirable to ward off or mitigate the effect of such proceedings, charging to contractor, as aforesaid any sum or sums of money which may be paid and any expenses whether for reinstatement or otherwise which may be incurred and the propriety of any such payment, defence or compromise, and the incurring of any such expenses shall not be called in question by the contractor.

- 25. Sheds, stores houses and Yards:-The DFCCIL shall at his own expense provide sheds, stores houses in such situations and in such numbers as in the opinion of the Engineer is requisite for carrying on the works and the contractor shall keep at each such sheds, stores houses a sufficient quantity of materials and plant in stock as not to delay the carrying out of the works with due expedition and the Engineer and the Engineer's representative shall have free access to the said sheds, store houses at any time for the purpose of inspecting the stock of materials or plant so kept in hand, and any materials or plan which the Engineer may object to shall not be brought upon or used in the works, but shall be forthwith removed from the sheds, store houses or yards by the contractor. The contractor shall at his own expenses provide and maintain all T & P or any other equipment's necessary for the execution of the works.
- 26. Provision of efficient and competent Staff at work sites by the Contractor:
- 26.1. For detail of manpower refer clause 1.15 of SCC of this tender.
- 26.2. The contractor shall at once remove from the works any agents, permitted sub-contractor, supervisors, Operators, Technicians and Helpers/labourers who shall be objected to by the Engineer and if and whenever required by the Engineer, he shall submit a correct return showing the names of all staff and workmen employed by him.
- **26A** Deployment of Qualified Engineers at Sites by the Contractor: As per provisions of SCC.
- 27.(1). **Workmanship and testing:-** The whole of the works and / or supply of materials specified and provided in the contract or that may be necessary to be works done in order to form and complete any part thereof shall be executed in the best and most substantial workman like manner with materials of the best and most approved quality of their respective kinds, agreeable to the particulars contained in or implied by the specifications and as referred to in and represented by the drawings or in such other additional particulars, instructions and drawings may be found requisite to be given during the carrying on of the works and to the entire satisfaction of the Engineer according to the instructions and directions which the contractors may from time to time receive from the Engineer. The works may be subjected to tests by means of such machines, instruments and appliances as the Engineer may direct and wholly at the expense of the contractor.
- 27.(2). **Removal of materials & Correction in bad work: -** The Engineer or the Engineer's Representative shall be entitled to order from time to time:
 - (a) The removal from the site, within the time specified in the order, of any materials or spare parts which in his opinion are not in accordance with the specifications.
 - (b) The substitution of proper and suitable materials, and

- 31.(1). Water required for O & M of RGM Formation and RIV shall be provided free of cost.
- 31.(2). Not Applicable.

- 31.(5). Electric power required for O & M of RGM Formation and RIV shall be provided free of cost.
- **32. Property in materials and plant:** Not Applicable to this tender.
- **33.(1).** Tools, Plant and Materials Supplied by DFCCIL: Provision of O & M of RGM formation and RIV as detailed in SCC of this O & M Contract has to be adhered by O & M Contractor without fail.
- **33.(2). Hire of DFCCIL's Plant:** Not Applicable to this tender.
- **34.(1). Precaution during progress of works:** During the execution of works, contractors shall take all precautions to avoid any damage, injury or loss is caused or likely to be caused to any person, property or railway system of DFCCIL.
- 34.(2). Roads and Water courses: Not Applicable to this tender.
- 34.(3). **Provision of access to premises:** Not Applicable to this tender.
- **34.(4). Safety of Public:** The Contractor shall be responsible to take all precautions to ensure the safety of the public whether on public or DFCCIL property and shall post such look out men as may in the opinion of the Engineer be required to comply with regulations pertaining to the work.
- 35. Deleted.
- **36.(1). Suspension of works:** The Contractor shall on the order of the Engineer, suspend the progress of the works or any part thereof for such time or times and in such manner as the Engineer may consider necessary and shall during such suspension properly protect and secure the work so far as is necessary in the opinion of the Engineer. If such suspension is:
 - (a) Provided for in the contract, or
 - (b) Necessary for the proper execution of the works or by the reason of weather conditions or by some default on the part of the Contractor, and/or

Rates for items of works: The rates, entered in the accepted Schedule of Rates of the Contract are intended to provide for works duly and properly completed in accordance with the general and special (if any) conditions of the contract, TOR, O & M conditions of RGM Formation and RIV and the specifications and drawings together with such enlargements, extensions, diminutions, reductions, alterations or additions as may be ordered in terms of Clause 42 of these conditions and without prejudice to the generality thereof and shall be deemed to include and cover superintendence and labour, supply, including full freight, of materials, stores, tools and all apparatus and plant required on the works, except such tools, plant or materials as may be specified in the contract to be supplied to the Contractor by the DFCCIL, the erection, maintenance and removal of all temporary works and, all watching, lighting, all prevention of or compensation for trespass, all barriers and arrangements for the safety of the public or of employees during the execution of works, all sanitary and medical arrangements for labour camps as may be prescribed by the DFCCIL, the setting of all work, site clearance, all fees duties, royalties, rent and compensation to owners for surface damage or taxes and impositions payable to local authorities in respect of land, structures and all material supplied for the work or other duties of expenses for which the Contractor may become liable or may be put to under any provision of law for the purpose of or in connection with the execution of the contract, and all such other incidental charges or contingencies as may have been specially provided for in the specifications.

39.(1). Rates for extra items of works:

- **39.(2).** Provided that if the Contractor commences work or incurs any expenditure in regard thereto before the rates as determined and agreed upon as lastly hereunto fore-mentioned, then and in such a case the Contractor shall only be entitled to be paid in respect of the work carried out or expenditure incurred by him prior to the date of determination of rates as aforesaid according to the rates as shall

be fixed by the Engineer. However, if the Contractor is not satisfied with the decision of the Engineer in this respect he may appeal to the CPM/General Manager within 30 days of getting the decision of the Engineer, supported by analysis of the rates claimed. The CGM/CPM's/ General Manager's decision after hearing both the parties in the matter would be final and binding on the Contractor and the DFCCIL.

- 40.(1). Handing over of works: On completion of block for track machine working, the Contractor shall be bound to hand over the track in safe condition for normal speed for running of trains. In case after examining the completed work after Rail Grinding, if Contractor founds that track is not fit for normal sectional speed, then he should suggest the speed restriction to be imposed for passing DFCCIL trains on track in writing to DFCCIL official present during the block. The decision of Engineer for about track fitness after block working shall be final and binding on contractor. In case rail traffic is not allowed at sectional speed due to contractor default, then for that day contractor will not get any payment and it will be considered that machine is not available for working on that day.
- 40.(2). Clearance of site on completion: On completion of O & M Contract works, the Contractor shall clear away and remove from the site all plant, surplus materials and temporary works of every kind and leave the whole of the site and works clean and in a workman like condition to the satisfaction of the Engineer. No final payment in settlement of the accounts for the works shall be paid, held to be due or shall be made to the, Contractor till, in addition to any other condition necessary for final payment, site clearance shall have been affected by him, and such clearance may be made by the Engineer at the expense of the Contractor in the event of his failure to comply with this provision within 7 days after receiving notice to that effect. Should it become necessary for the Engineer to have the site cleared at the expenses of the Contractor, the DFCCIL shall not be held liable for any loss or damage to such of the Contractor's property as may be on the site and due to such removal there from which removal may be effected by means of public sales of such materials and property or in such a way as deemed fit and convenient to the Engineer.

VARIATIONS IN EXTENT OF CONTRACT

- 41. Modification to contract to be in writing: In the event of any of the provisions of the contract requiring to be modified after the contract documents have been signed, the modifications shall be made in writing and signed by the DFCCIL and the Contractor and no work shall proceed under such modifications until this has been done. Any verbal or written arrangement abandoning, modifying, extending, reducing or supplementing the contract or any of the terms thereof shall be deemed conditional and shall not be binding on the DFCCIL unless and until the same is incorporated in a formal instrument and signed by the Contractor, and till then the DFCCIL shall have the right repudiate such arrangements.
- **42.(1).** Powers of modification to contract: The Engineer on behalf of the DFCCIL shall be entitled by order in writing to make any alterations in the method of their execution or in the combination and use of materials for the execution thereof or to order any additional work to be done or any works not to be done and the contractor will not be entitled, to any compensation for any increase/reduction in the quantities of work.
- 42.(2). Unless otherwise specified in the contract, the accepted variation in quantity of each individual item of the contract would be up to 25% of the quantity originally contracted. The contractor shall be bound to carry out the work at the agreed rates and shall not be entitled to any claim or any compensation whatsoever up to the limit of 25% variation in quantity of individual item of works.
- 42.(3). **Valuation of variations:-** The enlargements, extensions, diminution, reduction, alterations or additions referred to in sub-clause (2) of this clause shall in no degree affect the validity of the contract but shall be performed by the Contractor as provided therein and be subject to the same conditions, stipulations and obligations as if they had been originally and expressively included and provided for in the specifications and drawings and the amounts to be paid therefore shall be

calculated in accordance with the accepted schedule of rates. Any extra items / quantities of work falling outside the purview of the provisions of sub-clause (2) above shall be paid for at the rates determined under clause-39 of these conditions.

Variations In Quantities During Execution of Works: - Individual items in contracts (**except item of Schedule A of SOR**) can be operated with variation of plus or minus 25% and payment would be made as per the agreement rate. In case an increase in quantity of an individual item by more than 25% of the agreement quantity is considered unavoidable, the same shall be got executed by floating a fresh tender. If floating a fresh tender for operating that item is considered not practicable, quantity of that item may be operated in excess of 125% of the agreement quantity after finalizing the rates mutually by both parties.

CLAIMS

- 43.(1). **Monthly Statement of Claims:-** The Contractor shall prepare and furnish to the Engineer once in every month an account giving full and detailed particulars of all claims for any additional expenses to which the Contractor may consider himself entitled to and of all extra or additional works ordered by the Engineer which he has executed during the preceding month and no claim for payment for and such work will be considered which has not been included in such particulars.
- 43.(2). **Signing of "No Claim" Certificate:-** The Contractor shall not be entitled to make any claim whatsoever against the DFCCIL under or by virtue of or arising out of this contract, nor shall the DFCCIL entertain or consider any such claim, if made by the Contractor, after he shall have signed a "No Claim" Certificate in favour of the DFCCIL in such form as shall be required by the DFCCIL after the works are finally measured up. The contractor shall be debarred from disputing the correctness of the items covered by "No Claim" Certificate or demanding a clearance to arbitration in respect thereof.

MEASUREMENTS, CERTIFICATES AND PAYMENTS

- **Quantities in schedule annexed to Contract:** The quantities set out in the accepted schedule of rates with items of works quantified are the estimated quantities of the work to be executed by the Contractor in fulfilment of his obligations under the contract.
- 45.(i). Measurement of works by DFCCIL: The Contractor shall be paid for the works at the rates in the accepted schedule of rates and for extra works at rates determined under Clause 39 of these conditions on the measurements taken by the Engineer or the Engineer's representative in accordance with the rules prescribed for the purpose by the DFCCIL. The date and time on which "on account" or final measurements are to be made shall be communicated to the Contractor who shall be present at the site and shall sign the results of the measurements (which shall also be signed by the Engineer or the Engineer's representative) recorded in the official measurements book as an acknowledgement of his acceptance of the accuracy of the measures. Failing the Contractor's attendance, the work may be measured up in his absence and such measurements shall, notwithstanding such absence, be binding upon the Contractor whether or not he shall have signed the measurement books provided always that any objection made by him to measurement shall be duly investigated and considered in the manner set out below:
 - (a) It shall be opened to the Contractor to take specific objection to any recorded measurements or Classification on any ground within seven days of the date of such measurements. Any remeasurement taken by the engineer or the Engineer's representative in the presence of the Contractor or in his absence after due notice has been given to him in consequence of objection made by the Contractor shall be final and binding on the Contractor and no claim whatsoever shall thereafter be entertained regarding the accuracy and classification of the measurements.

- **46.(5). Manner of payment:** Unless otherwise specified payments to the Contractor will be made by RTGS/NEFT only.

- 51.(1). **Final Payment:** On the Engineer's certificate of completion in respect of the works, adjustment shall be made and the balance of account based on the Engineer or the Engineer's representative's certified measurements of the total quantity of work executed by the contractor upto the date of completion and on the accepted schedule or rates and for extra works on rates determined under Clause 39 of these conditions shall be paid to the Contractor subject always to any deduction which may be made under these presents and further subject to the Contactor having delivered to the Engineer either a full account in detail of all claims he may have on the DFCCIL in respect of the works or having delivered "No Claim Certificate" and the Engineer having after the receipt of such account given a certificate in writing that such claims are not covered under excepted matter i.e. Clauses 7(j), 8, 18, 22(5), 39.1, 39.2, 40A, 43(2), 45(i)(a), 55, 55-A(5), 57, 57A, 61(1), 61(2) and 62(1), 63(iv) and 63.2.11 of the Standard General Conditions of Contract or in any Clause (stated as

The contractor shall similarly produce vouchers; etc., if required to prove to the Engineer, that materials supplied by him, are in accordance with the specifications laid down in the contract.
- (ii) If any portion of the work in a contract of value more than one crore of rupees be carried out by a sub-contractor or any subsidiary or allied firm or company (as per Clause 7 of the General Conditions of Contract), the Engineer shall have power to secure the books of such subcontract or any subsidiary or allied firm or company, through the contractor, and such books shall be open to his inspection.
- (iii) The obligations imposed by sub clause (i) & (ii) above is without prejudice to the obligations of the contractor under any statute rules or orders binding on the contractor.
- **52. Withholding and lien in respect of sums claimed:-** Whenever any claim or claims for payment of a sum of money arises out of or under the contract against the contractor, the DFCCIL shall be entitled to withhold and also have a lien to retain such sum or sums in whole or in part from the security, if any, deposited by the contractor and for the purpose aforesaid, the DFCCIL shall be entitled to withhold the security if any, furnished as the case may be and also have a lien over deposit or the security if any, furnished as the case may be and also have a lien over the same pending finalization or adjudication of any such claim. In the event of the security being insufficient to cover the claimed amount or amounts or if no security has been taken from the contractor, the DFCCIL shall be entitled to withhold and have a lien to the extent of the such claimed amount or amounts referred to supra, from any sum or sums found payable or which at any time thereafter may become payable to the contractor under the same contract or any other contract with this or any other DFCCIL or any Department of the Central Government pending finalization or adjudication of any such claim

It is an agreed term of the contract that the sum of money or moneys so withheld or retained under the lien referred to above, by the DFCCIL will be kept withheld or retained as such by the DFCCIL till the claim arising out of or under the contract is determined by the arbitrator (if the contract governed by the arbitration clause) or by the competent court as the case may be and that the contractor will have no claim for interest or damages whatsoever on any account in respect of such withholding or retention under the lien referred to supra and duly notified as such to the contractor. For the purpose of this clause, where the contractor is a partnership firm

or a limited company, the DFCCIL shall be entitled to withhold and also have a lien to retain towards such claimed amount or amounts in whole or in part from any sum found payable to any partner/limited company, as the case may be whether in his individual capacity or otherwise.

52.A Lien in respect of claims in Other Contracts:

- (i) Any sum of money due and payable to the contractor (including the PG returnable to him) under the contract may be withheld or retained by way of lien by the DFCCIL, against any claim of this or any other DFCCIL or any other Department of the Central Government in respect of a payment of a sum of money arising out of or under any other contract made by the contractor with this or any other Department of the Central Government.
- (ii) However, recovery of claims of DFCCIL in regard to terminated contracts may be made from the Final Bills and Performance Guarantees of other contract or contracts, executed by the contractor. The Performance Guarantees submitted by the Contractor against other contracts, if required, may be withheld and enchased. In addition, 10% of each subsequent 'on-account bill' may be withheld, if required, for recovery of DFCCIL's dues against the terminated contract.
- (iii) It is an agreed term of the contract that the sum of money so withheld or retained under this clause by the DFCCIL will be kept withheld or retained as such by the DFCCIL till the claim arising out of or under any other contract is either mutually settled or determined by arbitration, if the other contract is governed by arbitration clause or by the competent court as the case may be and contractor shall have no claim for interest or damages whatsoever on this account or on any other ground in respect of any sum of money withheld or retained under this clause and duly notified as such to the contractor.
- 53. Signature on Receipts for Amounts: Every receipt for money which may become payable or for any security which may become transferable to the Contractors under these presents, shall, if signed in the partnership name by anyone of the partners of a Contractor's firm be a good and sufficient discharge to the DFCCIL in respect of the moneys or security purported to be acknowledged thereby and in the event of death of any of the Contractor, partners during the pendency of the contract it is hereby expressly agreed that every receipt by anyone of the surviving Contractor partners shall if so signed as aforesaid be good a sufficient discharge as aforesaid provided that nothing in this clause contained shall be deemed to prejudice or effect any claim which the DFCCIL may hereafter have against the legal representative of any contractor partner so dying for or in respect to any breach of any of the conditions of the contract, provided also that nothing in this clause contained shall be deemed to prejudice or effect the respective rights or obligations of the Contractor partners and of the legal representatives of any deceased Contractor partners interse.

LABOUR

54. Wages to Labour :- The Contractor shall be responsible to ensure compliance with the provision of the Minimum Wages Act, 1948 (hereinafter referred to as the "said Act" and the Rules made there under in respect of any referred to as the "said Act" and the Rules made there under in respect of any employees directly or through petty contractors or subcontractors employed by him. If, incompliance with the terms of the contract, the Contractor supplied any labour to be used wholly or partly under the direct orders and control of the DFCCIL whether in connection with any work being executed by the Contractor or otherwise for the purpose of the DFCCIL such labour shall, for the purpose of this clause, still be deemed to be persons employed by the Contractor.

If any moneys shall, as a result of any claim or application made under the said Act be directed to be paid by the DFCCIL, such money shall be deemed to be moneys paid by it as aforesaid within seven days after the same shall have been demanded, the DFCCIL shall be entitled to recover the

same form any moneys due or accruing to the Contractor under this or any other Contract with the DFCCIL.

Apprentices Act: The Contractor shall be responsible to ensure compliance with the provisions of the Apprentices Act, 1961 and the Rules and Orders issued there under from time to time in respect of apprentices directly or through petty contractors or sub-contractors employed by him for the purpose of carrying out the Contract.

If the contractor directly or through petty contractors or sub-contractors fails to do so, his failure will be a breach of the contract and the DFCCIL may, in its discretion, rescind the contract. The contractor shall also be liable for any pecuniary liability arising on account of any violation of the provisions of the Act.

Note: The contractors are required to engage apprentices when the works undertaken by them last for a period of one year or more and / the cost of works is rupees one lakh or more.

Provisions of payments of Wages Act: The Contractor shall comply with the provisions of the Payment of Wages Act, 1936 and the rules made there under in respect of all employees directly or through petty contractors or sub-contractors employed by him in the works. If In compliance with the terms of the contract, the Contractor directly or through petty contractors of sub-contractors shall supply any labour to be used wholly or partly under the direct orders and control of the Engineer whether in connection with the works to be the less be deemed to comprise persons employed by the contractor and any moneys which may be ordered to be paid by the Engineer shall be deemed to be moneys payable by the Engineer on behalf of the Contractor and the Engineer may on failure of the contractor to repay such money to the DFCCIL deduct the same from moneys due to contractor in the terms of contract. The DFCCIL shall be entitled to deduct from any moneys due to the contractor (whether under this contract or any other contract) all moneys paid or payable by the DFCCIL by the way of compensation of aforesaid or for costs of expenses in connection with any claim thereto and the decision of the Engineer upon any question arising out of the effect or force of this clause shall be final and binding upon the Contractor.

55.A Provisions of Contract labour (Regulation and Abolition) Act, 1970:

- **55.A(1).** The contractor shall comply with the provision of the contract labour (Regulation and Abolition) Act, 1970 and the Contract labour (Regulation and Abolition) Central Rules 1971 as modified from time to time, wherever applicable and shall also indemnify the DFCCIL from and against any claims under the aforesaid Act and the Rules.
- **55.A(2).** The Contractor shall obtain a valid license under the aforesaid Act as modified from time to time before the commencement of the work and continue to have a valid licence until the completion of the work. Any failure to fulfill the requirement shall attract the penal provision of the Contract arising out of the resultant non-execution of the work.
- **55.A(3).** The Contractor shall pay to the labour employed by him directly or through subcontractors the wages as per provision of the aforesaid Act and the Rules wherever applicable. The Contractor shall notwithstanding the provisions of the contract to the contrary, cause to be paid the wages to labour indirectly engaged on the works including any engaged by subcontractors in connection with the said work, as if the labour had been immediately employed by him.
- **55.A(4).** In respect of all labour directly or indirectly employed in the work for performance of the contractor's part of, the contract, the Contractor shall comply with or cause to be complied with the provisions of the aforesaid Act and Rules wherever applicable.
- **55.A(5).** In every case in which, by virtue of the provisions of the aforesaid Act or the Rules, the DFCCIL is obliged to pay any amount of wages to a workman employed by the Contractor or his sub-

contractor in execution of the work or to incur any expenditure on account of the Contingent, liability of the DFCCIL due to the contractor's failure to fulfil his statutory obligations under the aforesaid Act or the rules the DFCCIL will recover from the Contractor, the amount of wages so paid or the amount of expenditure so incurred, and without prejudice to the rights of the DFCCIL under the section 20, sub-section (2) and section 2, sub-section (4) of the aforesaid Act, the DFCCIL shall be at liberty to recover such amount or part thereof by deducting it from the running bills and/ or from any sum due by the DFCCIL to the contractor whether under the contract or otherwise. The DFCCIL shall not be bound to contest any claim made against it under sub-section of section 20 and sub-section (4) of section 21 of the aforesaid Act except on the written request of the contractor and upon his giving to the DFCCIL full security for all costs for which the DFCCIL might become liable in contesting such claim. The decision of the DFCCIL regarding the amount actually recoverable from the contractor as stated above shall be final and binding on the Contractor.

55 B Provisions of Employees Provident Fund and Miscellaneous Provisions Act, 1952:

The Contractor shall comply with the provisions of Para 30 & 36-B of the Employees Provident Fund Scheme, 1952; Para 3 & 4 of Employees' Pension Scheme, 1995; and Para 7 & 8 of Employees Deposit Linked Insurance Scheme, 1976; as modified from time to time through enactment of "Employees Provident Fund & Miscellaneous Provisions Act, 1952", wherever applicable and shall also indemnify the DFCCIL from and against any claims under the aforesaid Act and the Rules.

- **55C (i)** Contractor is to abide by the provisions of various labour laws in terms of above clause 54, 55, 55-A and 55-B of the Standard General Conditions of Contract. In order to ensure the same, an application has been developed and hosted on website 'www.shramikkalyan.indianrailways.gov.in'. Contractor shall register his firm/company etc. and upload requisite details of labour and their payment in this portal. These details shall be available in public domain. The registration/ updation in Portal shall be done as under:
 - a) Contractor shall apply for onetime registration of his company/firm etc. in the Shramikkalyan portal with requisite details subsequent to issue of Letter of Acceptance. Engineer shall approve the contractor's registration in the portal within 7 days of receipt of such request.
 - b) Contractor once approved by any Engineer, can create password with login ID (PAN No.) for subsequent use of portal for all Letter of Acceptances (LoAs) issued in his favour.
 - c) The contractor once registered on the portal, shall provide details of his Letter of Acceptances (LoAs) / Contract Agreements on shramikkalyan portal within 15 days of issue of any LoA for approval of concerned Engineer. Engineer shall update (if required) and approve the details of LoA filled by contractor within 7 days of receipt of such request.
 - d) After approval of LoA by Engineer, contractor shall fill the salient details of contract labours engaged in the contract and ensure updating of each wage payment to them on shramikkalyan portal on monthly basis.
 - e) It shall be mandatory upon the contractor to ensure correct and prompt uploading of all salient details of engaged contractual labour & payments made thereof after each wage period.
 - (ii) While processing payment of any 'On Account Bill' or 'Final Bill' or release of 'Advances' or 'Performance Guarantee', contractor shall submit a certificate to the Engineer or Engineer's representatives that "I have uploaded the correct details of contract labours engaged in connection with this contract and payments made to them during the wage period in Railway's Shramik_kalyan portal at 'www.shramikkalyan.indianrailways.gov.in' till Month, Year."
- Reporting of Accidents of Labour: The Contractor shall be responsible for the safety of all employees directly or through petty contractors or sub- contractor employed by him on the works and shall report serious accidents to any of them however and wherever occurring on the works to the Engineer or the Engineers Representative and shall made every arrangements to render all

possible assistance.

- Provision of Workmen's Compensation Act: In every case in which by virtue of the provisions of section 12 sub-section (1) of the Workmen's Compensation Act 1923, DFCCIL is obliged to pay compensation to a workman directly or through petty contractor or subcontractor employed by the Contractor in executing the work, DFCCIL will recover from the Contractor the amount of the compensation so paid, and, without prejudice to the rights of DFCCIL under Section 12 Sub-section of the said Act, DFCCIL shall be at liberty to recover such amount or any part thereof by deducting it from the next running bills or from any sum due by DFCCIL to the Contractor whether under these conditions or otherwise, DFCCIL shall not be bound to contest any claim made against it under Section 12 Sub-section (1) of the said Act except on the written request of the Contractor and upon his giving to DFCCIL full security for all costs for which DFCCIL might become liable in consequence of contesting such claim.
- **57.A** Provision of Mines Act:- Not applicable for O & M contract.
- **58.** DFCCIL not to provide quarters for Contractors: No quarters shall normally be provided by the DFCCIL for the accommodation of the contractor or any of his staff employed on the work.
- **59(1).** Labor Camps: Refer SCC of this Contract.
- **59(2).** Compliance to rules for employment of labour:- The contractor(s) shall conform to all laws, by-laws rules and regulations for the time being in force pertaining to the employment of local or imported labour and shall take all necessary precautions to ensure and preserve the health and safety of all staff employed directly or through petty contractors or sub-contractors on the works.
- **59(3). Preservation of peace:-** The contractor shall take requisite precautions and use his best endeavours to prevent any riotous or unlawful behavior by or amongst his workmen and other employed directly or through the petty contractors or sub-contractors on the works and for the preservation of peace and protection of the inhabitants and security of property in the neighborhood of the works. In the event of the DFCCIL requiring the maintenance of a special Police Force at or in the vicinity of the site during the tenure of works, the expenses thereof shall be borne by the contractor and if paid by the DFCCIL shall be recoverable from the contractor.
- **59(4). Sanitary arrangements:** The contractor shall obey all sanitary rules and carry out all sanitary measures that may from time to time be prescribed by the Medical Authority and permit inspection of all sanitary arrangements at all times by the Engineer, the Engineer's Representative of the Medical staff of the DFCCIL. Should the contractor fail to make the adequate sanitary arrangements, these will be provided by the DFCCIL and the cost therefore recovered from the contractor.
- 59(5). Outbreak of infectious disease: The contractor shall remove from his camp such labour and their families as refuse protective inoculation and vaccination when called upon to do so by the Engineer or the Engineer's representative on the advice of the DFCCIL. Should cholera, plague or other infectious disease break out, the contractor shall burn the huts, beddings, clothes and other belongings of or used by the infected parties and promptly erect new huts on health sites as required by the engineer, failing which within the time specified in the Engineer's requisition, the work may be done by the DFCCIL and the cost therefore recovered from the contractor.
- **59(6).** Deleted
- **59(7). Medical facilities at site: -** The Contractor shall provide medical facilities at the site as may be prescribed by the Engineer on the advice of the DFCCIL in relation to the strength of the Contractor's **resident** staff and workmen.
- **59(8).** Use of intoxicants: The sale of ardent spirits or other intoxicating beverages upon the work or in

any of the buildings, encampments or tenements owned, occupied by or within the control of the contractor or any of his employees shall be forbidden and the Contractor shall exercise his influence and authority to the utmost extent to secure strict compliance with this condition.

- **59(9). Non-employment of female labour:** The Contactor shall see that the employment of female labour on/in Cantonment areas, particularly in the neighborhood of soldier's barracks, should be avoided as far as possible.
- 59(10). Restrictions On The Employment Of Retired Engineers Of Railway/DFCCIL Services Within one Year Of Their Retirement: The Contractor shall not, if he is a retired Government Engineer of Gazetted rank, himself engage in or employ or associate a retired Government Engineer of Gazetted rank, who has not completed one year from the date of retirement, in connection with this contract in any manner whatsoever without obtaining prior permission of the President and if the Contractor is found to have contravened this provision it will constitute a breach of contract and administration will be entitled to terminate the contract and forfeit BID SECURITY and Performance Guarantee (PG) of that contract.
- **60.(1).** Non-employment of labours below the age of 15: the Contractor shall not employ children below the age of 15 as laborer's directly or through petty contractors or subcontractors for the execution of work.
- **60.(2). Medical Certificate of fitness for labour:** It is agreed that the contractor shall not employ a person above 15 and below 19 years of age for the purpose of execution of work under the contract unless a medical certificate of fitness in the prescribed form (Proforma at **Form- 23**) granted to him by a certifying surgeon certifying **that** he is fit to work as an adult is obtained and kept in the custody of the contractor or a person nominated by him in this behalf and the person carries with him, while at work; a token giving a reference to such certificate. It is further agreed that the responsibility for having the adolescent examined medically at the time of appointment or periodically till he attains the age of 19 years shall devolve entirely on the contractor and all the expenses to be incurred on this account shall be borne by him and no fee shall be charged from the adolescent or his parent for such medical examination.
- **60.(3). Period of validity of medical fitness certificate:** A certificate of fitness granted or renewed for the above said purposes shall be valid only for a period of one year at a time. The certifying surgeon shall revoke a certificate granted or renewed if in his opinion the holder of it is, no longer fit for work in the capacity stated therein. Where a certifying surgeon refuses to grant or renew a certificate or revoke a **certificate**, he shall, if so required by the person concerned, state his reasons in writing for doing so.
- 60.(4). Medical re-examination of labourer:- Where any official appointed in this behalf by the Ministry of labour is of the opinion that any person employed in connection with the execution of any work under this contract in the age group 15 to 19 years is without a certificate of fitness or is having a certificate of fitness but no longer fit to work in the capacity stated in the certificate, he may serve on the Contractor, or on the person nominated by him in the regard, a notice requiring that such persons shall be examined by a certifying surgeon and such person shall not if the concerned official so directs, be employed or permitted to do any work under this contract unless he has been medically examined and certified that he has been granted a certificate of fitness or a fresh certificate of fitness, as the case may be.

EXPLANATIONS:-

- (1) Only qualified medical practitioners can be appointed as "Certifying Surgeons" and the term "Qualified Medical Practitioners" means a person holding a qualification granted by an authority specified in the Schedule to the Indian Medical Degrees Act, 1916 (VII to 1916) or in the Schedule to the Indian Medical Council Act, 1933 (XXVII) of 1933.
- (2) The Certifying surgeon may be a medical officer in the service of State or Municipal Corporation.

DETERMINATION OF CONTRACT

- **61.(1). Right of DFCCIL of determine the contract:** The DFCCIL shall be entitled to determine and terminate the contract at any time should, in the DFCCIL's opinion, the cessation of work becomes necessary owing to paucity of funds or from any other cause whatever.
- **61.(2).** Payment on determination of contract: Refer SCC of this O & M Contract.
- **61.(3).** The contractor shall have no claim to any payment of compensation or otherwise, howsoever on account of any profit or advantage which he might have derived from the execution of the work in full but which he did not derive in consequence of determination of contract. Refer SCC of this O & M Contract
- **62(1)** Determination of contract owing to default of contractor: If the Contractor should:
 - (i) Becomes bankrupt or insolvent, or
 - (ii) Make an arrangement with of assignment in favour of his creditors, or agree to carry out the contract under a Committee of Inspection of his creditors, or
 - (iii) Being a Company or Corporation, go into liquidation (other than a voluntary liquidation for the purposes of amalgamation or reconstruction), or
 - (iv) Have an execution levied on his goods or property on the works, or
 - (v) Assign the contract or any part thereof otherwise than as provided in Clause 7 of these conditions, or
 - (vi) Abandon the contract, or
 - (vii) Persistently disregard the instructions of the Engineer, or contravene any provision of the contract, or
 - (viii) Fail to Execute the contract documents on time or
 - (ix) Fail to remove materials from the site or to pull down and rectify work after receiving from the Engineer notice to the effect that the said materials or works have been condemned or rejected under clause 25 and 27 of these conditions, or
 - (x) Fail to take steps to employ competent or additional staff and labour as required under clause 26 of the conditions.
 - (xi) Fail to afford the Engineer or Engineer's representative proper facilities for inspecting the work or any part thereof as required under clause 28 of the conditions, or
 - (xii) Promise, offer or give any bribe, commission, gift or advantage either himself or through his partner, agent or servant to any officer or employee of the DFCCIL or to any person on his or on their behalf in relation to the execution of this or any other contract with this DFCCIL.
 - (xiii) At any time after the tender relating to the contract, has been signed and submitted by the Contractor, being a partnership firm admit as one of its partners or employee under it or being an incorporated company elect or nominate or allow to act as one of its directors or employee under it in any capacity whatsoever any retired engineer of the gazetted rank or any other retired gazetted officer working before his retirement, whether in the executive or administrative capacity, or whether holding any pensionable post or not, in the DFCCIL for the time being owned and administered by the President of India before the expiry of one year from the date of retirement from the said service of such Engineer or Officer unless such Engineer or Officer has obtained permission from the President of India or any officer duly authorized by him in this behalf to become a partner or a director or to take employment under the contract as the case may be, or
 - (xv) Fail to give at the time of submitting the said tender:
 - a. The correct information as to the date of retirement of such retired engineer or retried officer

from the said service, or as to whether any such retired engineer or retired officer was under the employment of the Contractor at the time of submitting the said tender, or

- b. The correct information as to such engineers or officers obtaining permission to take employment under the contractor, or
- c. Being a partnership firm, the correct information as to, whether any of its partners was such a retired engineer or a retired officer, or
- d. Being in incorporated company, correct information as to whether any of its directors was such a retired engineer or a retired officer, or
- e. Being such a retired engineer or retried officer suppress and not disclose at the time of submitting the said tender the fact of his being such a retired engineer or a retired officer or make at the time of submitting the said tender a wrong statement in relation to his obtaining permission to take the contract or if the contractor be a partnership firm or an incorporated company to be a partner or director of such firm or company as the case may be or to seek employment under the contractor.

Then and in any of the said clause, the Engineer on behalf of the DFCCIL may serve the Contractor with a notice (as per Proforma as **Form-24**) in writing to that effect and if the contractor does not within seven days after the delivery to him such notice proceed to make good his default in so far as thereof being made good and carry on the work or comply with such directions as aforesaid of the entire satisfaction of the Engineer, the DFCCIL shall be entitled after giving 48 hours' notice (as per Proforma as **Form-25**) in writing under the hand of the Engineer to rescind the and after expiry of 48 hours' notice, a final termination notice (as per Proforma as **Form-26**) should be issued and adopt the following courses:

To measure up of the work from which the contractor has been removed and get it completed by another contractor, the manner and method in which such work is completed shall be in the entire discretion of the Engineer whose decision shall be final.

62.(2). Right of DFCCIL after, rescission of contract owing to default of contractor: In the event of any or several of the courses, referred to in sub-clause (1) of the clause, being adopted.

- (a) the contractor shall have no claim to compensation for any loss sustained by him by reason of his having purchased or procured any materials or entered into any commitments or made any advances on account of or with a view to the execution of the works or the performance of the contract and contractor shall not be entitled to recover or be paid any sum for any work thereto for actually performed under the contract unless and until the Engineer shall have certified the performance of such work and the value payable in respect thereof and the contractor shall only be entitled to be paid the value so certified.
- (b) In the contract which has been rescinded, the Performance Guarantee already submitted for the contract shall be encashed. The failed Contractor shall be debarred from participating in the tender for executing the balance work. If the failed Contractor is a JV or a Partnership firm, then every member/partner of such a firm shall be debarred from participating in the tender for the balance work in his/her individual capacity or as a partner of any other JV /partnership firm.

Further the authorized representative of failed Contractor cannot be accepted as authorized representative in new contract.

STATEMENT OF DISPUTES - ARBITRATION

63.0 Conciliation of Disputes

(i) This clause is applicable in the tender having an advertised value less than or equal to

- (ii) All disputes and differences of any kind whatsoever arising out of or in connection with the contract, whether during the progress of the work or after its completion and whether before or after the determination of the contract, shall be referred by the Contractor to the "CGM/CPM/GM" through "Notice of Dispute" provided that no such notice shall be served later than 30 days after the date of issue of Completion Certificate by the Engineer. CPM/CGM/GM shall, within 30 days after receipt of the Contractor's "Notice of Dispute", notify the name of conciliator(s) to the Contractor.
- (iii) The Conciliator(s) shall assist the parties to reach an amicable settlement in an independent and impartial manner within the terms of contract.
- (iv) In case the total value of all claims in dispute added together does not exceed Rs. One Crore, the number of Conciliator shall be one. For claims more than Rs. One Crore and upto Rs. Fifty Crore, the number of Conciliators shall be three.
- (v) The Sole Conciliator shall be nominated by the MD/ DFCCIL from the List of Empaneled Arbitrators / Conciliators maintained by DFCCIL. The sole arbitrator shall be appointed within 60 days from the day when a written and valid demand for Conciliation is received by CGM/CPM/GM of DFCCIL.
- (vi) In case, the Conciliation process consist of a panel of three members, the DFCCIL will send a panel of at least four (4) names from the List of Empaneled Arbitrators /Conciliators with DFCCIL empaneled to work as Arbitrator /Conciliator to the Contractor within 60 days from the day when a written and valid demand for Conciliation is received by the CGM/CPM/GM of DFCCIL. Contractor will be asked to suggest to MD/DFCCIL at least 2 names out of the panel for appointment as Contractor's nominee within 30 days from the date of dispatch of the request by DFCCIL. The MD shall appoint at least one out of them as the Contractor's nominee and will, also simultaneously appoint the balance number of conciliators either from the panel or from outside the panel, duly indicating the 'presiding conciliator' from amongst the 3 conciliators so appointed. MD DFCCIL shall complete this exercise of appointing the Conciliation Panel within 30 days from the receipt of the names of Contractor's nominees.
- (vii) If the parties reach agreement on a settlement of the dispute, they shall draw up and sign a written settlement agreement duly signed by Engineer, Contractor and conciliator(s). When the parties sign the settlement agreement, it shall be final and binding on the parties.
- (viii) The parties shall not initiate, during the conciliation proceedings, any arbitral or judicial proceedings in respect of a dispute that is the subject matter of the conciliation proceedings.
- (ix) The conciliation proceedings shall be subject to the provisions of the Arbitration and Conciliation Act 1996 and its amendments thereof.
- 63.1 **Matters Finally Determined by the DFCCIL:** All disputes and differences of any kind whatsoever arising out of or in connection with the contract, whether during the progress of the work or after its completion and whether before or after the determination of the contract, shall

be referred by the Contractor to the MD/DFCCIL and the MD/DFCCIL shall, within 120 days after receipt of the Contractor's representation, make and notify decisions on all matters referred to by the Contractor in writing provided that matters for which provision has been made in Clauses 7(j), 8, 18, 22(5),39.1, 39.2, 40A,43(2), 45(i)(a), 55, 55-A(5), 57, 57A,61(1), 61(2),62(1), 63(iv) and 63.2.11 of the General Conditions of Contract or in any Clause (stated as excepted matter) of the Special Conditions of the Contract, shall be deemed as 'excepted matters' (matters not arbitrable) and decisions of the DFCCIL authority, thereon shall be final and binding on the Contractor; provided further that 'excepted matters' shall stand specifically excluded from the purview of the Conciliation, Dispute Adjudication Board (DAB) and Arbitration.

- 63.2 **Dispute Adjudication Board (DAB):** This clause is applicable in the tender having advertised value more than Rs 50 Crore.
- 63.2.1 Any dispute/s if not settled with the Engineer, shall be referred to DAB.

The DAB shall consist of a panel of three Adjudicators from the List of Empaneled Arbitrators/Conciliators maintained by DFCCIL. The DAB shall be formed within 90 days of signing of Contract Agreement. For this purpose, a Panel of DAB members shall be maintained in the DFCCIL Corporate Office, New Delhi. The complete Panel, which shall not be less than five members, shall be sent by DFCCIL to the Contractor to nominate one member of the DAB from the panel as Contractor's nominee within two weeks of receipt of the Panel. On receipt of Contractor's nominee, the MD/DFCCIL shall nominate one member from the same Panel as DFCCIL nominee for the DAB. Both above nominees shall jointly select presiding member of the DAB from the same Panel.

- 63.2.2 The General condition of Dispute Adjudication Agreement is laid down in **Annexure- I.** The appointment of DAB shall be effectuated by way of a tri-partite DAB Agreement among the DFCCIL, Contractor and the respective DAB members as per format of **Annexure No. III**. The terms of the remuneration of each member shall be as fixed by DFCCIL from time to time. Each party shall be responsible for paying one-half of this remuneration.
- 63.2.3 If one or more of the members appointed refuses to act as DAB member, or is unable or unwilling to perform his functions as DAB member for any reason whatsoever or dies or in the opinion of the MD fails to act without undue delay, the parties shall terminate the mandate of such DAB member and thereupon new DAB member shall be appointed in the same manner, as the outgoing DAB member had been appointed.
- 63.2.4 The appointment of any member may be terminated by mutual agreement of both Parties, but not by the DFCCIL or the Contractor acting alone. Unless otherwise agreed by both the Parties, the appointment of the DAB (including each member) shall expire upon expiry of this Contract Agreement.
- 63.2.5 Before start of DAB proceedings, each DAB member shall give the following certificate to the DFCCIL and the Contractor:

"I have no any past or present relationship in relation to the subject matter in dispute, whether financial, business, professional or other kind. Further, I have no any past or present relationship with or interest in any of the parties whether financial, business, professional or other kind, which is likely to give rise to justifiable doubts as to my independence or impartiality."

- 63.2.6 DAB proceedings shall be conducted as per Procedural Rules to Dispute Adjudication laid down in **Annexure II.** The DAB shall give its decision within 84 days of a Dispute referred to it by any of the Parties, duly recording the reasons before arriving at the decision. The DAB shall decide the issue within terms and conditions of the contract. This time limit shall be extendable subject to the Parties mutual agreement.
- 63.2.7 In case any party is not satisfied by the decision of DAB, then the aggrieved party may, within 28 days after receiving the decision, give notice to the other Party of its dissatisfaction. If the DAB has given its decision as to a matter in dispute to both Parties, and no notice of dissatisfaction has been given by either Party within 28 days after its received the DAB's decision, then the decision shall become final and binding upon the Parties.
- 63.2.8 No dispute shall be referred to Arbitral Tribunal unless the same has been referred to DAB for adjudication. However, in case DAB is not formed due to any reason, the disputes can be directly referred to Arbitral Tribunal to adjudicate the dispute.
- 63.2.9 In the specific cases of any misconduct by any of the members of the DAB, the parties shall have the right to specifically bring it to the notice of the DAB such conduct, through a statement filed with necessary documents in proof of such misconduct and the DAB, after taking NOTICE of such conduct initiate the replacement of the member concerned, in the same manner the member to be replaced was appointed.
- 63.2.10 Once the decision is given by DAB, DAB cannot review the decision at its own or on the request of one party, unless both parties agree for review of decision by DAB.
- 63.2.11 In case DAB decision is not challenged, or no Notice of Dissatisfaction has been issued by either Party within 28 days of receipt of decision of DAB, the decision shall be considered as final and parties would be barred for referring the same to Arbitral Tribunal for adjudication.
- 63.2.12 The obligation of the DFCCIL and the Contactor shall not be altered by reasons of issue being or under reference to DAB.
- 63.2.13 The DAB shall conduct the proceedings at any convenient venue which shall be decided by DAB in consultations with parties.
- 63.2.14 It is a term of this contract that the Parties shall not approach any Court of Law for settlement of such disputes or differences unless an attempt has first been made by the parties to settle such disputes or differences through DAB and Arbitral Tribunal.

64. (1) Demand for Arbitration:

64. (1)(i) (a) In the event of any dispute or difference between the parties hereto as to the construction or operation of this contract, or the respective rights and liabilities of the parties on any

matter in question, dispute or difference on any account or as to the withholding by the DFCCIL of any certificate to which the contractor may claim to be entitled to, or if the DFCCIL fails to make a decision within 120 days, then and in any such case, but except in any of the 'excepted matters' referred to in clause 63 of these conditions, the contractor, after 120 days but within 180 days of his presenting his final claim on disputed matters shall demand in writing that the dispute or difference be referred to arbitration.

- (b) A dispute, unless settled though Conciliation or in which DAB's decision has become final and binding, shall be finally settled by Arbitration as per Arbitration and Conciliation Act 1996 and its amendments thereof.
- 64.(1) (ii) The demand for arbitration shall specify the matters which are in question, or subject of the dispute or difference as also the amount of claim item wise. Only such dispute or difference, in respect of which the demand has been made, together with counter claims or set off, given by the DFCCIL, shall be referred to arbitration and other matters shall not be included in the reference.
- **64.(1) (iii)** (a) The arbitration proceedings shall be assumed to have commenced from the day, a written and valid demand for arbitration is received by the DFCCIL.
 - (b) The claimant shall submit his claim stating the facts supporting the claims along with all the relevant documents and the relief or remedy sought against each claim within a period of 30 days from the date of appointment of the Arbitral Tribunal.
 - (c) The DFCCIL shall submit its defence statement and counter claim(s), if any, within a period of 60 days of receipt of copy of claims from Tribunal thereafter, unless otherwise extension has been granted by Tribunal.
 - (d) The seat of arbitration would be (New Delhi). However, the venue for arbitration meetings or hearings can be any other place with the consent of parties.
 - (e) Both the parties shall submit to the jurisdiction of the courts situated at New Delhi for the purpose of actions and proceedings arising out of the contract and the courts at Delhi shall have the sole and exclusive jurisdiction to hear and decide such actions and proceedings.
- **64.(1)(iv)** No new claim shall be added during proceedings by either party. However, a party may amend or supplement the original claim or defence thereof during the course of arbitration proceedings subject to acceptance by Tribunal having due regard to the delay in making it.
- **64.(1)(v)** If the contractor(s) does/do not prefer his/their specific and final claims in writing, within a period of 90 days of receiving the intimation from the DFCCIL that the final bill is ready for payment, he/they will be deemed to have waived his/their claim(s) and the DFCCIL shall be discharged and released of all liabilities under the contract in respect of these claims.
- **64.(2) Obligation During Pendency of Arbitration:** Work under the contract shall, unless otherwise directed by the Engineer, continue during the arbitration proceedings, and no payment due or payable by the DFCCIL shall be withheld on account of such proceedings, provided, however, it shall be open for Arbitral Tribunal to consider and decide whether or not such

work should continue during arbitration proceedings.

64.(3) Appointment of arbitrator

- **64.(3)(a):** In cases where the total value of all claims in question added together does not exceed ₹ 1,00,00,000/- (Rupees One Crore), the Arbitral Tribunal shall consist of a Sole Arbitrator from the List of Empaneled Arbitrators, nominated by the MD/DFCCIL. The sole arbitrator shall be appointed within 60 days from the day when a written and valid demand for arbitration is received by MD/ DFCCIL.
- **64.(3)(b):** In cases not covered by the Clause 64(3)(a), the Arbitral Tribunal shall consist of a panel of three members, as the arbitrators. For this purpose, a broad based panel of Arbitrators shall be maintained in DFCCIL corporate office, New Delhi. The panel, which shall not be less than 5 members, shall be sent by CGM/GM DFCCIL to the Contractor to nominate one member of Arbitral Tribunal from the Pannel as Contractor's Nominee within 2 weeks of receipt of the panel. On receipt of Contractor's Nominee, the MD/DFCCIL shall nominate one member from the same panel as DFCCIL nominee for the Arbitral Tribunal. Both above nominees shall jointly select Presiding Arbitrator of the Arbitral Tribunal from the same panel.
- 64.(3)(c) (i): If one or more of the arbitrators appointed as above refuses to act as arbitrator, withdraws from his office as arbitrator, or vacates his/their office/offices or is/are unable or unwilling to perform his functions as arbitrator for any reason whatsoever or dies or in the opinion of the MD DFCCIL fails to act without undue delay, the MD DFCCIL shall appoint new arbitrator/arbitrators to act in his/their place in the same manner in which the earlier arbitrator/arbitrators had been appointed. Such re-constituted Tribunal may, at its discretion, proceed with the reference from the stage at which it was left by the previous arbitrator (s).
- 64.(3)(c)(ii): (a) The Arbitral Tribunal shall have power to call for such evidence by way of affidavits or otherwise as the Arbitral Tribunal shall think proper, and it shall be the duty of the parties hereto to do or cause to be done all such things as may be necessary to enable the Arbitral Tribunal to make the award without any delay. The proceedings shall normally be conducted on the basis of documents and written statements.
 - (b) Before proceeding into the merits of any dispute, the Arbitral Tribunal shall first decide and pass its orders over any plea submitted/objections raised by any party, if any, regarding appointment of Arbitral Tribunal, validity of arbitration agreement, jurisdiction and scope of the Tribunal to dealwith the dispute (s) submitted to arbitration, applicability of time 'limitation' to any dispute, any violation of agreed procedure regarding conduct of the arbitral proceedings or plea for interimmeasures of protection and record its orders in day to day proceedings. A copy of the proceedings duly signed by all the members of tribunal should be provided to both the parties.
- **64.3(c)(iii):** While appointing arbitrator(s) under Sub-Clause 64.(3)(a) & 64.(3)(b) above, due care shall be taken that he/they is/are not the one/those who had an opportunity to deal with the matters to which the contract relates or who in the course of his/their duties as DFCCIL/Railway servant(s) expressed views on all or any of the matters under dispute or differences. A certification to this shall be taken from Arbitrators also. The proceedings of the Arbitral tribunal or the award made by such Tribunal will, however, not be invalidmentally for the reason that one or more arbitrator had, in the course of his service, opportunity to deal with the matters to which the contract relates or who in the course of his/their duties expressed views on all or any of the matters

- **64.(3)(d)(i):** The arbitral award shall state item wise, the sum and reasons upon which it is based. The analysis and reasons shall be detailed enough so that the award could be inferred therefrom.
- **64.(3)(d)(ii):** A party may apply for corrections of any computational errors, any typographical or clerical errors or any other error of similar nature occurring in the award of a Tribunal and interpretation of a specific point of award to Tribunal within 60 days of receipt of the award.
- **64.(3)(d)(iii):** A party may apply to Tribunal within 60 days of receipt of award to make an additional award as to claims presented in the arbitral proceedings but omitted from the arbitral award.
- **64.(4):** In case of the Tribunal, comprising of three members, any ruling on award shall be made by a majority of members of Tribunal. In the absence of such a majority, the views of the Presiding Arbitrator shall prevail.
- **64.(5):** Where the arbitral award is for the payment of money, no interest shall be payable on wholeor any part of the money for any period till the date on which the award is made.
- 64.(6): The cost of arbitration shall be borne by the respective parties. The cost shall inter-alia include fee of the arbitrator(s), as per the rates fixed by DFCCIL from time to time and the fee shall be borne equally by both the parties, provided parties sign an agreement in the format given at Annexure-IV to these conditions after/ while referring these disputes to Arbitration. Further, the fee payable to the arbitrator(s) would be governed by the instructions issued on the subject by DFCCIL from time to time irrespective of the fact whether the arbitrator(s) is/are appointed by the DFCCIL or by the court of law unless specifically directed by Hon'ble court otherwise on the matter.
 - **64.(7)** Subject to the provisions of the aforesaid Arbitration and Conciliation Act 1996 (as amended up to date) and the rules thereunder and relevant para of the General Conditions of Contract and any statutory modifications thereof shall apply to the appointment of arbitrators and arbitration proceedings under this Clause.
 - 64.(8) In case arbitration award is challenged by a party in the Court of Law, 75% of award amount, pending adjudication by Court of Law, shall be made by party to other party. In case payment is to be made by DFCCIL to Contractor, the terms & conditions incorporated in the DFCCIL Policy as amended from time to time, shall be followed. In case Contractor has to pay to the DFCCIL, then 75% of the award amount shall be deducted by the DFCCIL from the Contractor's bills, Performance Guarantee or any other dues of Contractor with the Government of India.
 - **64.(9)** The Arbitrator Fee will be governed by latest Fee structure for emplaned DFCCIL arbitrators.

Chapter V

Terms of reference (TOR)

General

- The Maintenance of DFCCIL RGM Formation and RIV has to be done as per maintenance provisions given in Chapter VII and VIII of this RFP. If any provision of Maintenance is not mentioned in Chapter VII and VIII of this RFP, then OEMs maintenance manual has to be referred and in case any provision of Maintenance is missing in OEMs manual, then Maintenance of DFCCIL RGM Formation and RIV has to be done as per good industry practices.
- 2 Contractor shall submit Project Quality Plan and Project Quality Assurance which shall be scrutinized by the DFCCIL prior to being adopted in implementation of this O&M Contract. A bad Quality Work shall constitute Non-Performance and DFCCIL shall be entitled to Contractual remedies to make good their losses.
- Bidders shall submit Back-to-back Technical support, by way of a duly Apostilled OEM Technical Support Letter from the Original Equipment Manufacturer (OEM-M/s Loram Maintenance of Way Inc.-USA). OEM's Technical Support includes direct interaction with M/S Loram, USA to address machine service needs. The cost of 1 M/s Loram, USA Equipment Specialist for three (3) days visit in every 3 months for entire duration of contract is included in the rate of item No.1 and 2 of Schedule A of SOR of this RFP.
- The O&M Contractor shall submit **a** detailed report, within 90 days of the commencement of this O&M Contract, duly delineating in sufficient elaboration the current status / health of the RGM Formation and RIV as on commencement date so as to enable the DFCCIL to correctly assess the condition of RGM Formation and RIV.
- 5 The DFCCIL shall hand over all the spares/consumables available with DFCCIL for the O & M of the RIV & RGM Machines to O & M Contractor with 15 days of issue of LOA.
- A comprehensive List of machine spare parts (in **Form 3B)** and consumables (**Form 3C)** of RFP on best assessment basis to be submitted by the Bidders in **Financial Bid**. All Machine spare parts and consumables, mentioned in the comprehensive list, shall be procured and brought to DFCCIL Premises at designated place (depot) as per inventory yard stick submitted by Bidder. The newly procured machine spares and released after replacement components shall be the property of DFCCIL. Transportation of machine Spares to the machine from DFCCIL Depot and vice-versa will be the responsibility of O&M Contractor. All taxes (excluding GST) and other duties levied on transportation of issued materials will be reimbursed on production of invoices. The designate mother depot will be New Dadri and satellite locations will be at New Manauri and New Saradhana..
- All tools and plants, drawings, manuals, which have been supplied by the OEM to DFCCIL will be handed over to the O&M Contractor free of cost for use along with the machine during O&M Services period. O&M Contractor shall maintain a real time-based record of the inventory of such Material, Tools and plants (T&Ps) in a separate Ledger (to kept with Machine operating Staff) for inspection by DFCCIL Personnel. All these Materials and T&P etc are to be handed over in good/working condition after expiry of the contract period to DFCCIL.

- 8 Availability of RGM Formation & RIV for operation- O&M Contractor shall, in consultation with DFCCIL, draw up a comprehensive grind plan for the next 30 days which shall be given effect to.
- In case applicable to POH, Process of Successful Completion of POH along with details of each operation carried out in correct sequence, as per approved Method Statement and Work plan of each POH, under the direct supervision of OEM's (M/s Loram,USA) relevant personnel including domain experts. Such a document would be provided 06 months prior to the scheduled commencement of POH and will also include the list of spares what would be anticipated to be used during the POH. The list of spares while exhaustive may not be complete as once the machine is opened, additional parts may be required and those will also be included in the scope of supply with due notice to DFCCIL for the POH completion. The OEM expert shall certify, under submission of a detailed Report of successful completion of POH, that POH operation were carried out as per approved method statement and work plan and the Machines functionality was restored nearly to original and the Machines would, except normal scheduled repairs and scheduled replacement of Spares, and grinding stones. Any recommended spares replaced during the POH shall not be replaced during the subsequent 1-year spares free period).

Rail Grinding

- **10 Rail Grinding** is done to re-profile the railhead taking into consideration the profile of the wheel for optimization of the rail wheel contact band and thereby making rail wheel interaction favorable with expectation that rail grinding increases the life of the rail and the wheel, apart from reducing the rate of generation of defects in the rails.
- 11 **Target Rail profile** Target rail profiles are the rail profiles to be achieved after rail grinding and are designed to produce minimum contact stresses during rail wheel interaction. Nature of Rail Wheel interaction is different on straight track as compared to curved track. It is different on mild curves and on sharp curves, for high rail and for low rail of a curve. The target rail profiles to be achieved by grinding are therefore different for each of these locations and are designed to produce least stresses during rail wheel interaction.
- 12 **Patterns** Grinding stones are positioned across the railhead to achieve a particular pattern for removal of metal. The position of a stone is characterized by the angle of the rotation axis of the stone from the vertical. Thus, depending upon the angle, the location of the grinding by each of the stone on the railhead will vary. A pattern will be defined by angle and power of each of the motors working on the railhead. For grinding at different locations, it is required to select one of the designed grinding patterns to achieve the target rail profile in one or more passes. Different patterns may be used for left and right rail of the same track. Metal removal from the railhead will depend upon the following factors:
 - (a) The number of grinding stones working on a rail.
 - (b) The power of the motors.
 - (c) Speed of grinding.
 - (d) Number of passes.
 - (e) Hardness of the rail.
 - (f) Characteristics of grinding stones (depending on specifications of the manufacturer).




- Grind data Management system- O&M Contractor may use Grind Data Management System (GDMS) of M/s Loram, USA which is an integrated automatic data acquisition, data management, quality control, reporting, and planning tool for Rail Grinding. GDMS is a software-based system, which is fed with track data, different pre-decided patterns and proposed target profiles for different track geometry and structure. It uses these details to suggest patterns to be followed for grinding at different locations. It uses laser-based rail profile management system available in the front as well as on the rear of the grinding machine, also available in the RIV, to record the pre and post grinding rail profile. By taking a measuring run of RIV, in advance, GDMS has the facility of recommending one of the pre-fed patterns to get target rail profile from the existing rail profile. After measuring the existing rail profile and choosing the target rail profile, GDMS recommends patterns and speed to get the most efficient results. O&M Contractor is free either to use M/s LORAM, USA GDMS or can adopt any other GDMS in use on any Advanced Railway System of any country of world.
- Grinding Strategy -The O&M Contractor shall, upon the basis of the Target Rail profile and patterns to achieve such target Rail profile being decided through application of GDMS, adopt a suitable Grinding Strategy to decide the metal removal during the process of grinding and the frequency of grinding with a purpose to control Rolling Contact Fatigue. O&M Contractor shall decide the type of rail grinding whether it would be (i) Preventive Grinding, (ii) Preventive Gradual grinding or (iii) Corrective grinding. O&M Contractor shall share, the prior RIV run generated date fed GDMS analysis-based Target Rail Profile, Pattern, Grinding Strategy, with the DFCCIL time to time.
- GDMS and an index known as Grind Quality Index (GQI) is displayed during the run. GQI gives an idea about deviation with respect to the target rail profile. GQI value of 100 means that target profile has been achieved (within the specified tolerances). The minimum value of GQI to be achieved should be 80. However, as the DFCCIL 72 Stone RGM has to work on a preventive gradual cycle, it may take up to 2 to 3 grinding cycles to reach this value depending on the initial GQI value of the section O&M Contractor shall finalize the Grinding Strategy to achieve GQI value of 80 or more. Following Instruments are to be used for finalizing Grinding Strategy and measuring GQI by O&M Contractor:
 - i) MINIPROF MINIPROF is an equipment to measure the profile of the railhead to the accuracy of 0.054 mm. This is contact type rail profile measuring system. It is also used to compare the post grind profile to the target profile to assess the appropriateness of the grinding parameters. O & M Contractor has to supply 2 numbers of software compatible with DFCCIL's MINIPROF for comparing the actual measured profile wrt standard profile of DFCCIL Rails used in EDFC and WDFC for DFCCIL internal use for which no extra payment shall be made. The License fee for the same has to be paid by O & M Contractor for entire duration of O & M Contract.
 - ii) **Bar Gauge** This is a handheld instrument used for measuring of profile of the railhead. Four templates are attached to this gauge for 4 target profiles, namely CPC, CPF, HRS and HRM. Deviation of existing profile from target profile is quickly known by putting one of the templates over the railhead and then using taper gauge to measure the gaps.
 - iii) Star Gauge This gauge is in the form of template having five different rail top radii. This instrument is used to make a quick check to compare the actual radius of the rail top, before and after grinding operation.
 - iv) **Digital Inclinometer** This is used to know the angle of grinding stone at a particular point on the rail surface. By simply keeping the instrument at a particular location, the angle will be known in digital form.

v) Surface Roughness Measuring Gauge – Roughness after grinding is high. This gauge measures the roughness of rail. Roughness after grinding should be within acceptable limits (less than 12 micron).

- vi) Rail Hardness The grinding should not cut the head hardened layer from the rail top completely. This will increase wear rate after grinding. This instrument is used to measure hardness before and after grinding.
- **Note:** 2 Numbers of each equipments mentioned at above item No. ii) to vi) are to be supplied to DFCCIL within one month of award of this work for which no extra payment shall be made to O & M Contractor
- **Quality Inspection of Grinding** It is essential to monitor the quality of grinding. A typical test site consists of stretch of track covering three sleeper spacings divided into three parts first for measuring rail profile by MINIPROF (Marked as MP), second for taking surface photographs and the third for doing Dye Penetration Test and taking DPT photographs. Inter-distance of the test sites will depend on the variation in the features in that section. Some of the Quality Checks of Rail Grinding are as under:
 - i) Monitoring Rail Surface Finish The condition of the rail top after grinding gives a lot of clues about the quality of grinding. A good finish should have regular grind marks of the grinding stones (these are known as facets) with silver finish. A bad finish will have irregular marks or skipped grinding at regular interval or blue colour on rails at certain locations (known as blueing defect) or irregular facet width etc.
 - ii) Surface roughness after grinding- The rail surface should not become too rough after the grinding. The surface roughness level should not go beyond 12 microns after grinding.
 - iii) **Crown radius** Crown radius of the railhead is measured before and after grinding by star gauge. The crown radius should be closer to 250 mm at the center of railhead after grinding.
- 17 **Test Site Management**: During the O&M period, 18 Nos of Test Sites on EDFC (for 90 UTS rails) and 18 Nos on WDFC (for 1080 HH E1 rails) are already developed by O&M Service provider (earlier awarded short term O&M Contract) and shown, schematically, below, may be made use of by the Contractor. Out of the 18 test sites already established on WDFC, 12 test sites will be reestablished as a one-time exercise





17.3 As part of the O&M Services provided by the O & M Contractor, 18 test sites on EDFC and 18 on WDFC would be actively managed by them. This would include at least 6 mild curves, 6 sharp curves and 6 tangents locations on EDFC and WDFC each. Breakup of tr4st sites on each DFC corridors are as under:

- -3 mild curves at same location on UP Line and DOWN Line
- -3 sharp curves at same location on UP Line and DOWN Line
- -3 tangents at same location on UP Line and DOWN Line
- 17.4 These locations should be maintained as permanent test sites and should be remarked periodically by proper paint by O & M Contractor. As part of requirement of the Test site management, O & M Contractor shall record the following for each test site:
 - -Pre-Grinding Miniprof, surface photograph and dye penetration test, within 10 days before grinding
 - -Post Grinding Miniprof, surface photograph and dye penetration test, within 10 days after grinding.
 - -Maintaining proper record of the same.
 - -Sharing run on run analysis for all 18 test site locations.
 - -Review of grinding pattern changes needed, if any post analysis.
 - -Review for further changes in profile and grinding cycle.
- 17.5 As part of this exercise, any existing templates would also be reviewed and modified as needed.
- 17.6 Normally 6 measuring points are established at three locations at interval of of 80 100 m distance at each test site. In addition of same, at each test site location in 100 m stretch Rail Grinding shall not to be done and permanent 6 measuring point (3 on left and 3 on Right rail) to be marked and Rail wear, DGR and DPT test needs to be measured/done as and when being done in designated test point location before actual rail grind of every cycle all 18 Test sites of EDFC and WDFC.

Rail Life Extension Analysis Services

- 18 **DFCCIL** had to implement rail grinding services (including rail-wheel interface studies) on DFC entire network Tracks. Such rail-wheel studies are a continuous process requiring techno-commercial analysis of existing wheel and rail profiles. As part of this tender, Rail Life Extension Analysis Services are required and thus forms part of the O&M Contract. Rail Life Extension Analysis has to be done by O & M Contractor under the active support, supervision & training provided by OEM (M/s Loram, USA). Rail life extension Analysis has to be done in 4 years period after award of the work to successful bidder. The following items are included as part of this service:
 - (i) Setup virtual test sites to collect new data such as vehicle-track dynamics, wheel-rail interaction, rail wear, rolling contact fatigue risk at the past test sites without requiring extensive additional monitoring
 - (ii) Expand rail life monitoring and calculations across the network without additional tests site and calculate the tangible life extension and economic benefits of DFCCIL improvements
 - (iii) Compare how further innovations to rail management (grind profile, grind frequencies, grind strategies in limited block windows, friction management) could further extend life and provide other benefits such as noise, safety, ride quality, etc.
- 19 O & M Contractor within 30 days of receiving the Commencement notice from the DFCCIL, shall submit a method statement on 'Rail Life Extension Analysis Services' to the DFCCIL with clear description of methodology to be adopted, measurements to be taken, studies to be made, digital analysis after feeding the measurement data in the dedicated Software and project of results, contained in a comprehensive Report with clear recommendation as to the progress achieved and the way forward for the future to seek desired extension, to the extent of 30% over and above stipulated Rail life, of life of Rails in DFCCIL Track. Such

Report shall be prepared & signed by OEM Expert and submitted by O & M Contractor for DFCCIL's scrutiny and approval. O & M Contractor shall, in addition, make a detailed presentation on the subject to ensure the DFCCIL familiarization with this analysis. Such Report shall be scrutinized by the DFCCIL and approved. Such Report shall form the base document to monitor the physical execution of the Rail life extension Analysis.

- After successful completion of such Rail life extension analysis, O & M Contractor shall submit a comprehensive 'Rail Life Extension Analysis Services' Report to the Employer with clear description of methodology adopted, details of measurements taken, studies made, details of digital analysis after feeding the aforesaid measurement data in the dedicated updated Software and results of Rail Life extension Analysis, contained in a dedicated Chapter, with clear certification as to the actual progress achieved, in real time, duly bringing out the extension of Rail life achieved and the way forward for the future to seek desired extension, to the extent of 30% over and above stipulated Rail life, of life of Rails in DFCCIL Track. Such Rail Life Extension Analysis Report shall be prepared, signed By OEM's Experts and submitted by O & M Contractor. Acceptance of the O&M Contractor report shall pave the way for payment to be released to the contractor against the successful execution of 'Rail Life Extension Analysis Services.
- DFCCIL understands that 'Rail Life Extension Analysis Services' is to be provided using OEM's proprietary Loram Virtual Rail (Loram VR) Digital Twin software to create customized rail life extension simulator "virtual test sites" for DFCCIL. OEM's proprietary software patent is also to be attached with the tender. The outputs from each customized rail life extension simulator include:
 - (i) Wear life extension simulations (natural wear due to wheel-rail interaction and artificial wear due to the grinding plan)
 - (ii) Rolling Contact Fatigue (RCF) life extension simulations (RCF initiation risk and crack growth)
 - (iii) Grinding strategy analysis (comparison of different grinding strategies' benefit at the test site or other tangent, mild curve or sharp curves, including evaluation of target rail profile to maximize the rail life)
- 22 **Technical Scope and Approach-** O&M Contractor will provide DFCCIL Rail Life Extension Analysis Services as part of a three-step approach:
 - a) Evaluate and expand past DFCCIL test sites
 - b) Expand life extension monitoring across the network
 - c) Evaluate life extension improvements
- Implementation Planning Once DFCCIL is satisfied with the expected performance of the new rail profile in simulations, O&M Contractor in consultation with M/s Loram, USA has to provide a grinding plan for implementing the new target profiles. OEM will use the Loram VR Economic Module to calculate the cost of implementing the rail profile and compare it to the expected savings.
- 24 **Continuous Improvement** O&M Contractor in consultation with OEM (M/s Loram, USA) will continue to suggest improvements to the profile as necessary based on field feedback, modelling iterations, and changes to DFCCIL/Indian Railway wheels and traffic as provided and highlight when the profile should be re-evaluated.
- 25 Additional Technical Scope & Services by O&M Contractor also includes following items:

- a) **Data Collection** O&M Contractor in consultation with M/s Loram, USA will work with DFCCIL to collect the required data from the chosen test site locations. O&M Contractor's team will work with DFCCIL to collate this data and provide the same in structured manner.
- b) **Setup Physical Test Sites** Based on the data analysis and prioritization of specific locations on track from the Data Analysis to Select High Priority Locations, O & M Contractor in consultation with M/s Loram, USA will work to setup wheel-rail test sites to study to collect initial rail profile, wheel profile, and friction management data.
- c) O&M Contractor's subject matter experts will inspect and measure rails at DFCCIL in various locations and evaluate rail wear and deterioration including:
 - Rail Profile measurements with MiniProf and/or Calipri to evaluate existing rail shape and wear
 - Running Band measurements visually to evaluate wheel-rail interaction.
- d) O&M Contractor's team shall measure wheels in service on DFCCIL rolling stock at various maintenance locations to evaluate tread and flange wear and deterioration:
 - Wheel Profile measurements with MiniProf to evaluate existing wheel maintenance and wheel-rail interaction
 - Wheel Condition measurements visually to evaluate wheel-rail interaction and defect rate.
- e) Field Monitoring O & M Contractor's team & M/s Loram, USA will monitor data on the rail, including contact band behavior and wear data, to ensure the rail is behaving as expected and DFCCIL is receiving the expected benefits. O&M Contractor shall inspect the track after the new profile designs are implemented and collect the same data at the same location and inspect the track at the same locations 3-4 months afterwards.
- In case, DFCCIL goes for 3rd party audit of Rail Life Extension Analysis submitted by Bidder for its adequacy, in that case O & M contractor has to provide all data in the form needed by 3rd Party for checking the adequacy of Rail Life Extension Analysis submitted by Bidder. The cost of arranging data for 3rd part is included in the rate of of schedule F of SOR of this RFP.

Technical Training of 4 weeks at RGM OEM Premises

- O&M Contractor shall arrange 4 weeks Training to 4 personals of DFCCIL in OEM (M/S Loram, USA) premises. The cost of Visa Support Letter, Local Transportation (Hotel to OEM Premises), Training Material and Resources, Site visit and costs related to transport to sites and intercity travels related to training are included in O & M contractor's scope. Cost related to Visa Application Process & Visa Application Fee, Travel from India to USA (i.e. hotel nearest to OEM's premises) and back, Boarding and Lodging, Incidentals (Local Travel, Communication, etc.) are to be borne by DFCCIL.
- The Bidder has to submit the Detailed Training Program of 4 weeks which is to be imparted to 4 DFCCIL personals covering aspects of Rail Life Extension Analysis, Test site management, Operation and maintenance of RGM Formation and RIV along with his offer.

CHAPTER - VI

Special Conditions of Contract

For

Operation and Maintenance of 72 Stone RGM Formation (Front Car, 3 Grinding Cars, One Water Tanker and Camping coach) and RIV

1.1 Objective

The objective of this O & M Contract is the operation and maintenance of DFCCIL's RGM Formation and RIV including 2 POH of RGM Formation and one POH of RIV, supply of consumables, Spare parts and Grinding stone for smooth working of RGM Formation and RIV by the O & M Contractor in the manner and to the standards and within the time stipulated in this RFP. In full recognition of this objective and with full acceptance of the obligations, liabilities and risks which may be involved, the O & M Contractor shall undertake the execution of the O & M Works of RGM Formation and RIV. The O & M work of RGM Formation and RIV shall be executed to the highest standards available using proven good Engineering practices.

This Tender will be governed by instructions to tenderers, General condition of Contract, Special conditions of contract and Prescribed Maintenance Activities of RGM formation in **Chapter-VII** and for RIV as per **Chapter - VIII** of this RFP. If there are varying or conflicting provisions in the documents forming part of the contract, Engineer shall be deciding authority regarding the intentions of the provision and decision of Engineer will be final and binding on the O & M contractor.

1.2 ORDER OF PRECEDENCE

In case of any difference, contradiction, discrepancy, with regard to Conditions of tender/contract, Specifications, Bill of quantities etc., forming part of the tender/contract, the following shall be the order of precedence:

- (a) Contract Agreement
- (b) Letter of Award
- (c) Schedule of Items, Rates & Quantities
- (d) Special Conditions of Contract
- (e) Terms of Reference (TOR) of this RFP
- (f) Technical specification of DFCCIL RGM Formation and RIV
- (g) General Conditions of Contract
- (h) Schedule of Dimension of DFCCIL
- (i) G & S R of DFCCIL
- (j) OEM RGM and RIV Operation manual,
- (k) OEM RGM and RIV Maintenance Manual and other Manuals
- (l) DFC Railroad Manual
- (m) Indian Railway Track Machine Manual

1.3 Scheme of work

Within a period of 15 days from the date of issue of Letter of Acceptance of Tender, the O & M Contractor shall submit the detailed plan for Operation & Maintenance of RGM Formation and

RIV and various documents enumerated in tender papers to the DFCCIL. DFCCIL shall give a prior notice of 15 days to Contractor for mobilization and start of work at site. This scheme of the O & M Contractor shall generally cover the following:

- a) The organization to manage efficient Operation & Maintenance of RGM Formation and RIV.
- b) The documentation control system:
 - i) Basic control system.
 - ii) Records for maintenance
 - iii) Manual for operation & maintenance of machine based on IRTMM manual, DFCCIL's Technical specification of RGM Formation and RIV Maintenance and OEM manual for RGM Formation and RIV Maintenance.

1.4 APPLICABLE TECHNICAL DOCUMENTS

The following manual/documents will be applicable for this work:

- (a) Technical specification RGM Formation and RIV.
- (b) OEM manual for RGM Formation and RIV Maintenance.
- (c) Indian Railway Track Machine Manual as updated on date of opening of tender. An updated copy of above manual/documents is available on Indian Railway web site Indianrailways.gov.in/railway board.
- (d) Schedule of Dimensions (SOD). (An updated copy of above manual/documents is available on Indian Railway web site Indianrailways.gov.in/railway board and DFCCIL SOD).
- (e) DFCCIL's General & Subsidiaries rules (Copy may be collected from DFCCIL), and
- (f) DFCCIL's SHE Manual (An updated copy of the this manual is available on DFCCIL web site).

Note: Changes made in above documents during execution of contract will be communicated to O & M contractor by DFCCIL under clear acknowledgment. Subsequent changes after date of opening of tender including correction slips to above documents will be applicable only when revision of rates, terms and conditions are worked out with mutual consent.

1.5 Obligations of Contractor & DFCCIL are incorporated in tender documents & important obligations on both parties are summarized below:

(a) Contractor's obligations:

- i) Maintain the RGM Formation as per Chapter VII and RIV as per Chapter- VIII of this RFP by providing timely consumables, spares and maintenance staff etc. by his own manpower.
- ii) Ensuring availability of agreed scale of staff for operation (movement, shifting and working) and maintenance of track machines.
- iii) Ensuring availability of RGM Formation and RIV for working 22 days in month (132 days in a half year) except during POH periods, provided that any penalty on the O&M Contractor would only be limited to reasons which can only solely be attributable to the O&M Contractor. No penalty or non-availability would be levied on account of any statutory, Force Majeure, DFCCIL requirements, etc. related matters.
- iv) Offer the RGM Formation and RIV timely to DFCCIL for obtaining traffic block and avail traffic block as granted.
- v) The block timings may be different depending upon the traffic pattern and shall be advised to the supervisor in advance, who will ensure that the machine is offered with due daily maintenance at least 30 minutes before the tentative block time.

- vi) Will arrange proper lighting for night block working, as provided on RGM/RIV. Furthermore, for any RGM / RIV related manpower working on the cess, additional flashlights would be provided to ensure safety while walking on the trac.
- vii) Carry out the O & M of RGM Formation and RIV by his own Machine Experts, Supervisors, Operators, Technicians and Helpers.
- viii) O & M Contractor will try to optimize the utilization of traffic blocks.
- ix) Indemnify the DFCCIL and maintain insurance as per contract.
- x) Provide accommodation and transport facilities to its staff.
- xi) The contractor will ensure validity of competency of staff and for this purpose he will spare the staff in time for refresher courses, Periodical Medical Examination and arrange suitable replacement at par with Indian Railway Track machine operators.
- xii) Contractor will supervise the Grinding of Rails, Rail profile measurement, Maintenance of RGM formation and RIV and other associated activities at its own cost and ensure safety at work site & of RGM Formation and RIV Maintenance and quality of Rail Grinding work.
- xiii) Shall maintain the record and submit periodical progress/information/reports as per contract.
- xiv) Shall make arrangements to expeditiously clear the block section in case of failure/derailment of RGM Formation/RIV by his own means and at his own cost
- xv) During breakdown maintenance, O & M Contractor shall provide:
 - a. All necessary manpower needed to restore the RGM Formation/ RIV for operation.
 - b. All additional manpower and specialists for immediate troubleshoot and repair in the least possible time.
- xvi) Contractor shall ensure that all precautions to be taken while working in Track circuited area is observed as per **Para 279 of IRPWM**.
- xvii) After completion of days/night works contractor shall ensure that all equipment, tools and plants is cleared before leaving the site. No material whatsoever shall be left behind on track.
- xviii) The contractor shall ensure that all his staff wear proper uniform with personal protective equipment including helmets, safety shoes and illuminated jacket etc. while working.
- xix) The contractor shall take all necessary safety measures & precautions and the contractor shall be entirely responsible for the safety & security of his men & materials.
- xx) Contractor shall provide Photo-identity cards to all his staff & supervisors.
- xxi) Shall Adhere to statutory laws.
- xxii) To deploy competent staff fulfilling necessary medical requirements. Medical examination at nominated medical hospital/Health centre and charges of medical examination will be borne and paid by contractor.
- xxiii) While working on double/multiple line sections and part of RGM Formation/RIV shall not infringe the adjoining track, and it must be possible to permit trains at full speed on that track. If considered unavoidable for working, any infringement of the adjoining track shall be allowed only after obtaining the traffic block of that track.
- xxiv) The cost of all Manpower and Service Engineer (including of OEMs) required for all schedules of maintenance prescribed in OEM Maintenance Manuals are included in agreed rates of item No. 1, 2, 3, 4 and 5 of Schedule A of SOR of this RFP.
- xxv) The safe upkeep, storage and record updation of the spares and tools as supplied by the bidder shall, be the responsibility of the bidder himself.
- xxvi) In case of repair of Proprietary software/related hardware of the electronic components of the RGM Formation/RIV, Contractor has to transport the part to their nearest workshop at his own cost

(b) **DFCCIL's obligations:**

- i) To ensure timely availability of work site to O & M Contractor.
- ii) To ensure availability of correct and reliable track survey data in machine compatible format available to the RGM/RIV before start of Grinding/Rail profile recording operation.
- iii) Removing all axle counters/HABDs before Griding work and refixing the same after Grinding activity.
- iv) Arrange HSD oil and water for RGM & RIV and electricity supply at stabling siding
- v) Carry out pre and post block activities.
- vi) Provide look out men for safety of track and workers during block as per conditions of contract.
- vii) To communicate changes made in IR/DFCCIL manuals/codes i.e. IRPWM, G&SR, IRTMM etc. to contractors.
- viii) DFCCIL will provide the required training of contractor's staff regarding track protection, G & SR and issue valid competency certificate on payment basis.
- ix) DFCCIL will provide and impose Speed Restrictions required for the work (if required).
- x) DFCCIL will erect caution indicator boards, speed indicator boards and termination boards at appropriate locations as per prevalent speed restriction.
- xi) DFCCIL will ensure timely availability of competent DFCCIL staff to submit requisition for traffic block, obtain and clear traffic block after completion of work. Based upon the track parameter, suitable speed at which traffic shall be opened will be mentioned by the competent DFCCIL staff in block clearance memo.
- xii) DFCCIL will depute sufficient support staff (Engineering, S&T etc.) as per requirement during working of RGM Formation and RIV including look out/safety men for ensuring safety of track, train and workers at its own cost.
- xiii) DFCCIL will ensure timely shifting of track machines by providing path and Competent DFCCIL(LP/ALP), wherever required.
- xiv) DFCCIL will provide suitable sidings/track for stabling of track machines, nearest possible to work site.
- xv) DFCCIL will provide sufficient open space in the nearest track machine depot/ISMD/IMD for storage of spares/consumables. DFCCIL shall provide, free of charge, adequate space for lubricants and spares at central depot location (if required) and office for manpower at depots, with free electricity, where RGM Formation and RIV is placed
- xvi) After work the block section should be cleared at the earliest and if contractor is not able to clear the block section in case of failure/derailment of RGM Formation/RIV. In such cases requiring DFCCIL's assistance of loco/ART/MFD van etc, the penalty as per contract will also be levied by DFCCIL on O & M contractor.
- xvii) DFCCIL will examine the bills submitted by the contractor and will make timely payment as per contract conditions.
- xviii) DFCC will provide free access to Contractor's operation and maintenance team members/vehicles/tools etc. The contractor will notify DFCCIL about the arrival of tools/heavy spares carrying vehicles for maintenance of the RGM Formation/RIV well in advance, if it is expected after normal works hours.
- xix) Wherever required, all necessary permissions has to be ensured by DFCCIL.
- xx) DFCCIL shall intimate about the working hour well in advance preferably one day in advance. Before the end of each day's work the contractor shall be advised in writing by DFCCIL of the commencement time and duration of the following day's occupation(s).
- xxi) O & M Contractor shall be allowed sufficient time on- track to calibrate and adjust the machine as part of the preventive maintenance of the machine. This time will be outside the scheduled occupation periods and will not be included in any of the Contract Measurements.

- xxii) The live electric/signaling/telecom cables will be removed by concerned DFCCIL staff at their cost.
- xxiii) Any item which is not specifically included in the scope of O & M contractor will be carried out by DFCCIL either departmentally or through other agencies.
- xxiv) Adhere to all its obligations as per O & M Contract conditions.

1.6 GENERAL REQUIREMENTS

- 1.6.1 The O & M Contractor has to execute the work of Operation & Maintenance of 72 Stone RGM Formation and RIV Machines which will be deployed over pan DFC network as per the instructions of DFCCIL. During the execution of the contract HSD and water are to be provided by DFCCIL free of cost to the O & M Contractor at Stabling siding. The cost of all consumables, manpower and other logistics required for operation and maintenance of machines are included on contract price excluding cost of HSD oil, water and electricity in RGM stabling siding.
- 1.6.2 The O & M Contractor is responsible for ensuring the availability of machines for 06 hour every day for grinding operation (which might be increased by up to 2 to 3 hours depending on traffic condition over DFCCIL during operation). During maintenance shift, the stipulated maintenance of RGM Formation/RIV stipulated preventive checks and scheduled maintenance of RGM Formation/RIV including all assemblies (like engines, generators, electrical control system etc.) or sub-assemblies (various water & HSD oil pumps, sensors etc.) as specified by OEM in Various OEM/Machine Manufacturer manuals to ensure its upkeep shall be carried out.
- 1.6.3 The timings of the shift are not fixed and will change depending upon corridor block timings. However overall shift time shall be 8 Hrs in a day. Roster of shift shall be issued by the respective field unit on weekly basis.
- 1.6.4 The machines will work on DFC tracks with the trains running on adjacent IR/DFC tracks. The O & M Contractor must ensure the care/safety/ health hazards of the labours engaged by him/her during the course of the execution of work. Necessary safety equipment shall be provided by the O & M Contractor for the staff engaged by the him. No extra amount is payable towards this.
- 1.6.5 O & M Contractor shall provide adequate and appropriate security at their disposal to protect and preserve the RGM Formation/RIV Machines from anti- social elements especially in insurgency defined areas, where the machine may be required to operate from time to time for which O & M Contractor shall arrange Insurance for RIV/RGM formation and the cost of same will be reimbursed by DFCCIL on production of Premium payment receipts on time to time.
- 1.6.6 The manpower employed by the O & M contractor shall have no right, whatsoever, for any appointment in the DFCCIL in temporary/adhoc/ daily wages/ regular capacity on the basis of their work in the DFCCIL territory.
- 1.6.7 Authorized DFCCIL's representative having route learning of the particular section where the RGM formation/RIV are working will be present for supervising the operation and to monitor the movement of the RGM/RIV from one section to another. RGM/RIV shall not be moved without authorized DFCCIL's representative. The same would be provided free of charge.
- 1.6.8 All tools and plants, drawings, manuals which are supplied by the DFCCIL to O & M Contractor free of cost for use along with the RGM Formation/RIV shall be handed over back to DFCCIL in working condition after expiry of the contract period to DFCCIL authorized personnel.
- 1.6.9 When the RGM Formation and/or RIV is on transit from one station to another, there will be no routine maintenance, and RGM Formation/RIV shall be made available for movement in two shifts of 10 hours each (2x10 hours) in 24 hours' time frame till it reaches destination. The staff of operation and maintenance should be so redistributed to perform transit work with sufficient staff.

- 1.6.10 Special cleaning of RGM Formation and RIV should be carried out once a month with detergents and other cleaning agents to remove all soot, dust and to keep the entire RGM Formation and RIV in good appearance. The machine will be stabled at a place in OHE/non-OHE siding available so as to ensure proper cleaning. Patch painting at rusted locations should be done after cleaning with matching color. No extra amount is separately payable towards this.
- 1.6.11 Complete and up to date records for daily/ weekly/monthly and higher maintenance schedules will be maintained by the contractor and counter signed by DFCCIL officials. The daily/Weekly/Monthly/ Half yearly progress reports (in mutually agreed formats) shall be mailed to the nominated DFCCIL official.
- 1.6.12 Each party agrees to indemnify, defend, and hold harmless the other party from all liability, cost or expense (including any court costs) caused by the joint and /or concurring negligence of the parties, arising on account of injury to or death of any employee, agent or representative of the indemnifying party during the performance of the Services or who shall, if not performing Services, be present as a bystander or otherwise on the property of either party, provided always, however, that if the injury or death to an employee of an indemnifying party is caused solely by the negligence of the other party then this indemnity and hold harmless provision shall be null and void, and the party who solely cause the injury or death shall bear the cost or expense. Notwithstanding any provision herein to the contrary, O & M Contractor's total cumulative liability for any or all claims arising out of this indemnification shall not exceed the 3% of the total value of Schedule-A of SOR.
- 1.6.13 The O & M contractor shall ensure compliance with all relevant Central/State laws and rules as applicable such as Tax Laws, Labour Laws and Insurance Laws etc with regard to this O & M contract and shall be solely responsible for the same and shall keep the DFCCIL fully indemnified against the liability of any Taxes, interest, penalty etc if any arising any connection with the contract may be incorporated. If any accident occurs with any worker of the contractor while doing his job, the DFCCIL will not be liable in any way and the sole responsibility for payment of compensation, etc. will be of the contractor.

1.7 MAINTENANCE OF RGM Formation and RIV

- 1.7.1 The prescribed activities to be done during various maintenance schedules of RGM Formation are detailed in Chapter-VII of this RFP.
- 1.7.2 The prescribed activities to be done during various maintenance schedules of RIV are detailed in Chapter-VIII of this RFP.
- 1.7.3 The maintenance role encompasses undertaking all schedule/periodic/ routine of RGM Formation/RIV including all assemblies (like engines, generators, Hydraulic system, Pneumatic system and electrical control system etc.) or sub-assemblies (various water & HSD oil pumps, sensors etc) as specified by O & M Contractor/OEM updated from time to time, either by day or night.
- 1.7.4 OEM recommended consumables and spares will be provided by O & M Contractor RGM Formation/RIV and released spares/material shall be returned to DFCCIL stores. The transport of consumables, spares/released spares will be done by O & M Contractor without any additional cost.
- 1.7.5 Contractor will be responsible for upkeep of RGM Formation and RIV, along with preventive checks and schedule maintenance of RGM Formation/RIV as whole.
- 1.7.6 Daily maintenance activities shall be strictly followed before/after of Machine working. Other prescribed schedule maintenance are to be performed at appropriate time intervals in the balance

time available after offering the RGM Formation/RIV for Grinding activities.

- 1.7.7 Routine maintenance of undercarriage systems shall also be undertaken by the contractor. All Workshop facilities to be arranged by contractor including repair of under frame system and for wheel turning. In case this contractor request DFFCIL to arrange the same from Indian Railway, then if possible for DFCCIL it will be arranged by DFCCIL on the cost of O & M contractor. The Pit facility will be provided by DFCCIL free of cost at New Dadri or any other station of DFC.
- 1.7.8 The O & M Contractor should maintain inventory of consumables, critical spares RGM Formation and RIV on Machine itself or at nearest place in order to minimize the duration of breakdowns and delays in the repair and operation. He should keep stand by critical spare parts which requires long procurement period.
- 1.7.9 O & M Contractor shall be responsible towards mounting and dismounting of unserviceable/ Serviceable/New components/parts/materials on the RGM Formation and RIV. O & M Contractor shall be responsible for providing serviceable components/parts/materials on the RGM Formation and RIV.
- 1.7.10 The O & M Contractor shall prepare and send to DFCCIL the days scheduled for planned/scheduled maintenance of the track machines during the month at least 15 days in advance of the beginning of the month.
- 1.7.11 All the fixtures on the Camping coach shall be maintained in good condition. All electrical, plumbing, furniture, electronics, computers/laptop, TV & DVD, Genset, washing machine, freezer, geysers, microwave/oven, communication and all other fixtures available in camping coach to be maintained at all times in good fettle and at the end of the contract period.

1.8 MAINTENANCE OF RECORDS

- 1.8.1 Maintenance records during Schedule and breakdown maintenance shall be maintained each rolling stock wise of RGM Formation/RIV in hard copy as well as soft copy in mutually agreed formats. These record are to be maintained in a register form and are to be kept in the machine itself. These records shall be provided to DFCCIL by the crew on the machine in a timely manner.
- 1.8.2 The contractor shall maintain the history book, logbook and all other documents prescribed for RGM formation and RIV as per IRTMM and any other document that may be prescribed further in due course of time.
- 1.8.3 The contractor shall compile and submit a standard daily report accurately depicting operational timings, delays, reasons for 'NO work', machine availability, progress achieved by each track machine and maintenance input given to RGM Formation and RIV machine. DFCCIL representatives will also sign this report on a daily basis. In case of difference of opinion, he will write his observations on the daily report submitted by the O & M contractor for his signature.
- 1.8.4 The signed joint daily report shall be the basis for invoicing and shall constitute DFCCIL's acceptance of day-to-day work apart from the completion of scheduled maintenance in timely manner. Daily progress and history shall be mailed to the nominated DFCCIL official/s along with weekly and monthly progress reports in the prescribed format.

1.9 SPARE PARTS

- 1.9.1 The cost of consumables, spare parts and Grinding stones will be paid by DFCCIL through schedule B, C and D respectively of SOR items of this RFP.
- 1.9.2 During the currency of the contract, if certificate from DFCCIL (in any) required by Contractor

for importing spare parts/material/testers/ equipment for Customs clearance will be provided by DFCCIL unit in required format for speedy clearance on arrival at port.

- 1.9.3 O & M contractor must maintain adequate liaison with the various OEMs of various parts of RGM Formation and RIV to ensure a quick turnround of the strategic reserves.
- 1.9.4 **Recoupment of Inventory** During the currency of Contract period, if inventory stock level fall below the defined minimum inventory level, the O & M contractor has to take action for automatic replenishment of stock level to recommended inventory level. Payments of the same shall be released by DFCCIL on receiving the same in DFCCIL warehouse on a monthly basis.
- 1.9.5 During various maintenance schedules various Consumables (filters, oil, lubricants, Coolants, Hydraulic fluids) are to be replaced at regular interval and also to be recouped on need basis. These consumables are also to be procured timely to maintain minimum inventory level, depending on procurement lead time and transported to DFCCIL warehouse for proper inventory management. Payments of the same shall be released by DFCCIL on receiving the same in DFCCIL warehouse on monthly basis.
- 1.9.6 During the currency of the contract O & M contractor will draw the various items required from DFCCIL inventory depot, transport it and install that part on the RGM Formation/RIV at his own cost.
- 1.9.7 The handling of required spare parts/consumables in DFCCIL depot and loading the same in trucks for transportation to RGM/RIV site has to be arranged by O & M Contractor at his own cost.
- 1.9.8 Before storing an engine, it should be thoroughly inspected, cleaned and preserved. It should be drained of any fluids, including fuel, oil and hydraulic fluids. The oil system should be filled with preservative oil to protect internal components from corrosion. Likewise other Machine units are also to be preserved.
- 1.9.9 If repairing of some parts/units of RGM Formation Plus RIV is needed as per advice of OEM's experts and the rate of those items are not covered in Form 3C of Bid, then rate of same will be decided mutually by DFCCIL and O & M Contractor as and when needed. The payment of Engine Overhauling by Engine's OEM will be done on the basis of actual Overhauling invoice raised by Engine OEMs.
- 1.9.10 Initial batch of spares of RGM Formation and RIV as per prescribed inventory level would be supplied within 2 months (parts easily available in India) and within 6 months (parts to be imported) of issue of LOA. All such spares shall be kept in the custody of DFCCIL. DFCCIL shall issue such spares to the machines as per the O & M requirement RGM Formation/RIV.
- 1.9.11 One 4-wheeler vehicle in good condition with proper road permit and insurance for transporting men and material required for day to day working will be provided by O & M Contractor without any extra payment for transporting his Manpower and various materials and spare parts of RGM formation and RIV from his /DFCCIL stores.
- 1.9.12 The O & M Contractor shall submit the details of machine spares/ consumables required for proper upkeep of Machines. The spares supplied by the O & M Contractor for operations and maintenance shall be kept in DFCCIL stores and shall be issued to the Machines as per the machine requirement.

1.10 Operation of track machines:

- 1.10.1 The RGM Formation/RIV should be ready to work sufficiently in advance before the proposed normal block timing as decided in weekly planning. For minimizing the travel time of RGM Formation/RIV, the shunting operations should be done in advance and RGM Formation/RIV should be kept ready near the starter signal towards the block section where the RGM Formation/RIV will work. This shall be planned by the DFCCIL supervisor. The contractor is required to factor this in the daily required working hours of the staff.
- 1.10.2 To move the RGM Formation/RIV from stabling siding to the work site and back, the DFCCIL

shall provide the O & M Contractor with a staff, who is aware of the route to provide the directions for movement/travel. However, the O & M contractor will provide sufficient operators to move the machines in shift and will not refuse the movement of machine.

- 1.10.3 Before the start of new site/ shifting of RGM Formation and RIV base stabling siding, a program will be prepared by the O & M contractor in consultation with sectional APM/DPM of DFCCIL and got signed by both the O & M Contractor and DFCCIL which will include the following:
 - Location of the work
 - Location and length of stabling siding
 - Proposed schedule of blocks
 - Site specific precautions
 - Any other item as considered necessary for the work
- 1.10.4 Stabling track for RGM Formation/RIV should be provided with sufficient external lights so as to make them capable of working at night. The contractor shall make his own arrangements for extra lighting at site for working in night.
- 1.10.5 During block all essential safety and other DFCCIL working rules shall be followed by the contractor as well as DFCCIL staff.
- 1.10.6 O & M Contractor shall furnish adequate VHF sets for crew communication for safe operation of RGM/RIV, this should include at least 8 hands free devices
- 1.10.7 In case of failure of RGM Formation/RIV, the Contractor shall promptly inform the DFCCIL. Information should be provided on paper or electronically in a format, which shall be specified by the DFCCIL. The format may be changed from time to time, as required by DFCCIL.
- 1.10.8 If any RGM Formation/RIV breaks down during block and require DFCCIL/Railway's loco/haulage arrangement, in addition to penalty for block bursting, a penalty of Rs. 2,00,000/-per case will also be charged to contractor and will be adjusted from his running bills. Similarly, if any Rolling stock of RGM Formation/RIV is/are derailed and required assistance of Railway crane/ART/MFD van for re-railing, in addition to penalty for block bursting, a penalty of Rs. 4,00,000/- per case for crane and Rs. 1,00,000/- for MFD van will also be charged to the O & M contractor and will be adjusted from his running bills. These rates are as on tender opening date. For every year on the anniversary of LOA the above penalty rates shall be increased by 3% compound.

1.11 Traffic block, speed restrictions

The O & M contractor will clear the traffic block on time. Block busting on account of O & M contractors will attract following penalties per instance:

00-15 minute: NIL

15-30 minutes: Rs. 10,000/- 30-60 minutes: Rs. 20,000/-

> 60 minutes: Rs. 50,000/- per hour or part of hour

The above rates are as on tender opening date. For every year on the anniversary of LOA the above penalty rates shall be increased by 3% compounded.

1.12 Progress of work is likely to be affected due to various reasons, i.e. technical requirement of work, natural reasons, statutory reasons, DFCCIL account, O & M contractor account etc. Some of the reasons are indicated below (list is only indicative and not exhaustive):

Spl Note: If bidder had made RGM Formation /RIV available for a more than of 132 days in any half yearly cycle (starting from date of commencement of O & M) then he can claim adjustment of same only next half yearly cycle as detailed in clause No. 1.13 of SCC. There will be no credit carry over of excess available Machine days in further Half yearly cycles. However, if Selected Bidder has any total cumulative credit same will be adjusted when calculating any default on account of excess days taken in execution of POH than that prescribed in item No.11 of table of clause 1.12.

1.13 The contractor will offer RGM Formation and/or RIV for work well before traffic block starts. If the RGM Formation/RIV is/are not able to work on account of any reason, it will be recorded jointly by contractor's representative and authorized DFCCIL staff. The progress will be monitored on a Half yearly basis. The RGM Formation/RIV will be considered as available if days are lost on account of natural reasons (i.e like heavy rains etc), statutory reasons, force majeure conditions, derailment (on account of DFCCIL) and other DFCCIL accounts. In every month, 22 days are estimated to be working day (including Sundays). The balance days are meant for maintenance functions during which time all maintenance activities are to be completed by the tenderer. No penalty will be levied on the contractor for loss of working days on account of DFCCIL, technical requirement, natural reasons, statutory reasons and Force Majeure conditions. If RGM Formation /RIV is/are not available for a minimum of 132 days in 6 months (Month will start from date of actual commencement of O & M work) on O & M contractor account, the payment of item No. 1/2 of Schedule A of SOR will be reduced proportionally and the penalty certificate will be rendered (as per enclosed Annexure-V). For example, if machine is available for only 130 days, the reduced payment will be = (130/132) X the monthly payment shown in SOR item No. ½ of Schedule A of SOR (for calculation of penalty amount 90% cost of Item No.1/2 will be considered for RGM Formation O & M and 10% for RIV O & M). In case in contactor has made availability of RGM Formation/for working for more than 132 days in subsequent half year, then recovery already deducted in previous 6 months will be returned back for no of days in excess of 132 days. This adjustment will be made on a half yearly basis. For the purpose of adjustment of penalty, 80% O & M cost vide item No.1 of item No.2 of Schedule A of SOR is assumed for RGM formation and 20% for RIV.

1.14 Requirement of Track machine staff

The contractor will provide competent staff for operation and maintenance of RGM Formation/RIV.

1.14.1 Contractor operators, Technicians and helpers shall be of sound physical and mental health

and shall not be more than 65 years of age.

- 1.14.2 For overall supervision, control and management of RGM Formation and/or RIV and work, O & M contractors shall deploy one qualified graduate engineer having Degree in Civil/Mechanical/Electrical/Industrial engineering along with overall working experience of 8 years. If contractor is not able to initially deploy the qualified supervisor as above, or provide a replacement within 15 days, a penalty of Rs. 2,00,000/- per month (for part of month- on prorata basis) per supervisor duly updated for PVC applicable for item No. 1 or 2 of Schedule A of SOR or part thereof will be imposed. Dy.CPM/DFCCIL is also empowered to stop the work with associated penalties under a situation of shortage of qualified track supervisor/s.
- 1.14.3 The O & M Contractor has to provide sufficient number of skilled/semi-skilled staff required for RGM Formation (Minimum 12 staff including 3 supervisors/operators at a time required, for operation and maintenance of RGM) and for RIV (Minimum 4 staff at a time including 1 supervisor).
- 1.14.4 Out of the 3 Supervisors on RGM Formation at least one should be Graduate Engineer in Civil/Mechanical/Electrical/Industrial Engineering having overall working experience of minimum 8 years and other 2 supervisor cum operators should be at least Diploma in Mechanical/Production/Industrial/ Automobile/Electrical/Electronics/Instrumentation Engg as required in item No. 1.14.2, above. Other 2 supervisors. However, if operator is having more than 10 years of working experience in Indian Railway as JE/SSE/TMC, the above educational qualification will be exempted, and such operators will be deemed to have requisite educational qualification.
- 1.14.5 The Supervisor on RIV should be a Graduate Engineer in Civil/Mechanical/Electrical/Industrial Engineering having overall working experience of minimum 8 years.
- 1.14.6 Technicians should be minimum ITI in any trade. However, if Technician is having more than 10 years of working experience in Indian Railway as Technician, the above educational qualification will be exempted, and such operators will be deemed to have requisite educational qualification.
- 1.14.7 Contractor's helpers should have minimum educational qualification of metric (10th pass).
- 1.14.8 All RGM Formation and RIV operators/supervisors shall be certified by the OEM and must have with valid competency certificate in train operation (G & S R) issued by HHI/Noida and medically fit in A-3 Category at all times during the currency of the contract. In case the initial/refresher course to be done for G & SR from HHI/Noida during the currency of this contract, the same shall be got done for the operators by the contractor at contractor cost. DFCCIL shall facilitate expediting the process. All the operators shall have valid PME certificate issued by Authorized Docters of DFCCIL and all the Cost for medical examination connected with PME, shall be payable by the O & M Contractor.
- 1.14.9 Upto 1st Anniversary of LOA it is desirable that contractor's Technicians and Helpers shall be fit in A-3 medical category but after 1st Anniversary of LOA it is must that contractor's Technicians and Helpers shall be fit in A-3 medical category during the currency of the contract. The classification of A-3 will be as per rules of Indian Railways. Contractor's staff will be required to undertake Periodical Medical Examination (PME) at designated hospitals of DFCCIL as per provisions of Indian Railway Track Machine Manual and G&SR
- 1.14.10 If staff is less than the agreed scale of staff, penalty as under will be imposed

Operator - Rs. 5000/per day Technician - Rs. 3000/per day Helper - 2000/per day

With seal

Above penalty duly updated for PVC applicable for Item No.1 or 2 of Schedule A of SOR but this provision will not be applicable during Occasional shortage (two instances in a year, with each instance lasting not more than 7 days) of staff, provided overall strength of machine operator & technician remain more than 70% of agreed strength in respective category.

1.14.11 The contractor should factor in the requirement of working hours, occasional extended working hours, workload and required progress, leave, weekly off, sickness of staff, labour laws, holidays, training, refresher courses, periodical medical examination, maintenance requirement of RGM Formation and /RIV etc. while working out staff cost. Contractor will maintain the agreed scale of RGM Formation/RIV staff in each category during execution of work. O & M Contractor is advised to deploy multi-skilled operators capable and competent to operate and maintain RGM Formation and RIV and allied equipment's.

1.15 Competency and Training of Contractor's Operators, Technicians and Helpers:

- 1.15.1 Before deputing its staff for movement/operation/working of track machines, Contractor shall impart the necessary training to its operators and obtain competency certificate from DFCCIL. Before issuing Competency Certificates, DFCCIL will check the knowledge of the contractor's operating staff and only after satisfying himself, shall issue the competency certificate. OEM's shall impart necessary training. DFCCIL G & SR training will be provided by DFCCIL. However, Boarding, lodging, transportation to training premises/site will be borne by contractor. In case, contractor imparts technical training at OEM's premises, the entire cost of such training shall be borne by the contractor.
- 1.15.2 Before deputing its staff for movement/operation/working of track machines, Contractor shall impart the necessary training to its Technicians.
- 1.15.3 The track machine staff deployed by the contractor will fulfill the required age, educational, training and medical criteria as mentioned above. Only those contractors' operators having valid competence certificate issued by DFCCIL will be authorized to operate and work the track machines. Before issue of competency certificate by DFCCIL, the track machine staff will fulfill all the criteria regarding age, educational qualification, training (technical & Safety) and medical fitness.
- 1.15.4 If actual working performance of any track machine staff of contractor is found not satisfactory or staff reports for duty in intoxicated state or indulged in indiscipline or continuous disregard of DFCCIL instruction or creating unsafe conditions towards working/operating of track machines/running of trains, concerned Dy.CPM/DFCCIL will be authorized to immediately demobilize the defaulting staff. Dy.CPM/DFCCIL will give notice to this effect to contractor and contractor will demobilize the defaulting staff as directed (immediately or within given time period). The contractor will also provide replacement for which a grace period of one month from the date of serving the notice to contractor will be provided. The resulting shortage of staff including penalty will be dealt with as detailed in subsequent sub-paras.
- 1.16 The RGM Formation /RIV will work on DFCCIL with the trains running on adjacent tracks. The contractor must ensure the care /safety/health hazards of the labors engaged by him/her during the course of the execution of work. Necessary safety staff/look out men/hand signal men/hooter men etc will be provided by the DFCCIL. O & M Contractor should organize regular safety camps/safety drills, including fire safety drills, at least once in a month and maintain necessary record. DFCCIL supervisors and officers may also be invited to counsel the staff with regard to safety of track, train and Workmen.
- 1.17 DFCCIL shall provide route learning to contractor's track machine operators in similar manner as applicable to DFCCIL track machine operators. No charge will be levied by DFCCIL from the contractor. For movement from DFCCIL to IR and back to DFCCIL from one work site to new work site and

to/from IOH, assistance of ALP/LP is provided by DFCCIL without any extra cost.

- 1.18 The DFCCIL shall depute an authorized representative for the supervision of the site where the work is to be carried out by the track machine. He will also offer the machine to section control for movement and /or working. He will also submit the demand of traffic block to section control, coordinate with traffic control for timely and adequate traffic block, will accept traffic block and will clear the traffic block. No payment will be charged by DFCCIL for such supervisor. Supervisors of electrical, S&T and traffic department will also be deputed by DFCCIL at its own cost wherever required.
- 1.19 **Siding** For stabling and repair/maintenance of RGM formation/RIV track will be provided by DFCCIL free of charge. The arrangements for security of RGM formation/RIV shall be made by the Contractor at his own expense. Water & electricity supply will be provided by DFC free of cost.

1.20 Accommodation of staff:

- 1.20.1 The O & M Contractor can utilize the accommodation facilities available in RGM Formation and RIV free of cost. O & M Contractor shall maintain and keep the camp coaches track worthy as per Railway rules.
- 1.20.2 If additional accommodation facility is needed for accommodating Manpower deployed by O & M contractor. The same has to be arranged by him at his own cost.. The Contractor shall arrange the timely transportation of his employees from their places of accommodation to the track machine stabling siding and back at his own cost

1.21 Compensation in case of Short closure of contract on DFCCIL Account

In case, DFCCIL doesn't want to continue the contract due to no scope, due to shortage of funds, or due to other reasons not attributable to contractor (except Force Majeure conditions), the contract may be short closed by giving notice of one month to the contractor. In case, on account claims of contractor are not cleared within 180 days from receipt of claims, contractor will have the option for short closing the contract at the expiry of 180-day period, by giving one month notice to DFCCIL to this effect. Till 30 days from giving such notice of short closure, the contractor will be bound to execute the contract at agreed rates, terms and contract. In case of short closure of contract by DFCCIL or by contractor in above circumstance, contractor will be entitled for following compensation after handing over RGM Formation and RIV to DFCCIL:

- a) All O & M works 'done as per contract agreement but not paid' will be paid.
- b) Performance Guarantee and Security Deposit available with DFCCIL will be returned.
- c) The cost of spares **purchased** by Contractor for maintenance of RGM Formation and RIV on production of actual purchase bills and the Spares will become property of DFCCIL.
- d) Rs. 1,00,000/- for demobilization of human resources.

1.22 Termination/short closure on other than DFCCIL account

- 1.22.1 In case of termination of O & M contract on Contractor Account no compensation, payments will be made, except payments for works already done conforming to contract agreement. In case of termination on contractor account, Security deposit (SD) and Performance Guarantee (PG) will also be forfeited in terms of contract agreement.
- 1.22.2 In case of persistent Force-Majeure conditions, contract may be short closed with the consent of both parties and without financial liabilities on either side. In such cases, no compensation payments will be made, due payments for works already done conforming to the contract agreement will be cleared and available SD & PG will be released.

1.22.3 In case of termination on Contractor Account/short closure in case of persistent Force-Majeure conditions, the Contractor will remove all his establishment, materials, offices from DFCCIL premises, within 30 days, after which Penalty @ Rs.10000/per day/ location will be levied. In case the premises are not vacated within 90 days DFCCIL shall have the right to take custody of all properties and equipment and dispose it as it deems fit.

1.23 Infringement of patents

The O & M Contractor is forbidden to use any patents or registered drawings, process or pattern in fulfilling his contract without the previous consent in writing of the owner of such patent, drawing, pattern or trademark, except where these are specified by the DFCCIL. Royalties where payable for the use of such patented processes, registered drawings of patterns shall be borne exclusively by the Contractor. The O & M Contractor shall advise the DFCCIL of any proprietary right that may exist on such processed drawings or patterns which he may use of his own accord.

1.24 Safety Measures

- 1.24.1 The O & M contractor shall take all precautionary measures in order to ensure the protection of his own personnel moving around or working in the DFCCIL premises, but shall then conform to the rules and regulations of the DFCCIL if and when, in the course of the work there is likely to be any danger to persons in the employment of the contractor due to running traffic while working in the DFCCIL siding and premises (i.e. all situations except during the actual working under block), the contractor shall provide flagman or look out men for protection of such persons. The DFCCIL shall remain indemnified by the contractor in the event of any accident occurring in the normal course of work, arising out of the failure of contractor or his men to exercise reasonable precaution at all places of work. All the works under the contract shall be carried out under the supervision of competent DFCCIL supervisor/staff. The format of the Competency certificate of Safety provisions is enclose as **Annexure-VI**.
- 1.24.2 The contractor shall abide by all DFCCIL regulations in force for the time being and ensure that the same are followed by his representatives or subcontractors or workmen. He shall give due notice to his employees and workers about provision of this para.
- 1.24.3 Detailed safety measures to be adhered are mentioned in the **Annexure-IV**.
- 1.24.4 It may also be noted that works must be carried out most carefully without any infringement of the Indian Railway Act or the General and Subsidiary Rules in force on the Railway/DFCCIL, in such a way that they do not hinder Railway/DFCCIL operation or affect the proper functioning of or damage any Railway/DFCCIL equipment, structure or rolling stock except as agreed to by the employer.

1.25 Change in law

- 1.25.1 "The contract price shall be adjusted to take account of any increase and decrease in cost after the bid submission date resulting from:
 - a. A change in the law of the Government of India (including the introduction of new laws and the repeal or modification of existing laws): or
 - b. In the Judicial or official government interpretation of such laws, or
 - c. The commencement of any Indian law which has not entered into effect until the bid submission date; or
 - d. Any change in the rates of any of the taxes or introduction of new taxes, duties, levies, cess etc. on supply of materials and services that have a direct effect on the works.

1.25.2 Further if as a result of change in law as stated in clause No. 1.25.1 above, interpretation, or rates of taxes, the contractor benefits from any reduction in the cost for the execution of this contract, save and except as expressly provided for this sub-clause or in accordance with the provisions of this contract, the contractor shall, within 28 days from the date he becomes reasonably aware of such reduction in the cost, notify the employer of such reduction in cost."

1.26 Expenses during shifting of machine

1.26.1 In case contractor is shifting RGM formation/RIV for POH, all transit expenses are to be borne by DFCCIL including cost of HSD. The time taken for shifting of RGM Formation/RIV POH on DFCCIL network will be considered as free time. In case DFCCIL is shifting machine from one section to another section of DFCCIL, all transit expenses are to be borne by DFCCIL. The days taken for shifting machines will be considered as availability for the purpose of counting 22 days.

1.27 Warrantee / Defect Liability Period

- 1.27.1 The O & M Contractor shall warranty that all the spares supplied under this contract shall be free from all defects and faults in material, workmanship and manufacture and shall be of acceptable standards / specifications for the contracted work and in full conformity with the technical specifications, and other contract stipulations. The warranty excludes normal wear and tear, rubber parts, lubricants, consumables including grinding stones. For recommended spares, the warranty would be 12 months from the date of supply.
- 1.27.2 During the period of warranty falling in the contract period the O & M Contractor shall keep available an experienced engineer / manpower to attend to any defective spares supplied by the Contractor. The contractor shall bear the cost of modifications, additions or substitutions that may be considered necessary due to faulty materials or workmanship for the satisfactory working of the equipment. The final decision shall rest with the Engineer his successor(s)/Nominee.
- 1.27.3 During the period of Warranty the Contractor shall be liable for the replacement of any part at site, of any parts supplied by the Contractor which may be found defective of his own manufacture or those of his sub-contractor / supplier whether arising from faulty materials, workmanship or negligence in any manner on the part of the Contractor provided always that such defective parts as are not repairable at site are promptly returned to the Contractor if so required by him at his (Contractor's) own expenses. In case of parts of executed work detected faulty/not as per specifications during guarantee period, contractor should replace all such items irrespective of the fact whether all such items have failed or not. The Contractor shall bear the cost of repairs carried out on his behalf by the Employer at site. In such a case, the contractor shall be informed in advance of the works proposed to be carried out by the Employer.
- 1.27.4 If it becomes necessary for the Contractor to replace or renew any defective portion/part/spare until the expiration of six month from the date of such replacement or renewal or until the end of the above-mentioned period whichever is later. Such an extension shall not apply in case of defects of a minor nature, the decision of the Chief General Manager / General Manager / CPM or his successor/nominee being final in the matter. If any defect is not remedy within a reasonable time during the aforesaid period the Employer may proceed to do work at the Contractor's risk and expense, but without prejudice to any other rights and remedies which the Employer may have against the Contractor in respect

1.27.5 The repaired or renewed parts/spares shall be delivered / supplied and erected/ executed on site free of charge by the contractor.

1.28 Payment

Payment will be governed by the terms specified in RFP and in accordance with the accepted schedule of prices (Form 3 of this RFP on the basis of contractor quoted bid), read with relevant para of the other parts of the contract. The DFCCIL retains the right to withhold money due to the contractor arising out of this contract for any default of the contractor. The Selected Bidder must submit monthly two bills separately one for main work as per SOR items and other for PVC (if claimed in that month). However, Selected Bidder can also submit more than one bill in a month, if spares /Consumables/Grinding stone are supplied in any particular month after submission of regular bill. Any type of reimbursement applicable as per this RFP will be made by DFCCIL as and when submitted by Selected Bidder

1.29 IPR Rights

All deliverables, outputs, plans, drawings, specifications, designs, reports, and other documents and software submitted by the contractor under this Contract shall become and remain the property of the DFCCIL and subject to laws of copyright and must not be shared with third parties or reproduced, whether in whole or part, without the DFCCIL's prior written consent. The O & M contractor shall, not later than upon termination or expiration of this Contract, deliver all such documents and software to the DFCCIL, together with a detailed inventory thereof. The O & M contractor may retain a copy of such documents and software but shall not use it for any commercial purpose.

1.30 Confidentiality

All documents, drawings, samples, data, associated correspondence or other information furnished by or on behalf of the DFCCIL to the contractor, in connection with the contract, whether such information has been furnished before, during or following completion or termination of the contract, are confidential and shall remain the property of the DFCCIL and shall not, without the prior written consent of DFCCIL neither be divulged by the O & M contractor to any third party, nor be used by him for any purpose other than the design, procurement, or other services and work required for the performance of this Contract. If advised by the DFCCIL, all copies of all such information in original shall be returned on completion of the contractor's performance and obligations under this contract.

1.31 Insurance

1.31.1 The contractor (a) shall take out and maintain, at its own cost (except for clause 1.31.2) but on terms and conditions approved by the DFCCIL, insurance against the risks, and for the coverage, as stipulated in the contract or any applicable law and shall provide, within 90 days of the issuance of the LOA, evidence to the DFCCIL showing that such insurance has been taken out and maintained and that the current premiums have been paid. Contractor shall be the Insuring party. DFCCIL shall be a beneficiary unless mentioned otherwise in this clause.

The contractor at DFCCIL cost shall provide, in the joint names of the DFCCIL and the O & M 1.31.2 contractor, insurance cover from the start date to the date of completion of the contract. Insurance for equipment shall be taken by the O&M Service Provider and this insurance should be of a value not less than the total cost of RGM & RIV. The insurance may be taken in the joint name of DFCCIL and the O&M Service Provider concerned. Copy of the insurance shall be shared with DFCCIL. In case of any event (Derailments, Cattle hits, Cattle run over, Strikes, riots, bomb attacks, Stone pelting, terrorist attacks, Fire incidents, Floods, Earthquakes, Collapse of shed or building, Other natural calamities including hurricanes, torrid rains etc.) damaging the RGM & RIV during O&M period, during the currency of the contract, the O&M Service Provider is responsible to get the machines (RGM & RIV) repaired using the funds from the insurance claim settlement amount. In case of any accident, irrespective of the responsibility of any party regarding the cause of the accident, the intent is to ensure that the machine is brought back to service as soon as possible by immediately applying for an insurance claim. The funds received as insurance claim settlement amount should be used to repair the damages on the machine and bring it back into operational condition. Nothing extra for such repairs would be paid by the DFCCIL. If required, DFCCIL would issue a "No Objection Certificate (NOC)" so that the O&M Service Provider can get the insurance claim settlement amount directly into their account explicitly for the purpose of immediate repairs of the RGM & RIV. It may be noted that any downtime of the RGM & RIV during the period of such heavy accidental/repairs, would not be counted as non-availability and the contract would be extended by the period of such delay without any additional liabilities/ penalties. If the claim is made by the O&M Service Provider in a timely manner but denied fully or partially by the Insurance company (on any ground) then for such unscheduled maintenance / repairs DFCCIL shall bear the cost of such repairs.

Loss including loss due to theft of or damage, including vandalism, to Machines both RGM Formation & RIV] all Equipment, machine tools, materials including Spares — Value covering the full reinstatement cost.

- 1.31.3 Insurance policies and certificates for insurance shall be delivered to the DFCCIL in original for scrutiny and In case, as a result of DFCCIL scrutiny, the policies are adjudged to be not covering the above mentioned risks, Contractor shall be under obligation, to take additional coverage or for due modification in Insurance policy, at their own cost. All such insurance shall provide compensation payable in Indian Rupees to rectify the loss or damage incurred. Any Alterations to the terms of insurance shall not be made without the approval of the Engineer. Both parties shall comply with any conditions of the insurance policies.
- 1.32.1 Contractor shall be liable to pay/refund the amount collected as GST to the DFCCIL along with interest and penalties, if any imposed by the authorities, in case GST input tax credit of DFCCIL is denied/rejected by the tax authorities due to reasons mentioned below but not limited to:
 - a) Wrong/incorrect invoices issued by Contractor.
 - b) No-filing of GST returns.
 - c) Non-payment of GST collected from DFCCIL to the authorities.

- 1.32.3 Retention Money: Any payment liable to be paid by DFCCIL to contractor against the goods or services or both supplied by such contractor to DFCCIL shall be kept on hold in case supplier makes any non-compliance of any of the GST law provisions including non-reporting of invoices in GST returns. Such payment shall be released after proper verification of records and availability of ITC to DFCCIL as per the provisions of GST Law.

PRE CONTRACT INTEGRITY PACT

General

WHEREAS the CLIENT proposes to procure (Name of the Stores/Equipment/Item, Name of the Consultancy Service, Name of Works Contract, Name of Services) and the [A] is willing to Offer/has offered for stores or works.

WHEREAS the [A] is a private company/ public company/ Government undertaking/ partnership/ registered export agency, constituted in accordance with the relevant law in the matter and the CLIENT is a PSU performing its functions or behalf of the President of India.

NOW, THEREFOR,

To avoid all forms of corruption by following a system that is fair, transparent and free from any influence/prejudiced dealings prior to, during and subsequent to the currency of the contract to be entered into with a view to:-

Enabling the CLIENT to obtain the desired said (Name of the Stores/Equipment/Item, Name of the Consultancy Service, Name of Works Contract, Name of Services) at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement, and

Enabling BIDDERs to abstain from bribing or indulging in any corrupt practice in order to secure [B] by providing assurance to them that their competitors will also abstain from bribing and other corrupt practices and the CLIENT will commit to prevent corruption, in any form, by its Officials by following transparent procedures.

The parties hereto hereby agree to enter into this Integrity Pact and agree as follows:

Commitments of the CLIENT

In such [B] a case while an enquiry is being conducted by the CLIENT the proceedings under the [B] would not be stalled.

Commitments of BIDDERS

- 3. The [A] commits itself to take all measures necessary to prevent corrupt practices, unfair means and illegal activities during any stage of its bid or during any pre-contract or postcontract stage) in order to secure the [B] contract or in furtherance to secure it and in particular committee itself to the following:-

 - * [A] shall disclose the name and address of agents and representatives and Indian [A] shall disclose their foreign principals or associates.

- * [A] shall disclose the payments to be made by them to agents/brokers or any other intermediary, in connection with this bid/contract.
- The [A] further confirms and declares to the CLIENT that the [A] is the original manufacturer/ integrator/ authorized government sponsored export entity of the defense stores and has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate or in any way to recommend to the CLIENT or any of its functionaries, whether officially or unofficially to the award of the [B] to the [A] nor has any amount been paid, promised or intended to be paid to any such individual, firm or company in respect of any such intercession, facilitation or recommendation.
- The [A] either while presenting the bid or during pre-contract negotiations or before signing the [B] shall disclose any payments he has made, is committed to or intends to make to officials of the CLIENT or their family members, agents, brokers or any other intermediaries in connection with the [B] and the details of services agreed upon for such payments.

- 8.4 Both the parties accept that the Monitors have the right to access all the documents relating to the project/procurement, including minutes of meetings.
- 8.5 As soon as the Monitor notices, or has reason to believe, a violation of this Pact, he will so inform the Authority designated by the CLIENT
- 8.6 The BIDDER(s) accepts that the Monitor has the right to access without restriction to all Project documentation of the CLIENT including that provided by the BIDOER. The [A] will also grant the Monitor, upon his request and demonstration of a valid Interest, unrestricted and unconditional access to his project documentation. The same is applicable to Subcontractors. The Monitor shall be und 'contractual obligation to treat the information and documents of the [A] with confidentiality.
- 8.7 The client will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the parties. The parties will offer to the Monitor the option to participate in such meetings.

8.8 The monitor will submit a written report to the MD/DFCCIL within 8 to 10 weeks from the date of reference or intimation to him by the CLIENT/BIDDER and, should the occasion arise, submit proposal for correcting problematic situations.

In case of any allegation of violation of any provisions of this Pact or payment of commission, the CLIENT or its agencies shall be entitled to examine all the documents including the Books of Accounts of the [A] and the [A] shall provide necessary information and documents in English and shall extend all possible help for the purpose of such examination.

- 9.1 Law and Place of Jurisdiction: This pact is subject to Indian law. The place of performance and jurisdiction is the seat of the CLIENT.
- 10. Other Legal Actions

The actions stipulated in this integrity pact are without prejudice to any other legal action that may follow in accordance with the provisions of the extant law in force relating to any civil or criminal proceedings.

- The validity of this integrity pact shall be from date of its signing and extend up to 5 years or the complete execution of the [B] to the satisfaction of both the CLIENT and the [A] including warranty period, whichever is later. In case [A] is unsuccessful, this integrity pact shall expire after six months from the date of the signing of the [B].
- 12. Should one or several provisions of this pact turn out to be invalid; the remainder of this pact shall remain valid. In this case, the parties will strive to come to an agreement to their original intentions.

Subject: Public Procurement (Preference to Make in India), Order 2017- Revision; regarding.

Department for Promotion of Industry and Internal Trade, in partial modification [Paras 2, 3, 5, 10 & 13] of Order No.P-45021/2/2017-B.E.-II dated 15.6.2017 as amended by Order No.P-45021/2/2017-B.E.-II dated 28.05.2018, Order No.P-45021/2/2017-B.E.-II dated 29.05.2019 and Order No.P-45021/2/2017-B.E.-II dated 04.06.2020, hereby issues the revised 'Public Procurement (Preference to Make in India), Order 2017" dated 16.09.2020 effective with immediate effect.

Whereas it is the policy of the Government of India to encourage 'Make in India' and promote manufacturing and production of goods and services in India with a view to enhancing income and employment, and

Whereas procurement by the Government is substantial in amount and can contribute towards this policy objective, and

Whereas local content can be increased through partnerships, cooperation with local companies, establishing production units in India or Joint Ventures (JV) with Indian suppliers, increasing the participation of local employees in services and training them,

Now therefore the following Order is issued:

- This Order is issued pursuant to Rule 153 (iii) of the General Financial Rules 2017.
- 2. Definitions: For the purposes of this Order:

'Local content' means the amount of value added in India which shall, unless otherwise prescribed by the Nodal Ministry, be the total value of the item procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all customs duties) as a proportion of the total value, in percent.

"Class-I local supplier" means a supplier or service provider, whose goods, services or works offered for procurement, meets the minimum local content as prescribed for 'Class-I local supplier' under this Order.

-2-

'Class-II local supplier' means a supplier or service provider, whose goods, services or works offered for procurement, meets the minimum local content as prescribed for 'Class-II local supplier' but less than that prescribed for 'Class-I local supplier' under this Order.

'Non - Local supplier' means a supplier or service provider, whose goods, services or works offered for procurement, has local content less than that prescribed for 'Class-II local supplier' under this Order.

"£1" means the lowest tender or lowest bid or the lowest quotation received in a tender, bidding process or other procurement solicitation as adjudged in the evaluation process as per the tender or other procurement solicitation.

'Margin of purchase preference' means the maximum extent to which the price quoted by a "Class-I local supplier" may be above the L1 for the purpose of purchase preference.

'Nodal Ministry' means the Ministry or Department identified pursuant to this order in respect of a particular item of goods or services or works.

'Procuring entity' means a Ministry or department or attached or subordinate office of, or autonomous body controlled by, the Government of India and includes Government companies as defined in the Companies Act.

'Works' means all works as per Rule 130 of GFR- 2017, and will also include 'turnkey works'.

Eligibility of 'Class-I local supplier'/ 'Class-II local supplier'/ 'Non-local suppliers' for different types of procurement

- (a) In procurement of all goods, services or works in respect of which the Nodal Ministry / Department has communicated that there is sufficient local capacity and local competition, only 'Class-I local supplier', as defined under the Order, shall be eligible to bid irrespective of purchase value.
- (b) Only 'Class-I local supplier' and 'Class-II local supplier', as defined under the Order, shall be eligible to bid in procurements undertaken by procuring entities, except when Global tender enquiry has been issued. In global tender enquiries, 'Non-local suppliers' shall also be eligible to bid along with 'Class-I local suppliers' and 'Class-II local suppliers'. In procurement of all goods, services or works, not covered by subpara 3(a) above, and with estimated value of purchases less than Rs. 200 Crore, in accordance with Rule 161(iv) of GFR, 2017, Global tender enquiry shall not be issued except with the approval of competent authority as designated by Department of Expenditure.
- (c) For the purpose of this Order, works includes Engineering, Procurement and Construction (EPC) contracts and services include System Integrator (SI) contracts.

- 3 -

3A. Purchase Preference

- (a) Subject to the provisions of this Order and to any specific instructions issued by the Nodal Ministry or in pursuance of this Order, purchase preference shall be given to 'Class-I local supplier' in procurements undertaken by procuring entities in the manner specified here under.
- (b) In the procurements of goods or works, which are covered by para 3(b) above and which are divisible in nature, the 'Class-I local supplier' shall get purchase preference over 'Class-II local supplier' as well as 'Non-local supplier', as per following procedure:
 - Among all qualified bids, the lowest bid will be termed as L1. If L1 is 'Class-l local supplier', the contract for full quantity will be awarded to L1.
 - ii. If L1 bid is not a 'Class-I local supplier', 50% of the order quantity shall be awarded to L1. Thereafter, the lowest bidder among the 'Class-I local supplier' will be invited to match the L1 price for the remaining 50% quantity subject to the Class-I local supplier's quoted price falling within the margin of purchase preference, and contract for that quantity shall be awarded to such 'Class-I local supplier' subject to matching the L1 price. In case such lowest eligible 'Class-I local supplier' fails to match the L1 price or accepts less than the offered quantity, the next higher 'Class-I local supplier' within the margin of purchase preference shall be invited to match the L1 price for remaining quantity and so on, and contract shall be awarded accordingly. In case some quantity is still left uncovered on Class-I local suppliers, then such balance quantity may also be ordered on the L1 bidder.
- (c) In the procurements of goods or works, which are covered by para 3(b) above and which are not divisible in nature, and in procurement of services where the bid is evaluated on price alone, the 'Class-I local supplier' shall get purchase preference over 'Class-II local supplier' as well as 'Non-local supplier', as per following procedure:
 - Among all qualified bids, the lowest bid will be termed as L1. If L1 is 'Class-l local supplier', the contract will be awarded to L1.
 - ii. If L1 is not 'Class-I local supplier', the lowest bidder among the 'Class-I local supplier', will be invited to match the L1 price subject to Class-I local supplier's quoted price falling within the margin of purchase preference, and the contract shall be awarded to such 'Class-I local supplier' subject to matching the L1 price.
 - iii. In case such lowest eligible 'Class-I local supplier' fails to match the L1 price, the 'Class-I local supplier' with the next higher bid within the margin of purchase preference shall be invited to match the L1 price and so on and contract shall be awarded accordingly. In case none of the 'Class-I local supplier' within the margin of purchase preference matches the L1 price, the contract may be awarded to the L1 bidder.

- (d) "Class-II local supplier" will not get purchase preference in any procurement, undertaken by procuring entities.
- 3B. Applicability in tenders where contract is to be awarded to multiple bidders In tenders where contract is awarded to multiple bidders subject to matching of L1 rates or otherwise, the 'Class-I local supplier' shall get purchase preference over 'Class-II local supplier' as well as 'Non-local supplier', as per following procedure:
 - a) In case there is sufficient local capacity and competition for the item to be procured, as notified by the nodal Ministry, only Class I local suppliers shall be eligible to bid. As such, the multiple suppliers, who would be awarded the contract, should be all and only 'Class I Local suppliers'.
 - b) In other cases, 'Class II local suppliers' and 'Non local suppliers' may also participate in the bidding process along with 'Class I Local suppliers' as per provisions of this Order.
 - c) If 'Class I Local suppliers' qualify for award of contract for at least 50% of the tendered quantity in any tender, the contract may be awarded to all the qualified bidders as per award criteria stipulated in the bid documents. However, in case 'Class I Local suppliers' do not qualify for award of contract for at least 50% of the tendered quantity, purchase preference should be given to the 'Class I local supplier' over 'Class II local suppliers' 'Non local suppliers' provided that their quoted rate falls within 20% margin of purchase preference of the highest quoted bidder considered for award of contract so as to ensure that the 'Class I Local suppliers' taken in totality are considered for award of contract for at least 50% of the tendered quantity.
 - d) First purchase preference has to be given to the lowest quoting 'Class-I local supplier', whose quoted rates fall within 20% margin of purchase preference, subject to its meeting the prescribed criteria for award of contract as also the constraint of maximum quantity that can be sourced from any single supplier. If the lowest quoting 'Class-I local supplier', does not qualify for purchase preference because of aforesaid constraints or does not accept the offered quantity, an opportunity may be given to next higher 'Class-I local supplier', falling within 20% margin of purchase preference, and so on.
 - e) To avoid any ambiguity during bid evaluation process, the procuring entities may stipulate its own tender specific criteria for award of contract amongst different bidders including the procedure for purchase preference to 'Class-I local supplier' within the broad policy guidelines stipulated in sub-paras above.
 - 4. Exemption of small purchases: Notwithstanding anything contained in paragraph 3, procurements where the estimated value to be procured is less than Rs. 5 lakhs shall be exempt from this Order. However, it shall be ensured by procuring entities that procurement is not split for the purpose of avoiding the provisions of this Order.
 - Minimum local content: The 'local content' requirement to categorize a supplier as 'Class-I local supplier' is minimum 50%. For 'Class-II local supplier', the 'local content' requirement is minimum 20%. Nodal Ministry/ Department may prescribe only a higher

percentage of minimum local content requirement to categorize a supplier as 'Class-I local supplier'/ 'Class-II local supplier'. For the items, for which Nodal Ministry/ Department has not prescribed higher minimum local content notification under the Order, it shall be 50% and 20% for 'Class-I local supplier'/ 'Class-II local supplier' respectively.

- Margin of Purchase Preference: The margin of purchase preference shall be 20%.
- 7. Requirement for specification in advance: The minimum local content, the margin of purchase preference and the procedure for preference to Make in India shall be specified in the notice inviting tenders or other form of procurement solicitation and shall not be varied during a particular procurement transaction.
- 8. Government E-marketplace: In respect of procurement through the Government E-marketplace (GeM) shall, as far as possible, specifically mark the items which meet the minimum local content while registering the item for display, and shall, wherever feasible, make provision for automated comparison with purchase preference and without purchase preference and for obtaining consent of the local supplier in those cases where purchase preference is to be exercised.

Verification of local content:

- a. The 'Class-I local supplier'/ 'Class-II local supplier' at the time of tender, bidding or solicitation shall be required to indicate percentage of local content and provide self-certification that the item offered meets the local content requirement for 'Class-I local supplier'/ 'Class-II local supplier', as the case may be. They shall also give details of the location(s) at which the local value addition is made.
- b. In cases of procurement for a value in excess of Rs. 10 crores, the 'Class-I local supplier'/ 'Class-II local supplier' shall be required to provide a certificate from the statutory auditor or cost auditor of the company (in the case of companies) or from a practicing cost accountant or practicing chartered accountant (in respect of suppliers other than companies) giving the percentage of local content.
- c. Decisions on complaints relating to implementation of this Order shall be taken by the competent authority which is empowered to look into procurement-related complaints relating to the procuring entity.
- d. Nodal Ministries may constitute committees with internal and external experts for independent verification of self-declarations and auditor's/ accountant's certificates on random basis and in the case of complaints.
- e. Nodal Ministries and procuring entities may prescribe fees for such complaints.
- f. False declarations will be in breach of the Code of Integrity under Rule 175(1)(i)(h) of the General Financial Rules for which a bidder or its successors can be debarred for up to two years as per Rule 151 (iii) of the General Financial Rules along with such other actions as may be permissible under law.

- g. A supplier who has been debarred by any procuring entity for violation of this Order shall not be eligible for preference under this Order for procurement by any other procuring entity for the duration of the debarment. The debarment for such other procuring entities shall take effect prospectively from the date on which it comes to the notice of other procurement entities, in the manner prescribed under paragraph 9h below.
- h. The Department of Expenditure shall issue suitable instructions for the effective and smooth operation of this process, so that:
 - The fact and duration of debarment for violation of this Order by any procuring entity are promptly brought to the notice of the Member-Convenor of the Standing Committee and the Department of Expenditure through the concerned Ministry /Department or in some other manner;
 - ii. on a periodical basis such cases are consolidated and a centralized list or decentralized lists of such suppliers with the period of debarment is maintained and displayed on website(s);
 - iii. in respect of procuring entities other than the one which has carried out the debarment, the debarment takes effect prospectively from the date of uploading on the website(s) in the such a manner that ongoing procurements are not disrupted.

10. Specifications in Tenders and other procurement solicitations:

- a. Every procuring entity shall ensure that the eligibility conditions in respect of previous experience fixed in any tender or solicitation do not require proof of supply in other countries or proof of exports.
- b. Procuring entities shall endeavour to see that eligibility conditions, including on matters like turnover, production capability and financial strength do not result in unreasonable exclusion of 'Class-I local supplier' 'Class-II local supplier' who would otherwise be eligible, beyond what is essential for ensuring quality or creditworthiness of the supplier.
- c. Procuring entities shall, within 2 months of the issue of this Order review all existing eligibility norms and conditions with reference to sub-paragraphs 'a' and 'b' above.

d. Reciprocity Clause

i. When a Nodal Ministry/Department identifies that Indian suppliers of an item are not allowed to participate and/ or compete in procurement by any foreign government, due to restrictive tender conditions which have direct or indirect effect of barring Indian companies such as registration in the procuring country, execution of projects of specific value in the procuring country etc., it shall provide such details to all its procuring entities including CMDs/CEOs of PSEs/PSUs, State Governments and other procurement agencies under their administrative control and GeM for appropriate reciprocal action.

-7-

ii. Entities of countries which have been identified by the nodal Ministry/Department as not allowing Indian companies to participate in their Government procurement for any item related to that nodal Ministry shall not be allowed to participate in Government procurement in India for all items related to that nodal Ministry/ Department, except for the list of items published by the Ministry/ Department permitting their participation.

The stipulation in (ii) above shall be part of all tenders invited by the Central iii. Government procuring entities stated in (i) above. All purchases on GeM shall also necessarily have the above provisions for items identified by nodal

Ministry/ Department.

State Governments should be encouraged to incorporate similar provisions in their respective tenders.

- The term 'entity' of a country shall have the same meaning as under the FDI Policy of DPIIT as amended from time to time.
- e. Specifying foreign certifications/ unreasonable technical specifications/ brands/ models in the bid document is restrictive and discriminatory practice against local suppliers. If foreign certification is required to be stipulated because of nonavailability of Indian Standards and/or for any other reason, the same shall be done only after written approval of Secretary of the Department concerned or any other Authority having been designated such power by the Secretary of the Department concerned.
- f. *All administrative Ministries/Departments whose procurement exceeds Rs. 1000 Crore per annum shall notify/ update their procurement projections every year, including those of the PSEs/PSUs, for the next 5 years on their respective website."
- 10A. Action for non-compliance of the Provisions of the Order: In case restrictive or discriminatory conditions against domestic suppliers are included in bid documents, an inquiry shall be conducted by the Administrative Department undertaking the procurement (including procurement by any entity under its administrative control) to fix responsibility for the same. Thereafter, appropriate action, administrative or otherwise, shall be taken against erring officials of procurement entities under relevant provisions. Intimation on all such actions shall be sent to the Standing Committee.
- 11. Assessment of supply base by Nodal Ministries. The Nodal Ministry shall keep in view the domestic manufacturing / supply base and assess the available capacity and the extent of local competition while identifying items and prescribing the higher minimum local content or the manner of its calculation, with a view to avoiding cost increase from the operation of this Order.
- 12. Increase in minimum local content: The Nodal Ministry may annually review the local content requirements with a view to increasing them, subject to availability of sufficient local competition with adequate quality.

- 13. Manufacture under license/ technology collaboration agreements with phased indigenization: While notifying the minimum local content, Nodal Ministries may make special provisions for exempting suppliers from meeting the stipulated local content if the product is being manufactured in India under a license from a foreign manufacturer who holds intellectual property rights and where there is a technology collaboration agreement / transfer of technology agreement for indigenous manufacture of a product developed abroad with clear phasing of increase in local content.
- 13A. In procurement of all goods, services or works in respect of which there is substantial quantity of public procurement and for which the nodal ministry has not notified that there is sufficient local capacity and local competition, the concerned nodal ministry shall notify an upper threshold value of procurement beyond which foreign companies shall enter into a joint venture with an Indian company to participate in the tender. Procuring entities, while procuring such items beyond the notified threshold value, shall prescribe in their respective tenders that foreign companies may enter into a joint venture with an Indian company to participate in the tender. The procuring Ministries/Departments shall also make special provisions for exempting such joint ventures from meeting the stipulated minimum local content requirement, which shall be increased in a phased manner.
- 14. Powers to grant exemption and to reduce minimum local content: The administrative Department undertaking the procurement (including procurement by any entity under its administrative control), with the approval of their Minister-in-charge, may by written order, for reasons to be recorded in writing,
 - a. reduce the minimum local content below the prescribed level; or
 - b. reduce the margin of purchase preference below 20%; or
 - exempt any particular item or supplying entities from the operation of this Order or any part of the Order.

A copy of every such order shall be provided to the Standing Committee and concerned Nodal Ministry / Department. The Nodal Ministry / Department concerned will continue to have the power to vary its notification on Minimum Local Content.

- 15. Directions to Government companies: In respect of Government companies and other procuring entities not governed by the General Financial Rules, the administrative Ministry or Department shall issue policy directions requiring compliance with this Order.
- 16. Standing Committee: A standing committee is hereby constituted with the following membership:

Secretary, Department for Promotion of Industry and Internal Trade—Chairman Secretary, Commerce—Member Secretary, Ministry of Electronics and Information Technology—Member Joint Secretary (Public Procurement), Department of Expenditure—Member Joint Secretary (DPIIT)—Member-Convenor

The Secretary of the Department concerned with a particular item shall be a member in respect of issues relating to such item. The Chairman of the Committee may co-opt technical experts as relevant to any issue or class of issues under its consideration.

- Functions of the Standing Committee: The Standing Committee shall meet as often as necessary, but not less than once in six months. The Committee
 - a. shall oversee the implementation of this order and issues arising therefrom, and make recommendations to Nodal Ministries and procuring entities.
 - b. shall annually assess and periodically monitor compliance with this Order
 - shall identify Nodal Ministries and the allocation of items among them for issue of notifications on minimum local content
 - d. may require furnishing of details or returns regarding compliance with this Order and related matters
 - e. may, during the annual review or otherwise, assess issues, if any, where it is felt that the manner of implementation of the order results in any restrictive practices, cartelization or increase in public expenditure and suggest remedial measures.
 - f. may examine cases covered by paragraph 13 above relating to manufacture under license/ technology transfer agreements with a view to satisfying itself that adequate mechanisms exist for enforcement of such agreements and for attaining the underlying objective of progressive indigenization
 - g. may consider any other issue relating to this Order which may arise.
- 18. Removal of difficulties: Ministries /Departments and the Boards of Directors of Government companies may issue such clarifications and instructions as may be necessary for the removal of any difficulties arising in the implementation of this Order.
- 19. Ministries having existing policies: Where any Ministry or Department has its own policy for preference to local content approved by the Cabinet after 1st January 2015, such policies will prevail over the provisions of this Order. All other existing orders on preference to local content shall be reviewed by the Nodal Ministries and revised as needed to conform to this Order, within two months of the issue of this Order.
- 20. Transitional provision: This Order shall not apply to any tender or procurement for which notice inviting tender or other form of procurement solicitation has been issued before the issue of this Order.

Annexure-I

General Conditions of Dispute Adjudication Agreement

1. Definitions

Each "Dispute Adjudication Agreement" is a tripartite agreement by and between:

- (a) the "Employer";
- (b) the "Contractor"; and
- (c) the "Member" who is defined in the Dispute Adjudication Agreement as one of the three persons who are jointly called the "DAB" (or "dispute adjudication board") and, where this is the case, the other two persons are called the "Other Members".

The Employer and the Contractor have entered (or intend to enter) into a contract, which is called the "Contract" and is defined in this Dispute Adjudication Agreement, In the Dispute Adjudication Agreement, words and expressions which are not otherwise defined shall have the meanings assigned to them in the Contract.

General Provisions

The Dispute Adjudication Agreement shall take effect when the Employer, the Contractor and each of the Members (or Member) have respectively each signed a dispute adjudication agreement.

When the Dispute Adjudication Agreement has taken effect, the Employer and the Contractor shall each give notice to the Member accordingly. If the Member does not receive either notice within six months after entering into the Dispute Adjudication Agreement, it shall be void and ineffective.

This employment of the Member is a personal appointment. No assignment or subcontracting of the Dispute Adjudication Agreement is permitted without the prior written agreement of all the parties to it and of the Other Members (if any).

3. Warrenties

The Member warrants and agrees that he/she is and shall be impartial and independent of the Employer, the Contractor and the Engineer. The Member shall promptly disclose, to each of them and to the Other Members (if any), any fact or circumstance which might appear inconsistent with his/her warranty and agreement of impartiality and independence.

When appointing the Member, the Employer and the Contractor relied upon the Member's representations that he/she is:

- (a) experienced in the work which the Contractor is to carry out under the Contract,
- (b) experienced in the interpretation of contract documentation, and
- (c) fluent in the language for communications defined in the Contract.

4. General Obligations of the Member

The Member shall:

(a) have no interest financial or otherwise in the Employer, the Contractor or the Engineer, nor any financial interest in the Contract except for payment under the Dispute Adjudication Agreement;

- (b) not previously have been employed as a consultant or otherwise by the Employer, the Contractor or the Engineer, except in such circumstances as were disclosed in writing to the Employer and the Contractor before they signed the Dispute Adjudication Agreement;
- (c) have disclosed in writing to the Employer, the Contractor and the Other Members (if any), before entering into the Dispute Adjudication Agreement and to his/her best knowledge and recollection, any professional or personal relationships with any director, officer or employee of the Employer, the Contractor or the Engineer, and any previous involvement in the overall project of which the Contract forms part;
- (d) not, for the duration of the Dispute Adjudication Agreement, be employed as a consultant or otherwise by the Employer, the Contractor or the Engineer, except as may be agreed in writing by the Employer, the Contractor and the Other Members (if any);
- (e) comply with the annexed procedural rules and with Sub-Clause 63.2 of the Conditions of Contract;
- (f) not give advice to the Employer, the Contractor, the Employer's Personnel or the Contractor's Personnel concerning the conduct of the Contract, other than in accordance with the annexed procedural rules;
- (g) not while a Member enter into discussions or make any agreement with the Employer, the Contractor or the Engineer regarding employment by any of them, whether as a consultant or otherwise, after ceasing to act under the Dispute Adjudication Agreement;
- (h) ensure his/her availability for any site visit and hearings as are necessary; and
- (i) treat the details of the Contract and all the DAB's activities and hearings as private and confidential, and not publish or disclose them without the prior written consent of the Employer, the Contractor and the Other Members (if any).

The Employer, the Contractor, the Employer's Personnel and the Contractor's Personnel shall not request advice from or consultation with the Member regarding the Contract, otherwise than in the normal course of the DAB's activities under the Contract and the Dispute Adjudication Agreement, and except to the extent that prior agreement is given by the Employer, the Contractor and the Other Members (if any). The Employer and the Contractor shall be responsible for compliance with this provision, by the Employer's Personnel and the Contractor's Personnel respectively.

The Employer and the Contractor undertake to each other and to the Member that the Member shall not, except as otherwise agreed in writing by the Employer, the Contractor, the Member and the Other Members (if any):

- (a) be appointed as an arbitrator in any arbitration under the Contract;
- (b) be called as a witness to give evidence concerning any dispute before arbitrator(s) appointed for any arbitration under the Contract; or
- (c) be liable for any claims for anything done or omitted in the discharge or purported discharge of the Member's functions, unless the act or omission is shown to have been in bad faith.

The Employer and the Contractor hereby jointly and severally indemnify and hold the Member harmless against and from claims from which he/she is relieved from liability under the preceding paragraph.

5. General
Obligations of the Employer and the
Contractor

- 6. Payment The Member shall be paid as per fee defined by DFCCIL
 - (a) a daily fee shall be considered as payment in full for:
 - (i) each working day spent reading submissions, attending hearings (if any), preparing decisions, or making site visits (if any); and
 - (ii) each day or part of a day up to maximum of two days travel time in each direction for the journey (if any) between the Member's home and site or another location of a meeting with Other Members (if any) and/or the Employer and the Contractor;
 - (b) all reasonable expenses incurred in connection with the Member's duties, including the cost of secretarial services, telephone calls, courier charges, faxes and telexes, travel expenses, hotel and subsistence costs; a receipt shall be required for each item in excess of five percent of the daily fee referred to in sub-paragraph (a) of this Clause; and
 - (c) any taxes properly levied in the Country on payments made to the Member (unless a national or permanent resident of the Country) under this Clause 6.

The daily fee shall be as specified in the Dispute Adjudication Agreement.

Immediately after the Dispute Adjudication Agreement takes effect, the Member shall, before engaging in any activities under the Dispute Adjudication Agreement, submit to the Contractor, with a copy to the Employer, an invoice for (a) an advance of twenty-five (25) percent of the estimated total amount of daily fees to which he/she will be entitled and (b) an advance equal to the estimated total expenses that he/she shall incur in connection with his/her duties. Payment of such invoice shall be made by the Contractor upon his receipt of the invoice. The Member shall not be obliged to engage in activities under the Dispute Adjudication Agreement until each of the Members has been paid in full for invoices submitted under this paragraph.

Thereafter the Member shall submit to the Contractor, with a copy to the Employer, invoices for the balance of his/her daily fees and expenses, less the amounts advanced. The DAB shall not be obliged to render its decision until invoices for all daily fees and expenses of each Member for making a decision shall have been paid in full.

Unless paid earlier in accordance with the above, the Contractor shall pay each of the Member's invoices in full within 28 calendar days after receiving each invoice and shall apply to the Employer (in the Statements under the Contract) for reimbursement of one-half of the amounts of these invoices. The Employer shall then pay the Contractor in accordance with the Contract.

If the Contractor fails to pay to the Member the amount to which he/she is entitled under the Dispute Adjudication Agreement, the Employer shall pay the amount due to the Member and any other amount which may be required to maintain the operation of the DAB; and without prejudice to the Employer's rights or remedies. In addition to all other rights arising from this default, the Employer shall be entitled to reimbursement of all sums paid in excess of one-half of these payments, plus all costs of recovering these sums and financing charges calculated at the rate specified in Sub-Clause 14.8 of the Conditions of Contract.

If the Member does not receive payment of the amount due within 28 days after submitting a valid invoice, the Member may (i) suspend his/her services (without notice) until the payment is received, and/or (ii) resign his/her appointment by giving notice to the Employer and the Contractor. The notice shall take effect when received by them both. Any such notice shall be final and binding on the Employer, the Contractor and the Member.

7. Default of the Member

If the Member fails to comply with any obligation under Clause 4, he/she shall not be entitled to any fees or expenses hereunder and shall, without prejudice to their other rights, reimburse each of the Employer and the Contractor for any fees and expenses received by the Member and the Other Members (if any), for proceedings or decisions (if any) of the DAB which are rendered void or ineffective.

8. Disputes

Any dispute or claim arising out of or in connection with this Dispute Adjudication Agreement, or the breach, termination or invalidity thereof, shall be finally settled under the Rules of Arbitration of the Indian Council of Arbitration by one arbitrator appointed in accordance with these Rules of Arbitration

Annexure-II

PROCEDURAL RULES TO DISPUTE ADJUDICATION

- The Employer and the Contractor shall furnish to the DAB one copy of all documents which the DAB may request, including Contract documents, progress reports, variation instructions, certificates and other documents pertinent to the matter in dispute. All communications between the DAB and the Employer or the Contractor shall be copied to the other Party. If the DAB comprises three persons, the Employer and the Contractor shall send copies of these requested documents and these communications to each of these persons.
- 2 The DAB shall proceed in accordance with Sub-Clause 63.2 and these Rules. Subject to the time allowed to give notice of a decision and other relevant factors, the DAB shall:
 - (a) act fairly and impartially as between the Employer and the Contractor, giving each of them a reasonable opportunity of putting his case and responding to the other's case, and
 - (b) adopt procedures suitable to the dispute, avoiding unnecessary delay or expense.
- 3 The DAB may conduct a hearing on the dispute, in which event it will decide on the date and place for the hearing and may request that written documentation and arguments from the Employer and the Contractor be presented to it prior to or at the hearing.
- Except as otherwise agreed in writing by the Employer and the Contractor, the DAB shall have power to adopt an inquisitorial procedure, to refuse admission to hearings or audience at hearings to any persons other than representatives of the Employer, the Contractor and the Engineer, and to proceed in the absence of any party who the DAB is satisfied received notice of the hearing; but shall have discretion to decide whether and to what extent this power may be exercised.
- 5 The Employer and the Contractor empower the DAB, among other things, to:
 - (a) establish the procedure to be applied in deciding a dispute,
 - (b) decide upon the DAB's own jurisdiction, and as to the scope of any dispute referred to it,
 - (c) conduct any hearing as it thinks fit, not being bound by any rules or procedures other than those contained in the Contract and these Rules,
 - (d) take the initiative in ascertaining the facts and matters required for a decision,
 - (e) make use of its own specialist knowledge, if any,
 - (f) decide upon the payment of financing charges in accordance with the Contract,
 - (g) decide upon any provisional relief such as interim or conservatory measures, and
 - (h) open up, review and revise any certificate, decision, determination, instruction, opinion or valuation of the Engineer, relevant to the dispute.
- The DAB shall not express any opinions during any hearing concerning the merits of any arguments advanced by the Parties. Thereafter, the DAB shall make and give its decision in accordance with Sub-Clause 63.2, or as otherwise agreed by the Employer and the Contractor in writing. If the DAB comprises three persons:
 - (a) it shall convene in private after a hearing, if any, in order to have discussions and prepare its decision;
 - (b) it shall endeavour to reach a unanimous decision: if this proves impossible, the applicable decision shall be made by a majority of the Members, who may require the minority Member to prepare a written report for submission to the Employer and the Contractor; and
 - (c) if a Member fails to attend a meeting or hearing, or to fulfil any required function, the other two Members may nevertheless proceed to make a decision, unless:
 - (i) either the Employer or the Contractor does not agree that they do so, or
 - (ii) the absent Member is the chairman and he/she instructs the other Member to not make a decision.

Annexure-IV

DETAILED SAFETY MEASURES

(A) MEASURES TO BE ENSURED PRIOR TO START OF WORK

- 1.1 The contractor shall not start any work without the presence of DFCCIL supervisors at site.
- 1.2 The methodology in detail for execution of the work at site shall be approved by engineering in charge of the organization executing the work and copies of the same shall be available with contractor's supervisor, DFCCIL supervisor of the section in whose jurisdiction the work falls.

(B) PROTECTION OF TRACK DURING EMERGENCY

- Action to be taken when a contractor's supervisor or vehicle operator apprehends any unusual circumstances likely to infringe the track and endanger safe running of trains. At any time if a contractor's supervisor or vehicle operator observes any unusual circumstances likely to infringe the track and apprehend danger to safe running of track, he shall take immediate steps to advise a DFCCIL official of such danger and assist him in protection of track.
- 2. The track shall be protected as under. One person shall immediately plant a red flag (red lamp during night) at the spot and proceed with all haste in the direction of approaching train with a red flag in hand (red lamp during night) and plant a detonator on rail at a distance of 600m from the place of obstruction of BG track after which he shall further proceed for not less than 1200m from the place of obstruction from BG track and plant three detonators at 10 m apart on rails. After this he shall display the red flag (red lamp during night) at a distance of 45 m from the detonators. Attempts shall also be made to send an advice to the nearest DFCCIL/Railway station about the incident immediately.
- 3. Action to be taken if train is seen approaching to site of danger and there is no time to protect the track as per guidelines mentioned above. In such a case the detonators shall be planted on rails immediately at distance away from place of danger as far as possible and attention of driver of approaching train shall be invited by whistling, waving the red flag vigorously, gesticulating and shouting.
- 4. Action to be taken if more than one track is obstructed.
 - i. In case of single line protection as above shall be done in both the directions from place of danger.
 - ii. In case of double line or multiple lines, if other tracks are also obstructed, the protection as above shall be done for other track also.
 - iii. The protection shall be done in that direction and on that track first on which train is likely to arrive first.
 - iv. The Contractor's Supervisors, Operators and lookout men shall be properly explained about the direction of trains on running tracks.
- 5. Equipment required for protection of track: Minimum compliment of protection equipment i.e. 10 detonators, 4 red hand flags, 4 red hand lamps, 4 banner flags and whistles etc. shall always be kept ready at worksites for use in case of emergency. DFCCIL will arrange to provide detonators, whereas Contractor shall arrange other equipment at his own cost
- 6. Arrangement of lookout men and competency required for lookout man to warn labour about approaching train.
 - a. DFCCIL will provide lookout men.

b. The lookout men shall be properly trained in warning to staff at worksite about approaching

c. Only those lookout men shall be provided at site who have been issued with a competency certificate by the DFCCIL Supervisor.

(C) SAFETY ASPECTS TO BE OBSERVED WHILE WORKING IN OHE AREA

- No electrical work close to running track shall be carried out without permission of DFCCIL representative.
- 2. A minimum distance of 2 m has to be maintained between live OHE wire and body part of worker or tools or metallic supports etc
- 3. No electric connection etc. can be tapped from OHE.

train.

- 4. Authorized OHE staff should invariably be present when the relaying work or any major work is carried out.
- 5. Power block is correctly taken and 'permit to work' is issued.
- 6. The structure bonds, track bonds, cross bonds, longitudinal rail bonds are not disturbed and If disconnected for the work, they are reconnected properly when the work is completed.
- 7. The track level is not raised beyond the permissible limit during the work.

(D) Dos and DONT'S FOR WORKING IN A.C. TRACTION AREA

DO(s)

- 1. In case of fire on electric traction equipment or wires:
 - a. Inform Traction Power Controller (TPC).
 - b. Extinguish fire by special extinguishers (Carbon tetrachloride or carbon dioxide type), if available.
 - c. Ensure no water jet directed at the fire is used under any circumstances.
- 2. Anything unusual on traction wires or eclectic rolling stock, inform Traction Power Controller or nearest Station Master.
- 3. In any emergency speak to Traction Power controller through the nearest means of communication.
 - a) Large metallic structures such as fencing, structural steel work of platform running parallel to the track should be earthed suitably.
 - Any tree or branches likely to fall on live conductor or nearer than 4m from the nearest live conductor shall be cut or trimmed by concerned staff in the presence of authorized staff of OHE.
 - c) Before taking up the work on a line running parallel to 2*25KV/25kV AC lines, the line shall be earthed on both the sides of the working party.
 - Ensure that distance between the two earths used for protection of working party does not exceed 1 km.

e) Keep clear of the track and avoid contact with the rails when electric train within 250m.

f) Special care should be taken to carry long pipes, poles or ladders so that it should not come in contact with or within 2m of live OHE.

DON'T(s)

- a) DO NOT approach within 2 meters (approximately 7 feet) of any traction wires or live equipment.
- **b)** DO NOT work on or near traction wires or any live equipment unless they are made dead, earthed, and shut down notices/permit to work obtained.
- c) DO NOT enter any switching station or remote-control center unless specially permitted.
- d) DO NOT permit unauthorized persons to operate any equipment even if it be for making it dead.
- **e)** DO NOT disturb any earthing or bonding or traction wires or connections to BEC (buried earth cable) or OPC (overhead protection cable).
- f) DO NOT touch a person in contact with live traction wires. Remove body only after power supply is switched off & earthed.
- g) DO NOT forget to give artificial respiration to the victim as per the prescribed procedure laid down at shock treatment charts.
- h) DO NOT touch any traction wire hanging from the mast or fallen on the ground and do not allow anyone else to touch it.
