There shall be no upper limit on number of auto extensions. When no offer is received in the last auto extension period, e-RA shall close.
 - (c) Minimum decrement in percentage of value of the last successful bid.
3. Date and time for start of e-RA shall be communicated to qualified tenderers by the convener after evaluation of the Technical Bids.
4. After submission of Initial Price Bid, tenderers will not be allowed to revise the taxes and other levies.
5. During auction period, identities of the participating tenderers will be kept hidden.
6. Minimum admissible bid value will be last bid value minus minimum decrement as specified by the tendering authority before starting of reverse auction. Starting point for reverse auction shall be the lowest initial Price Bid of the Tenderer eligible for award of contract.
7. After close of the RA, tabulation of last (minimum) bids received from all the tenderers will be generated and made visible to Railways and participating tenderers.
8. Railway users can also view the bidding history in chronological order.
9. Bidders not be allowed to withdraw their last offer.
10. L-1 will be defined as the lowest bid obtained after the closure of R.A. session for Goods Works and Services tenders.

4.0	<u>USE OF DFCCIL LAND</u>
4.1	Use of DFCCIL land required by the contractor(s) for constructing temporary offices, quarters, hutments etc. for the staff and for storing materials etc. would be permitted to him/them free of charge by DFCCIL, if available. The location of these offices, hutments, stores etc., will be subject to the approval of the engineer or his authorized representative. - (b) During the period of guarantee the Contractor shall keep available an experienced engineer / man power to attend to any defective works / installations resulting from defective erection and/or defect in the installation supplied by the Contractor. This engineer shall not attend to rectification of defects which arise out of normal wear and tear and come within the purview of routine maintenance work. The contractor shall bear the cost of modifications, additions or substitutions that may be considered necessary due to faulty materials or workmanship for the satisfactory working of the equipment. The final decision shall rest with the Engineer his successor(s)/Nominee.
- (c) During the period of Guarantee the Contractor shall be liable for the replacement at site of any parts which may be found defective in the executed work whether such parts / structural elements of his own manufacture or those of his sub-contractor / supplier whether arising from faulty materials, workmanship or negligence in any manner on the part of the Contractor provided always that such defective parts as are not repairable at site are promptly returned to the Contractor if so required by him at his (Contractor's) own expenses. In case of parts of executed work detected during guarantee period, contractor should replace all such items irrespective of the fact whether all such items have failed or not. The Contractor shall bear the cost of repairs carried out on his behalf by the Employer at site. In such a case, the contractor shall be informed in advance of the works proposed to be carried out by the Employer.
- (d) If it becomes necessary for the Contractor to replace or renew any defective portion of the structural elements until the expiration of six month from the date of such replacement or renewal or until the end of the above mentioned period whichever is later. Such extension shall not apply in case of defects of a minor nature, the decision of the Chief General Manager or his successor/nominee being final in the matter. If any defect be not remedied within a reasonable time during the aforesaid period the Employer may proceed to do work at the Contractor's risk and expense, but without prejudice to any other rights and remedies which the Employer may have against the Contractor in respect of such defects or faults.
- (e) The repaired or renewal parts structure shall be delivered / supplied and erected / executed on site free of charge to the Employer.
- (f) Any materials, fittings, components or equipment / structure supplied under items for supplying / providing and fixing in schedule shall also be covered by the provisions of this paragraph. The liability of the Contractor under the

	<p>guarantee will be limited to re-supply of components / structure installation and fittings.</p> <p>(g) In this contract, the testing of equipments is the only activity to be carried out. (b) If the Contractor shall be dissatisfied by reason of any decision of the Engineer's representative, he shall be entitled to refer the matter to the Engineer who shall there upon confirm or vary such decision.

(SAFETY PRECAUTIONS)

1.0	<u>MEASURES TO BE ENSURED PRIOR TO START OF WORK</u>
1.1	The contractor shall not start any work without the presence of DFCCIL supervisors at site.
1.2	The methodology in detail for execution of the work at site shall be approved by engineering in charge of the organization executing the work and copies of the same shall be available with contractor's supervisor, DFCCIL supervisor of the section in whose jurisdiction the work falls.
1.3	Before permitting the execution of certain work involving shutdown / outage of tower wagon for specific time period, DFCCIL engineer-in-charge (APM/DPM/PM/Dy. CPM), of the section shall ensure that he received the prior intimation/confirmation of the following aspects from representative of contractor.
I.	Name and address of the contract assigned to execute the work.
II.	Name of the Contractor's supervisor
III.	Name of the supervisor/assistant engineer/assistant officer of the construction organization/other organizations who are going to be site in charge/in charge of work site.
IV.	List of the number(s) of individual vehicle(s)/ machineries, names and license particulars of the driver(s) proposed to be used by contractor.
V.	Information regarding location, duration and timings during which the vehicles/machinery are planned to be plied/worked.
VI.	The supervisors and operators of the contractor proposed to be deployed at work site which is close to the running track, shall be imparted training by the DFCCIL trainer at contractor own cost about the safety measures to be adopted while working in the vicinity of running track. Further competency certificate to the individual supervisors/operator shall be issued as in Annexure-A by a DFCCIL officer not below the rank of Assistant level officer who is in charge of site. No supervisor/operator of the contractor shall work or allowed to work in the vicinity of running track who is not possession of valid competent certificate.
VII.	Survey of site by supervisor of contractor and DFCCIL to assess the precautions to be taken at site for working of trains and materials required for protection.
VIII.	Written advice to sectional APM/DPM about the detailed planning of work including protection of track and safety measures proposed to be adopted.
IX.	A copy of the approved methodology (to be approved by engineer in charge) proposed to be adapted by the contractor with a view to ensure safety of trains passengers and workers.
X.	Assurance that the methods and arrangements are actually available at site before start of the work and the contractors supervisors and the workers have clearly understood the safety aspects and requirement to be adapted/followed while executing the work.
XI.	An assurance register has been kept at site duly signed by both DFCCIL supervisor as well as by the contractor supervisor as a token of their having understood the safety precautions to be observed at site.
XII.	No work shall which is to be done near running track shall commence unless permitted by sectional APM/DPM/PM/Dy.CPM
XIII.	Supplementary site specific instructions, wherever considered necessary shall be issued by the Engineer in Charge
XIV.	Standard Check list on Safety at Work Sites shall be used to ensure that all the requisite measures have been taken before start of work.
2.0	<u>PLYING OF ROAD VEHICLES AND WORKING OF MACHINERIES CLOSE TO RUNNING TRACKS</u>

(i)	Normally, the road vehicles shall be run or machinery shall be worked so as not to come closer than 6.0m from center line of nearest running track.
(ii)	The land strip adjacent to running tracks, where road vehicle is to ply or machinery is to work, shall be demarcated by lime in advance in consultation with the DFCCIL's Supervisor. Wooden pegs at interval not exceeding 75mts shall be provided along the line marking as permanent marks. The road vehicles shall ply or machinery shall work so as not to infringe the line of demarcation.
(iii)	If a road vehicle or machinery is to work closer to 6.0m due to site conditions or requirement of work, following precautions shall be observed.
a.	In no case the road vehicle shall run or machinery shall work at distance less than 3.5m from center line of track.
b.	Demarcation of land shall be done by bright colored ribbon/nylon cord suspended on 120 cm high wooden/bamboo posts at distance of 3.5 m from center line of nearest running track.
c.	Presence of an authorized DFCCIL's representative shall be ensured before plying of vehicle or working of machinery.
d.	DFCCIL's Supervisor shall issue suitable caution order to Drivers of approaching train about road vehicles plying or machineries working close to running tracks. The train drivers shall be advised to whistle freely to warn about the approaching train. Whistle boards shall be provided wherever considered necessary.
e.	Lookout men shall be posted along the track at a distance of 800m from such locations who will carry red flag and whistles to warn the road vehicle/machinery users about the approaching trains. Lookout man shall be deputed for Safety at Work Sites.
f.	On curves where visibility is poor, additional lookout men shall be posted.
(iv)	If vehicle/machinery is to be worked closer to 3.5m from running track. Under unavoidable conditions, if road vehicles is to ply or machinery is to work closer to 3.5m due to site conditions or requirement of work, following precautions shall be observed:
a.	Plying of vehicles or working of machinery closer to 3.5m of running track shall be done only under protection of track. Traffic block shall be imposed wherever considered necessary. The site shall be protected as per provisions of Para No. 806 & 807 of P-Way Manual as case may be.
b.	Presence of a DFCCIL's Supervisor shall be ensured at worksite.
c.	DFCCIL's Supervisor shall issue suitable caution order to Drivers of approaching train about road vehicles plying or machineries working close to running tracks. The train drivers shall be advised to whistle freely to warn about the approaching train.
(v)	Precaution to be taken while reversing road vehicle alongside the track. The location where vehicle will take a turn shall be demarcated duly approved by DFCCIL's representative. The road vehicle driver shall always face the DFCCIL track during the course of turning/reversing his vehicle. Presence of an authorized DFCCIL representative shall be ensured at such location.
(vi)	Road vehicle shall not be allowed to run along the track during night hours generally. In unavoidable situations, however, vehicles shall be allowed to work during night hours only in the presence of an authorized DFCCIL's representative and where adequate lighting arrangements are made and where adequate precautions as mentioned earlier have been ensured.

(i)	Precaution to be taken to ensure safety of trains while execution of work close to the running line or on running lines.
(a)	Contractor has deputed trained supervisors in required number at worksites duly certified by APM/DPM/PM/Dy. CPM in charge of the works.
(b)	Drivers of vehicle/operators of the machines have been briefed about the safety and precautions to be taken while moving / working close to traffic.
(c)	Contractor shall ply road vehicles/working of machinery only between sunset and sunrise. In case of emergency where it is necessary to work during night hours sufficient lighting shall be ensured in the complete work area for the safety of public and passengers. Also additional staff shall be posted as necessary for night working and taking safety precautions.
(d)	The contractor shall not change the approved vehicle/machinery and driver/operator for working at site. Contractor shall not induct any new vehicle/machinery and driver/operator without prior written approval of APM/DPM and the list of such changes with numbers of individual vehicle, name and license particulars of the driver shall be given to APM/DPM/PM/Dy. CPM of the section.
(e)	Contractor shall ensure that road vehicle/machinery ply/work in a way so that these do not infringe the line of demonstration.
(f)	Lookout men with required safety equipment shall be posted where necessary.
(g)	In unusual circumstances, where operator apprehends danger to track while working truck/machinery near running track, following action shall be taken.
a)	The contractor/supervisor/vehicle operator immediately advice the situation to DFCCIL official/officials of the organization executing the work and assist him/them in protecting the track.
b)	Protection shall be done as done for other emergencies.
(h)	Individual vehicle/machinery shall not be left unattended at site of work. If it is unavoidable and becomes necessary to stable the road vehicle/machinery at site near the running track, these shall be properly secured against any possible roll off and always be manned even during non-working hours. In addition the road vehicle / machinery should be stabled parallel to track only so that incase of failure of any securing arrangement, it may not roll towards the track.
(i)	All temporary arrangements required to be made during execution of work shall be made in such a manner that moving dimensions do not infringe. Necessary checks shall be exercised by site in charge from time to time.
(j)	During the hours of night, lamps of temporary indicators which are not of reflective type should be lit at sun-set and kept burning till sun rise, where trains run at night.
(ii)	Precaution to be taken to ensure safety of electrical/signal/ telephone cables while excavating near tracks.
(a)	Particular care shall be taken to mark the locations of buried electrical/signal/telephone cables on the plans jointly with S & T/Electric supervisor and also at site so that these are not damaged during excavation
(b)	Copy of the cable plan should be given to the contractor's authorized representative before handing over the site to start the work.
(c)	Due care shall be taken to ensure that any part of the equipment or machinery or temporary arrangement does not come close to cables while working.
(iii)	Precaution to be taken during execution of works requiring traffic blocks.
a)	Any work, which infringes the moving dimensions or causes discontinuity in the track any activity making the existing track unsafe for passage of trains etc. Shall be started only after the traffic block has been imposed, DFCCIL servant in charge of the work is present at the worksite, engineering signals are exhibited at specified distance and flagmen are posted with necessary equipment to man them etc.
b)	Before closing the work, the track shall be left with the proper track geometry so that the trains run safely and flagmen are kept in the night with safety and track protection

	equipment to patrol the stretch and take action to protect the track, if so warranted and inform the DFCCIL supervisors.
c)	After completion of work the released sleeper and fittings should be properly stacked away from the track to be kept clear of moving dimensions.
d)	Block shall be removed only when all the temporary arrangement, machineries, tools, plants etc. have been kept clear of moving dimensions.
(iv)	Precaution to be taken during execution of works during night. The work close to running line, generally, shall be carried out only during day hours. At locations, however, where night working is unavoidable, proper lighting arrangement should be made. The engineering indicator boards shall be lighted during night hours as per the provisions of IRPWM. The staff deputed for night working should have taken adequate rest before deploying them in night shift. We can specify duration of night shift from 20.00 hrs to 04.00 hrs. All other safety precautions applicable for day time work should be strictly observed during night working.
(v)	Precautions to be taken to ensure safety of workers while working close to running lines.
a)	Any work close to or on running tracks shall be executed under the presence of a DFCCIL's supervisor only.
b)	Precaution to be taken to ensure safety of trains while execution of work close to the running line or on running lines.
	<ul style="list-style-type: none"> (i) Such works shall be planned and necessary drawings particularly with regard to infringement to moving dimensions shall be finalized duly approved by competent authority before execution of work. The work shall be executed only as per approved procedure and drawings. (ii) All temporary arrangements required to be made during execution of work shall be made in such a manner that moving dimension do not infringe. (iii) Suitable speed restriction shall be imposed or Traffic block shall be ensured as required. (iv) The site shall be protected as per provisions of Para No. 806 & 807 of P.Way Manual as case may be. (v) Necessary equipment for safety of trains during emergency shall be kept ready at site.
c)	A 'first aid kit' shall always be kept ready at site.
(vi)	Precaution shall be taken for safety of public or passengers, while executing works at locations, used by passengers and public. The worksite shall be suitably demarcated to keep public and passengers away from work area. Necessary signage boards such as "Work in progress. Inconvenience is regretted" etc. shall be provided at appropriate locations to warn the public/ passengers. Adequate lighting arrangement of worksite wherever required shall be done to ensure safety of public/passengers during night.
(vii)	Precaution to be taken before stacking materials alongside the track to ensure that safety of trains is not affected. The following precautions shall be taken before stacking the materials along the track for stacking of ballast, rails, sleepers etc.
a)	The sites for material stacking should be selected in advance in such a manner as to ensure that no part of the material to be stacked is infringing the Standard Moving Dimensions. A plan of proposed stacking locations be made and signed jointly by an authorized DFCCIL's representative and contractor's representative.
b)	The selected locations shall be marked by lime in advance.
c)	Presence of an authorized DFCCIL's representative while unloading and stacking shall be ensured.
d)	The material shall be stacked in such a height so as to not to infringe SOD in case of accidental roll off.

(viii)	Precaution for handling of departmental material trains Instructions for working of material trains are contained in Chapter XII of IRPWM which should be brought to the notice of the supervisors and other staff working on the material trains. In addition to this, following precautions should be taken:
(i)	Issue of 'fit to run' certificate. As per Para 1207 before a material train is allowed to work, the complete rake should be examined by the Carriage and Wagon staff and a 'fit to run' certificate issued to the Guard.
(ii)	As per Para 1208 of IRPWM, a qualified Engineering official should be deputed on the train to ensure working of the material train as the Guard is not qualified to carry out such duties like Supervising of loading and unloading of materials.
(iii)	As per Para 1204 of IRPWM, the material train should not be permitted to work during the period of poor visibility due to fog, storm or any other cause except with the permission of the APM/DPM/PM/Dy. CPM. Working of the material trains carrying labour should not be permitted between sunset and sunrise except in an emergency.
(iv)	While unloading rail panels by the side of the running track, placement of the panels, clear of the maximum moving dimensions should be ensured.
(v)	Unloading of rail panels should be done by a team of trained staff under the active supervision of competent Supervisor/Officer.
(vi)	Before unloading of rail panels, site should be prepared by way of leveling/removing extra ballast, if any, from the crib and shoulder with the objective to ensure requisite lateral and vertical clearances so as to prevent slippage of rail panels due to vibration during the passage of trains.
(vii)	Reasonably adequate block should be asked and provided for unloading of the material and the work should be done preferably in day light to avoid shortcut in haste which may infringe the safety requirements.
(ix)	<u>SAFETY ASPECTS TO BE OBSERVED WHILE WORKING IN OHE AREA</u>
(i)	No electrical work close to running track shall be carried out without permission of DFCCIL representative.
(ii)	A minimum distance of 2m has to be maintained between live OHE wire and body part of worker or tools or metallic supports etc.
(iii)	No electric connection etc. can be tapped from OHE.
(iv)	Authorized OHE staff should invariably be present when the relaying work or any major work is carried out.
(v)	Power block is correctly taken and 'permit to work' is issued.
(vi)	The structure bonds, track bonds, cross bonds, longitudinal rail bonds are not disturbed and
(vii)	If disconnected for the work, they are reconnected properly when the work is completed.
(viii)	The track level is not raised beyond the permissible limit during the work.
4.0	<u>PROTECTION OF TRACK DURING EMERGENCY</u>
(i)	Action to be taken when a contractor's supervisor or vehicle operator apprehends any unusual circumstances likely to infringe the track and endanger safe running of trains. At any time if a contractor's supervisor or vehicle operator observes any unusual circumstances likely to infringe the track and apprehend danger to safe running of track, he shall take immediate steps to advise a DFCCIL official of such danger and assist him in protection of track. The track shall be protected as under. One person shall immediately plant a red flag (red lamp during night) at the spot and proceed with all haste in the direction of approaching train with a red flag in hand (red lamp during night) and plant a detonator on rail at a distance of 600m from the place of obstruction of BG track after which he shall further proceed for not less than 1200m from the place of obstruction from BG track and plant three detonators at 10m apart on rails. After this he shall display the red flag (red lamp during night) at a distance of 45m from the detonators.

	Attempts shall also be made to send an advice to nearest DFCCIL station about the incident immediately.
(ii)	Action to be taken if train is seen approaching to site of danger and there is no time to protect the track as per guidelines mentioned above. In such a case the detonators shall be planted on rails immediately at distance away from place of danger as far as possible and attention of driver of approaching train shall be invited by whistling, waving the red flag vigorously, gesticulating and shouting.
(iii)	Action to be taken if more than one track is obstructed.
a)	In case of single line protection as above shall be done in both the directions from place of danger.
b)	In case of double line or multiple lines, if other tracks are also obstructed, the protection as above shall be done for other track also. The protection shall be done in that direction and on that track first on which train is likely to arrive first.
c)	The Contractor's Supervisors, Operators and lookout men shall be properly explained about the direction of trains on running tracks.
(iv)	Equipment required for protection of track. Minimum compliment of protection equipment i.e. 10 detonators, 4 red hand flags, 4 red hand lamps, 4 banner flags and whistles etc. shall always be kept ready at worksites for use in case of emergency. DFCCIL will arrange to provide detonators, whereas Contractor shall arrange other equipment at his own cost.
(v)	Arrangement of lookout men and competency required for lookout man to warn labour about approaching train.
a)	Contractor will provide lookout men
b)	The lookout men shall be properly trained in warning to staff at worksite about approaching train.
c)	Only those lookout men shall be provided at site who have been issued with a competency certificate by the DFCCIL's Supervisor.
d)	In case, it is felt necessary to provide lookout men by DFCCIL, the charges for the same as fixed by DFCCIL Administration shall be recovered from Contractor.
5.0	<u>TRAINING TO SUPERVISORS AND OPERATORS OF CONTRACTOR</u>
	The Supervisors and Operators of the contractor proposed to be deployed at wok site, which is close to the running track, shall be imparted mandatory training by the DFCCIL at site free of cost about the safety measures to be adopted while working in the vicinity of running track. Engineer-in charge of the work shall decide the scale, extent & adequacy of training. In case training is imparted at a recognized DFCCIL training institute, the charges for the same, as decided by DFCCIL, shall be recovered from contractor. A competency certificate to this effect to the individual Supervisor/ Operator shall be issued as given below by a DFCCIL Officer not below the rank of Project Manager. No Supervisor/Operator of the Contractor shall work or allowed to work in the vicinity of running track that is not in possession of valid competency certificate. All the labour, materials, tools, plants etc. except detonators, required for ensuring safe running of trains shall be provided by Contractor at his own cost. Wherever lookout men are provided by DFCCIL, charges at the rate of Rs. 500/- per man day shall be recovered from Contractor.
6.0	<u>SPECIAL CONDITIONS FOR WORKING OF ROAD CRANES</u>

	<p>To ensure safe working of road cranes used in works in connection with provision of ROB/RUB/Subways, following items shall invariable be ensured before putting the cranes to use:-</p> <ul style="list-style-type: none"> (i) No machine shall be selected to do any lifting on a specific job until its size and characteristics are considered against the weights, dimensions and lift radii of the heaviest and largest loads. (ii) The contractor shall ensure that a valid Certificate of Fitness is available before use of Road Cranes. SPECIAL CONDITIONS OF CONTRACT (GENERAL-TECHNICAL)

Name of Work: Maintenance of General power supply (E&M) for station building, IMD, IMSD, service buildings, staff quarters and any other buildings and electrical assets like DG sets, fire safety equipments, air conditioners etc. Between Madar - Iqbalgarh under CGM Ajmer unit for 02 years.

1. The brief scope of work covers "Maintenance of General power supply (E&M) for station building, IMD, IMSD, service buildings, staff quarters and any other buildings and electrical assets like DG sets, fire safety equipment's, air conditioners etc. Between Madar - Iqbalgarh under CGM AJMER unit.

The jurisdiction of work place is between Madar- Iqbalgarh section under CGM /DFCCIL/Ajmer. The work shall be executed under supervision of authorized representative of GM/EL/DFCCIL/AII. If required by DFCCIL, any other station/Site may be included under Schedule of work at same rates and no additional charges shall be given for this.

2. **Scheme of work:** - Within a period of 15 days beginning from the date of issue of Letter of Acceptance of Tender, the Contractor shall submit the detailed time schedule for execution of work and various documents enumerated in tender papers to the employer.
3. If the performance of the outsourced personnel is unsatisfactory, DFCCIL shall give a notice of 15 days to the Service Provider to take necessary action to improve the performance of outsourced personnel and the performance does not improve even after 15 days of such communication, the Service Provider shall provide additional list of eligible/ Suitable candidates for replacement to DFCCIL within 05 days' time failing which the remuneration for delayed period in respect of such person will be deducted from amount due to firm/ agency.
4. The Service provider shall provide the manpower with all necessary working tools at the Crossing stations and Junction stations of DFCCIL in Madar-Iqbalgarh section under Ajmer unit. The staff so provided shall also render services at any location in between block section or any other location, or any other office of DFCCIL in Madar-Iqbalgarh, as may be required by DFCCIL, at the agreed rates and terms & conditions.
5. The Service Provider shall make actual disbursement of salary to the out sourced person in various categories as agreed with DFCCIL. The copy of the payment scroll/ bank statement shall be submitted to DFCCIL with next bill as proof of such compliance.
6. Police verification for background check of outsource staff is required to be done by the agency and same should be submitted to DFCCIL.
7. **Inspection:** Quality of work carried out by the contractor is subject to periodical inspections by DFCCIL Railway Engineers of various levels as per the schedules laid down by DFCCIL. Any shortfall in the quality of work shall be subject to penalties / Recoveries as per prevailing conditions.

8. Deployment of Qualified Engineers at Work Sites by the Contractor:

- i. The Contractor shall also employ qualified Graduate Engineer(s) or equivalent, or qualified Diploma Engineer(s) as per GCC for this tender document.
- ii. In case the Contractor fails to employ the Engineer as mentioned in tender document, he shall be liable to pay liquidated damages at the rates, as prescribed in the tender documents

9. MODUS OPERANDI FOR ENGAGEMENT: -

- 9.1 The Service Provider shall provide the list of shortlisted eligible/ suitable candidates to DFCCIL. Screening of candidate will be carried out by DFCCIL for suitability of works as prescribed in Scope of Work and only suitable candidates will be allowed for deployment.
- 9.2 Working experience of persons must be of working in Government Organization/ Public sector undertaking (PSU)/ Autonomous body/Public Limited Company/Private Limited Company/Reputed Educational Institute/Commercial Institute/Partnership firms or Proprietorship firms who have executed the HT/LT installation works in Govt. organization/PSU/ Autonomous body/Public Limited Company.
- 9.3 In no way what so ever the relationship of employer and employee shall be established and entertained between the DFCCIL and the outsourced personnel engaged by the Service Provider. The Service Provider shall ensure that all persons employed by them shall be efficient, skilled, honest and conversant with the nature of work as required.
- 9.4 The Service Provider alone shall have the right to take disciplinary action against any person(s) engaged/employed by them; while no right whatsoever shall vest in any such person(s) to raise any dispute and/or claim whatsoever against the DFCCIL. The DFCCIL shall, under no circumstances be deemed or treated as the employer in respect of any person(s) engaged/employed by the Service Provider for any purpose whatsoever nor would the DFCCIL be liable for any claim(s) whatsoever of any person(s) of the Service Provider and Service Provider shall keep DFCCIL totally and completely indemnified against any such claim(s).
- 9.5 The Service Provider shall maintain all registers required under various Acts, which may be inspected by the DFCCIL as well as the appropriate authorities at any time.
- 9.6 The attendance rolls for the personnel deployed by the Service Provider at the premises of DFCCIL shall be provided by the Service Provider and it shall be monitored by the Service Provider. These attendance rolls shall be signed by the authorized representative of Service Provider who shall get it verified by the designated officer of DFCCIL.
- 9.7 Notwithstanding anything herein contained, the Service Provider will be liable to adequately compensate DFCCIL for any loss or damage occasioned by any act, omission or lapse on the part of the Service Provider or of any persons deployed by it pursuant to the Contract.
- 9.8 The Service Provider must also be able to arrange for the replacement of the existing outsourced person, as per the instructions of DFCCIL.
- 9.9 The engagement of outsourced person shall be purely on temporary basis. The Service Provider shall at all times make it absolutely clear to the outsourced personnel hired through them in DFCCIL that such deputed do not have any Claim whatsoever for any regular employment in DFCCIL. Any outsourced personnel deputed in DFCCIL can be removed any time by giving notice to the Service Provider and the staff in the circumstances provided herein above. The Service Provider will have to provide suitable replacement acceptable to DFCCIL within 05 days' time.

9.10 The Service Provider shall not terminate the services of hired staff unilaterally. In case any hired staff is proposed to be replaced/terminated by the Service Provider, such action should be taken only with the approval of DFCCIL.

9.11 The outsourced personnel should be in proper Uniform. with Name Badges. Service Provider will provide two sets of uniform per year to each staff which shall be reimbursed by DFCCIL as per rates specified.

10. Uniform:

Uniform to the outsourced manpower shall be provided by Service Provider and following reimbursement shall be done to the Service provider by DFCCIL: Additional amount for uniform for each Office Attendant / Field man for 2 Nos. of uniform per year shall be paid extra Rs. 1400/- per uniform and one winter coat/jacket/sweater Rs. 1200/- (as approved by DFCCIL).

11. Any change of Category of staff employed by successful bidder during the contract period shall be with prior approval of DFCCIL Engineer in-charge.

12. INSURANCE:

- i. Before commencing of works, it shall be obligatory for the contractor to obtain, at his own cost, insurance cover (Contractor All Risk - CAR policy) in the joint name of the Contractor and Employer from reputed companies under the following requirements:
- ii. Liability for death of or injury to any person/ employer's staff / animals or things or loss of or damage to any property / things / the work of other contractor (other than the work) arising out of the performance of the Contract.
- iii. Construction Plant, Machinery and equipment brought to site by the Contractor.
- iv. Any other insurance cover as may be required by the law of the land.
- v. The contractor shall provide evidence to the employer / Engineer before commencement of work at site that the insurances required under the contract have been effected and shall within 60 days of the commencement date, provide the insurance policies to the Employer/Engineer, the contractor shall, whenever, called upon, produce to the engineer or his representative the evidence of payment of premiums paid by him to ensure that the policies indeed continue to be in force.
- vi. The Contractor shall also obtain any additional insurance cover as per the requirements of the Contract.
- vii. The Employer/Engineer shall not be liable for or in respect of any damages or compensation payable to any workman or other person in the employment of the Contractor or his sub-contractor or petty contractor / other contractor working there. The Contractor shall indemnify and keep indemnified the Employer / Engineer against all such damages and compensation for which the contractor is liable.
- viii. The Policies of the contractor shall remain in force throughout the period of execution of the works and till the expiry of the defect liability period except for any specific insurance covers necessary for shorter period.
- ix. If the Contractor fails to effect or keep in force or provide adequate cover as acceptable to the engineer in the insurance policies mentioned above, then in such cases, the

engineer may effect and keep in force any such insurance or further insurance on behalf of the Contactor. The recovery shall be made at the rate of 1.5 times the premium/premiums paid by the engineer in this regard from the payment due to the Contractor or from the contractor's Performance security. However, the Contractor shall not be absolved from his responsibility and /or liability in this regard.

13. ELECTRICAL CONTRACTOR LICENSE:

Contractor must have valid Class-'A', Electrical Contractor License issued from appropriate government authority to execute mentioned works.

14. Time of start and completion:

The time allowed for execution of the works is 24 Twenty-Four Months from the date of issue of letter of acceptance from DFCCIL.

The contractor shall be expected to mobilize to the site of works and commence execution of the works within 15 (days) from issue of Acceptance Letter by DFCCIL.

The contractor shall be expected to complete all the work ordered on the contractor within 24 (Twenty-Four Months) from the date of issue of Acceptance Letter by DFCCIL.

If the contractor commits defaults in commencing execution of the works as aforesaid, DFCCIL shall without prejudice to any other right to remedy, be at liberty to forfeit fully the Earnest Money Deposit and performance guarantee of the contractor.

15. Progress of works:

The contractor shall submit a program of work in the form of a Bar Chart of all the activities in consistence. In case this bar chart requires to be modified, the Engineer and the contractor shall agree upon a time and progress chart. The chart shall be prepared in direct relation to the time stated as 24 months for the completion of the works as the milestone targets specified below of these special conditions. It shall indicate the forecast of the dates of commencement and completion of various activities of the work and may be amended as necessary by agreements between the Engineer and the contractor within the limitation of 24 (Twenty Four Months) as overall completion period.

16. PRICES AND PAYMENT:

16.1 SCHEDULE OF PRICES:

a) UNIT PRICES FOR MATERIALS:

The unit prices of materials as given in Schedule of quantities shall be inclusive of all charges including transport, loading/unloading handling all insurance premium, banker's charges, all Taxes, Duties and levies (including Octroi etc.) applicable on works contracts etc.

b) FOR ERECTION:

The unit prices given in Schedule of quantities shall include cost of erection, testing, commissioning and cover all cost of administration of the contract, insurance premium, bankers' charges for guarantees, cost of storage, loading, unloading and handling of materials, and for any road transport which the Contractor may use for carriage of materials between his depot and depot/s and site of work etc. Unit prices quoted shall be FIRM.

16.2 QUANTITIES:

The approximate estimated quantities of various items of works are included in Schedule of quantities and rates. However, quantities can be increased/ decreased as stipulated in Special Conditions of Contract.

16.3 NEW ITEMS OF WORK:

If during the execution of the work, the contractor is called upon to carry out any new item of work not included in Schedules, the contractor shall execute such works at such price as may be mutually agreed with the Purchaser before commencement after obtaining the competent authority's approval and sanction. The rates will be based on the Rly's LOA/rate analysis as per the current market / prevalent rates of such or similar items available with the DFCCIL/Railway Administration in that or nearby areas.

16.4 SUBMISSION OF BILLS:

On award of contract, a procedure order for submission of bills for payment shall be jointly drawn by finance and the purchaser. The contractor will be required to submit the bills as per the joint procedure order.

16.5 PAYMENT TERMS:(Except Sub head-1)

Payments for erection and commissioning included in schedule shall be made in stages as under: -

- (i) 80% of the item price (material cost) shall be paid on receipt of material in DFCCIL/Railway custody after inspection. If for any item of work, price of material and erection is not separately available, 80% of the cost of item of work will be considered as material cost.
- (ii) Further payment of material and erection cost to cover 90% of the cost of item of work shall be made on successful testing and commissioning of the installation.
- (iii) Balance 10% payment shall be released on issue of completion certificate by the Purchasers Engineer.

16.6 PAYMENT TERMS: - (For Sub Head 1 of Schedule)

- 16.6.1 The lump sum amount payable by DFCCIL to the Service Provider shall include the remuneration payable to the outsourced person besides the administrative charges payable to the Service Provider and applicable GST.
- 16.6.2 The consideration aforesaid will be paid by DFCCIL to the Service Provider, against monthly invoices raised at the end of each month, by the Service Provider in duplicate within 15 days.
- 16.6.3 The Service Provider shall make actual disbursement of salary to the outsourced person in various categories as per terms & conditions of bid.
- 16.6.4 The Service Provider will ensure that before raising the bill on DFCCIL for the service rendered by outsourced persons, the salary payable to outsourced person is paid on or before the 10th day of the following month and a proof of payment shall be annexed to the monthly bill.
- 16.6.5 In case the Service Provider fails to pay the outsourced person within the above time frame the rate of penalty shall be imposed on payment of Agency's monthly are as under: -
 - i) For payment to the outsourced person within 10th of the following month -Nil
 - ii) For payment to the outsourced person after 10th and up to 20th of the following month - 25% of the delayed payment or Rs. 2500/-whichever is higher.
 - iii) For payment to the outsourced person after 20th and up to 30th of the following month - 50% of the delayed payment or Rs.5000/- whichever is higher.

SCOPE OF WORK & EXPLANATORY NOTES

Detailed Scope of Work: -

The broad scope of work under this tender is as under : -

1. SUB HEAD – 1: Day to Day Running Operation :

This sub head of work is for supply of required manpower for day to day running operation and maintenance and repair of Electrical power supply system provided at 11 Nos Crossing/Junction stations and sections as per requirement of DFCCIL. The manpower will be used mainly at stations, traction installations (TSS,SP,SSP,ATS,PP) and non-traction installations in adjoining sections for operation, maintenance and breakdown/failure attention as required.

The jurisdiction of work place is between Madar- Iqbalgarh section under CGM /DFCCIL/Ajmer. The work shall be executed under supervision of authorized representative of GM/EL/DFCCIL/AII. If required by DFCCIL, any other station/Site may be included under Schedule of work at same rates and no additional charges shall be given for this.

Service Provider has to provide outsourced persons in various categories (As mentioned in schedule of offer) to carry out the following works.

The assets included in this operation and maintenance attention item, where the manpower supplied by the Contractor will be used, are broadly as under:

- i. 11KV incoming supply system from DISCOM GSS/DFCCIL receiving end ,as applicable to 11 KV/415 V transformers including 11 KV OH Line/UG cable, metering, protection equipments ,11 KV switchgears with panel etc
- ii. 11 KV/415 V, 03 phase transformers
- iii. 415 KV system installed at ESS which includes essential and non-essential panels, cabling, Fire extinguishers/Firefighting system and any other equipment at ESS buildings.
- iv. DG sets with panels, connection and cabling.
- v. Electrical General assets viz cabling & connections , masts, luminaries, fans, meters, exhaust fan , water cooler, desert cooler, switches, MCB/MCCB, LT panels, protection relays etc for street lighting, station buildings, IMD,IMSD & service buildings, circulation area in station area ,subways, FOB ,ROB/RUB, technical buildings, staff quarters, Pump house, High mast lights, HVAC /split A.C system, TSS & switching station lights in yards & buildings, sidings or any other asset of DFCCIL in section.
- vi. HT and LT panels with switchgears and APFC
- vii. Fire alarm System & Fire extinguishers installed at any building at stations and sections.
- viii. Emergency lighting equipments.

- ix. Pump houses with LT switchgears, pumping arrangements.
- x. Roof mounted Solar PV systems.
- xi. HV AC (VRV type) , split AC systems provided at stations/section.
- xii. UPS with batteries.
- xiii. Voltage stabilizers
- xiv. Non-traction SCADA system .
- xv. General lighting at ALH/TH/RUBs/ROBs in section.
- xvi. Indoor and outdoor earthing.
- xvii. Lightning protection system
- xviii. Any upcoming assets at every stations/ CGM office.

The routine preventive maintenance shall be as per E & M Manual for equipment maintenance issued by DFCCIL for WDFC (CTP 1 &2) and shall also comply with Indian Railway General Electrical Services Manual as applicable. The maintenance shall be complying to OEM's guidelines as applicable for particular equipment/system.

For specialized high tech maintenance items, separate AMCs have been awarded ,however, manpower under subject tender will used as support staff or for general maintenance of such equipments as required by DFCCIL . This shall be as per provision of AMC contract and at discretion of authorized DFCCIL Engineer.

The maintenance schedules to be followed are generally as under :

A. MAINTENANCE SCHEDULE FOR DISTRIBUTION TRANSFORMER (please refer Chaper II /para 2 of E&M manual)

Recommended Maintenance Schedule for Transformer of Capacities less than 1000 KVA (630 kVA 11/0.433 kV Transformer)

(i) Weekly Checks

- Check and record OTI and WTI readings .
- Check and record oil level in conservator tank.
- Check of any seepage of oil, abnormal sound , foreign material etc.
- Visually check earthing connection.

(ii) Monthly maintenance (Under power shutdown) :

- Repeat weekly schedule. Top up oil from fresh drum duly filtered if level found low.
- Check tightness of connections HT and LT side.
- Check tightness of earthing connection.
- Check and Clean bushings, top parts of TRF, radiators etc by cloth.
- Check and Clean the marshalling box by blower.
- Check condition of silica gel in dehydrating breather and replace/treat if required.

- Check that air passages are clear in Dehydrating breather & oil level in cup is OK.
- Clean switchyard and remove vegetation if any.
- Ensure proper locking arrangement of TRF valves and switch yard gate.
- Check for availability of caution boards.
- Check proper functioning of heater in marshalling box.

(iii) Half yearly maintenance (Under power shutdown) :

- Complete monthly maintenance as explained above .
- Check Cable boxes, gasketed joints, gauges, and general paintwork (Inspect for leaks & cracks etc.)
- Check IR value by 500 V/2.5 KV megger at LT/HT side . Insulation resistance is to be measured for 10sec. 60sec.and 600sec.for HV-LV, HV-E and LV-E. Calculate PI (Polarization index)
- Insulation resistance values should be compared with the last recorded value.
- Compare PI values with values at the time of commissioning/ last recorded. (PI Insulation/condition < 1.0 -Dangerous, < 1.1 Poor, <1.25-Questionable, 1.25 - 2.0-Satisfactory, >2.0Good
- If PI value is less than 1.1, oil should be filtered. In case the value does not improve even after filtrations, periodic overhauling should be under taken.
- Check BDV of TRF oil by BDV testing kit. Undertake filtration of oil if value found less than 40 KV .
- Check operation of all protection functions for alarms and trip i.e OTI, WTI, low oil, PRD operated, differential relay.
- Re-activate silica gel by heating or replace as required.
- Check ER values and paint them on pits by yellow background and black letters. Treat the soil ,if ER value is found more than 8.0 ohm.
- Open and clean HT and LT connection and retighten after applying conducting grease.Check for any heating mark/sparking and attend the same.

(iv) Yearly maintenance (Under power shutdown) :

- Repeat all Monthly and half yearly schedules.
- Carry out Yearly testing of Transformer oil as per IS 1866. (tests to be done -di-electric strength ,water content, , acidity and sludge, flash point, viscosity etc) and DGA testing .
- Check values of Earth resistance and take action to improve if found more than 8 ohm. Combined ER value shall be less than 2.0 ohm.
- Check and test Relay, alarms, and their circuits etc. (Examination relay and alarm contacts, their operation, fuses etc., Check relay accuracy.
- Check operation of Buckholz relay and PRD for correct operation.
- In addition to above, also to be checked Foundation of transformer,

Termination of HT/LT cable and visual inspection of transformer.

- Check for load balancing and adjust suitably in all 03 phases.
- Check neutral grounding for it's firm connection. Open the connection and refix after cleaning by emery cloth.
- Ensure neutral to earth voltage value < 5.0 Ohm.
- Check for correct relay setting at HV and LV sides of TRF.
- Carry out painting of TRF body and fencing for which paints, brushes etc shall be given by DFCCIL.

Note:

1. The silica gel may be reactivated by heating to 150-200°C.
2. Every time the oil is changed, oil seal should also be changed.
3. No work should be done on any transformer unless it is disconnected from all external circuits and the tank and all windings have been solidly earthed.

In case of anything abnormal occurring during service, maker's advice should be obtained giving him complete particulars regarding the nature and extent of occurrence, together with the nameplate particulars.

The Checking and maintenance against this item shall be carried out in line with Maintenance Manual/Approved drawings/Specifications of DFCCILs with its latest correction slips if any as per instruction of DFCCIL representative. Please refer E&M manual for maintenance and trouble shooting.

B. MAINTENANCE SCHEDULE FOR DIESEL GENERATOR SET (225 KVA, 200 KVA, 180 KVA, 160 KVA, 62.5 KVA & 30 KVA DG SET)

1. GENERAL CHECKS BEFORE STARTING THE ENGINE

- a) Check and correct the cooling water level.
- b) Check belt tensions.
- c) Clean radiator fins by blowing air from the opposite direction.
- d) Check lube oil level, top up if required with same brand and grade of oil.
- e) Check oil level of oil bath filter and clean air cleaner as required.
- f) Check clamping, tighten if required.
- g) Drain once 200ml. of diesel from bottom of fuel tank to remove sediments.
- h) Check and ensure sufficient quantity of fuel in tank.
- i) Check battery terminals and connections for proper tightness - top up electrolyte, if required
- j) Clean engine and premises.

2. A - CHECK MAINTENANCE OF DIESEL ENGINE

Proposal of Daily preventive maintenance -

Proposal of Weekly preventive maintenance -

- b) Fuel System- Drain sediments from fuel tanks.
- c) Air System - Check pre-cleanse dust pan weekly.
- d) Check air clearance restriction cleaner, change air cleaner element if required.
- e) Cooling System- Check coolant level.
- f) Other Maintenance- Drain air tank. Check and correct leaks. Drain fuel filter/Water separator daily. Check battery status and maintain properly.
- g) No load testing.

Daily monitoring and maintenance :

1. Check and record following status/parameters :
 - (i) Check and record energy consumption on daily basis.
 - (ii) Status of CBs of 11 KV and 440 V CBs.
 - (iii) Status of Spring Charging of CBs.
 - (iv) Status of battery provided for CB operation.
 - (v) Status of L/R Switch Position on C&R Panel
 - (vi) Details of any Protection relay Operated on day with timings.
 - (vii) Incoming voltage/outgoing and current .
 - (viii) Common trip circuit healthy
 - (ix) DC /AC Failure Indication
 - (x) Check all indication lamps, illumination lamp/ power socket etc for proper working .

Monthly maintenance :

- (i) Monthly Maintenance for proper opening / interlocking of panels, checking of fuse / MCB rating, check and ensure that L/R switch is at remote position.
- (ii) Panel shall be cleaned under shutdown by using air blower and all dust, dirt and webs etc shall be removed on monthly basis. Entries for insects etc shall be closed and naphthalene balls shall be placed to deter insects.

For detailed maintenance ,please refer E&M manual.

Half yearly maintenance :

- (i) Check and clean interior & external surface, Relay/Contractors with air blower.
- (ii) All control connections, Earthing connections wherever provided, inter panel coupling shall be checked for tightness .
- (iii) Also check Multi-core Cable Glands, Dressing of wiring, Check door bidding for dust proofing, check and ensure that relay healthy indication is glowing, check that all unused wires are insulated and secured..
- (iv) Check the tightness of bolt and nuts, Dust and foreign matter, Deformation excessive wear and damage, lost or missing parts of VCB. Take required action.
- (v) Check circuits and closing and tripping device.
- (vi) Replace damage Auxiliary switch.
- (vii) Check lubricant of bearing pins and shaft of closing and tripping portion. If necessary, use fresh lubricant.
- (viii) Check grease at main circuit breaker disconnects/contact finger. if necessary clean the contact and apply a thin film of new grease.
- (ix) Measure the Insulation resistance between the main circuit terminals. If Insulation resistance is low then clean the surface of vacuum interrupter with dry cloth and take measurement again (Insulation resistance should be more than 200 M ohm).
- (x) Check the condensation to ensure the specified insulating level in the Circuit Breaker (CB), if condensation is detected, clean the circuit-breaker.
- (xi) Check all protection (Like DMCR, WTI trip, O/C & E/F etc.) and communication connections as and when required.
- (xii) Check any damage to the paint, scratches and other damage regularly to avoid corrosion and repaint as required.
- (xiii) Check insulation resistance of multi-core cables.
- (xiv) Check wiring continuity, Armored connections and continuity to earth.
- (xv) Checking of Earthing of equipment, Doors, Panel to main grid and its continuity.
- (xvi) Checking of all internal equipment i.e. Space Heater/ Light/ MCB/ Door Switch/ Thermostat etc.
- (xvii) The Checking and maintenance against this item shall be carried out in line with Maintenance Manual/Approved drawings/Specifications of DFCCILs with its latest correction slips if any as per instruction of DFCCIL representative.

For detailed maintenance, trouble shooting and safety procedure ,please refer E&M manual.

D. MAINTENANCE OF CABLE AND END TERMINATION

Repairs of cables as and when required on discretion of Engineer in-charge involve replacement of a section of the defective cable by a length of new cable and insertion of two straight joints. All repairs and new joints in connection with repairs should be made in the same manner as joints on new cables. In some cases where the insulation has not been damaged severely, or where moisture has not obtained ingress into the insulation; it may only be necessary to install a joint at the point of cable failure.

In case of cable termination filled with liquid insulating compound, it is necessary to check periodically on discretion of Engineer in-charge the compound level in the termination boxes and to add compound if required.

All new cables should be tested for insulation resistance before jointing and after satisfactory results are obtained cable jointing and termination work should commence on discretion of Engineer in-charge.

Insulation resistance of 11 KV cables and LT cables shall be taken on half yearly basis and readings recorded. The IR value shall be compared with previous value. Continuity test of cables shall be taken on half yearly basis.

The Checking and maintenance against this item shall be carried out in line with Maintenance Manual/Approved drawings/Specifications of DFCCILs with its latest correction slips if any as per instruction of DFCCIL representative.

E. MAINTENANCE FOR FIRE EXTINGUISHER

Check periodically to ensure that they are ready to operate properly and safely and give reasonable assurance that the fire extinguisher is fully charged. Verify the same to Engineer in-charge that it is in its designated place, that it has not been actuated or tampered with, and that there is no obvious physical damage or condition to prevent its operation. Clean extinguisher to remove dirt, grease or foreign material. Check to make sure that the instruction nameplate is securely attached and legible. Inspect the cylinders for corrosion, abrasion, dents or weld damage.

Note: When cleaning, avoid use of solvents around the pressure gauge. They could seriously damage the plastic gauge face

1. Remove and check ring (safety) pin for freedom of movement. Replacement if bent or if removal appears difficult.
2. Visually inspect the pressure gauge :
 - a. If bent, damaged or improper gauge, depressurize and replace.
 - b. If pressure is low or high and temperature/pressure relationship has been ruled out
 - c. If pressure is low, check for leaks.
 - d. If over pressurized (overcharged), depressurize the extinguisher and follow recharge instructions.
3. Inspect discharge lever for any dirt or corrosion which might impair freedom of movement. Inspect carrying handle for proper installation. If lever, handle or rivets are damaged, replace them with proper part(s).
4. Check weight of extinguisher and compare to proper weight specified on extinguisher nameplate. If discrepancy is noted, remove nozzle or hose assembly and follow Complete Maintenance/Recharge Procedure for recharging.
5. Replace the extinguisher on the wall hanger making sure that it fits the bracket properly – replace the bracket if necessary.

The Checking and maintenance against this item shall be carried out in line with Maintenance Manual/Approved drawings/Specifications of DFCCILs with its latest correction slips if any as per instruction of DFCCIL representative.

The above checking shall be done periodically as instructed by DFCCIL Engineer.

F. Maintenance of internal & external wiring including street lighting - light fitting, fixtures, wiring, earthlings& switches and erection of the items as and when required or on discretion of Engineer in-charge at the mentioned locations. The Quantity is indicative and area / Building may be varied as per site condition.

Maintenance procedure:

Cleaning of the luminaire to be carried out periodically to optimize light output due to fumes, smoke and dust. Cleaning frequency depends on the environment in which the fixture operates and as per requirement on discretion of Engineer in-charge. Remove the main plug before cleaning in order to avoid electrical shock.

1. Use a soft cloth to wipe down the outside casing.
2. Do not use harsh liquids or chemicals for cleaning the diffuser. The diffuser can lose its transparency after reacting with the cleaning chemical.
3. Always be sure to dry all parts completely before plugging the unit back.
4. Always check broken wires, switches etc. in order to avoid damage to the luminaire as well as possible electric shock or fire.

The Checking and maintenance against this item shall be carried out in line with Maintenance Manual/Approved drawings/Specifications of DFCCILs with its latest correction slips if any as per instruction of DFCCIL representative.

G. AC Maintenance and air handling system

The Checking operation and routine maintenance against this item shall be carried out in line with Maintenance Manual/Approved drawings/Specifications of DFCCILs with its latest correction slips if any as per instruction of DFCCIL representative.

In this regards, please refer to E&M manual para 6.0 with annexures for split type and

VRV type (DAIKIN make) air conditioning system.

Separate AMC has been given for AC maintenance ,however staff under this contract may be used as support staff/General cleaning as per DFCCIL requirement at the desecration of DFCCIL Engineer.

H. OPERATION & MAINTENANCE OF SUBMERSIBLE PUMPS

1.0 Testing:

The operation and routine maintenance of submersible and other pumps and other following tests are to be conducted as and when required will be done as per direction & instruction of DFCCIL representative.

1.1 INSULATION TEST:

Connect one lead of a megger tester to the rising main and the other lead to the red core of the motor cable. A reading of 2 Mega ohms or more indicates that the motor winding, cable and cable joints are sound. If the reading is less than 2 Mega ohms, the fault is either in the wiring or the pump is locked by sand or other foreign substances.

1.2 DIRECTION OF ROTATION TEST:

Check the above-ground wiring against the wiring diagram. Test the operation of all the aboveground electrical equipment's, with the motor cable disconnected. If the operation of the equipment is normal, reconnect the motor cable, close the gate valve and reopen it three quarters of a turn only. Switch on the motor. If the overload release device trips or other fault occurs, it is an indication that cable connections are wrong or the pump is sand blocked. Try to reverse the direction of rotation for about three seconds only. If the pump still does not start, it must be raised to the surface to be cleared of obstruction.

If the pump is sand locked, recheck the level at which the pump suction is set. The pump suction and motor base must be in the solid casing (pump housing) and not opposite the well screen.

1.3 OPERATING HEAD TEST:

Close the gate valve at the surface completely. Check the pressure gauge reading, ammeter reading and the distance gauge from the center of the pressure gauge dial to the water level in the well. Compute the total head by adding the pressure gauge reading and the distance dial to the water level in the well.

The total head obtained should be approximately the same as expected.

1.4 AIR LOCKED TEST:

Close the gate valve at the surface completely. Check the pressure gauge and ammeter reading. Check the line voltage in all the phases while the pump is in operation. If the discharge from the pump is into an elevated reservoir or tank separate the pipe system at the ground level immediately after the gate valve at the ground surface, and check the meter current and discharge rate obtained at this point. A lower-than-normal reading of line current without any discharge at all will show the air locked pump. An increase in discharge and motor current will prove that the trouble is in the system beyond the gate valve and not in the pump or system below ground level.

1.5 LOW DISCHARGE TEST:

Close the gate valve at ground surface for a sufficient long time, to check the ammeter and pressure gauge reading. Check the water level in the well. Calculate the closed valve head developed by the pump. If this value is considerably less than the design total head, while the ammeter reading is higher than that specified by the manufacturer on the test sheet, the existence of following faults confirm.

Mechanical friction in pump or motor

1. Riser pipe developing a hole or leak developing in the system below the ground level.
2. The pump being worn by sand, there is an increase in mechanical friction.

1.6. PUMPING RATE TEST:

A. The test procedure to test whether the pumping rate greater than the rate of recuperation of well will include closing of the gate valve at the surface completely and then opening on turn only. If the trouble is corrected this proves that the pump discharge is too high for the yield of the well.

B. If the trouble persists; close the gate valve further, a small part of a turn at a time, until the trouble ceases. Leave the gate valve stem. Remove the gate valve handle to prevent authorized interference.

2.0 OPERATION OF SUBMERSIBLE PUMPS

Before operating the pump, the direction of rotation is checked. To ascertain the correct direction of rotation, let the motor run in both directions with the stop valve closed. The direction of rotation is changed by interchanging two of the phases. The pressure gauge will show different readings for the two directions. The direction which gives the higher pressure is correct one. When running freely, the correct direction of rotation can also be judged from the amount of water pumped.

2.1 STARTING AND INITIAL RUN:

The pump is started with sluice valve closed or slightly open. During the initial run, it is checked as to whether the pumped water is clear or muddy and whether any impurity is being pumped. If the water contains sandy or gritty particles or the impurities, care is taken not to stop pumping, otherwise the particles will settle inside the pump and on top of the non-return valve (if fitted), and may choke or seize the pump. The pump must be run with valve fully open (at not more than 40% discharge), until the sand content falls. The valve is then opened slowly to its full extent. Pumping is continued in this manner until it is possible to pump with a fully-open valve, without pumping excess sand. Generally, the permissible limit is up to 25 grains of sand per cubic meter of water (0.001percent, on volume basis, or 0.0025 per cent by weight). When the pumped water is clear, the pump may be stopped and restarted as required.

2.2 SHUT-DOWN PERIODS

The pump should not be allowed to remain stationary for more than 14 days at a stretch as, otherwise, lime, iron and other substances tend to settle in the bearings and impeller gaps and block the pump rotor. If operating conditions require the pump to remain stopped for a longer period, it should be started and allowed to run for at least 5 minutes once every 14 days and preferably once every 8 days. Only then the pump will be ready for instant resumption of service at anytime.

3.0 COMMON CAUSES OF BREAKDOWN OF SUBMERSIBLE PUMPS

The most common cause of breakdown of submersible pumps is the burning of motors. The following are the common causes of burning of the motor.

3.1 Uniform Burning of Motor Winding Due to Formation of Insulating Layer:

If the temperature of the winding exceeds the maximum allowable limit, it may result in the burning of the motor. This is generally caused by formation of an insulating layer around the motor surface, due to silt or grit gathered on the motor frame. The burning in this case is uniform. Whenever the motor is taken out, the surface should be cleaned and repainted before lowering.

3.2 BURNING OF MOTOR DUE TO OVERLOADING

A power overload occurs when the pump requires more power from the motor than the rated motor. Such a situation could lead to the overloading of winding, thus burning the motor. Power overloads can occur if the pump is run far away from the duty point specified on the pump and motor. In the field, such conditions normally happen if the assessment of total head to be developed by the pump is not made properly. To avoid this, the motor selected should have adequate output.

3.3 BURNING OF MOTOR DUE TO VOLTAGE FLUCTUATION

Submersible motors are designed to function without any problem, in the voltage range of $\pm 10\%$ of the rated voltage. When the voltage exceeds the limit, the output of the motor increases, leading to overheating and burning of the winding. It is always advisable to have a voltmeter and an ammeter fixed on the switchboard as near the motor as possible. Necessary action could then be taken, in case the variation in voltage is more than the permissible limit. It is safer to have a motor of horse power about 10 to 15 per cent more than the rated power for the pump, so that some overload can be sustained. In case of fluctuating voltage conditions, a 3 phase voltage stabilizer should be provided.

3.4 BURNING OF MOTOR DUE TO SINGLE PHASING

Single phasing of the motor is frequent in the field. In most cases, the missing of phase can also be due to malfunctioning of the switch gear. Inadequate capacity of fuses can also lead to this hazard. Further, single phasing can occur due to damage of the power cable. This can happen at the time of pump installation. Great care must be taken to avoid any damage or bending of the cable at the time of installation of the pump set.

It is recommended that economy should not be considered in the choice of switch gear for quality and capacity. It is always advisable to have a single-phasing presenter installed with the pump set.

3.5 BURNING OF MOTOR DUE TO EXCESSIVE NUMBER OF STARTS

The starting current of all motors is much higher than the current required for normal running. Consequently, if the number of times the pump is started is high and in quick succession, the winding will not have time to dissipate the heat developed in starting and will overheat. This will weaken the insulation and result in the winding burning. The permissible switching frequency depends on the motor horsepower. The maximum switching allowed is 20 times and 15 times an hour for motors up to 5 hp, and 7.5 to 100 hp, respectively. If the motor does not start to run and build up to full speed as soon as it is switched on, it must be switched off immediately and should not be started again until about 5 minutes have elapsed.

3.6 BURNING OF MOTORS DUE TO ELECTRICAL DISCHARGE

Electrical discharge can occur between winding and earth or between turns. The cause can be direct sparking or accidental jumping of current from one conductor to another. The contact between winding and earth, due to defect in insulation of the wire or puncture of the wire at the time of winding, could also cause the damage.

3.7 WRONG REPAIR AND REPLACEMENT

The spare parts used in the repair of motor, starter and pump may be improper quality and Capacity, which may cause burning of motor due to non-matching of characteristics. The parts replaced should be genuine, purchased from authorized dealers of reputed manufacturers.

In addition to burning of submersible motor, the following are the other causes responsible for Breakdown of submersible pumps:

a) Damage to motor and pump:

The submersible pump and motor until is aligned by manufacturer or in repair workshop. Rough handling in transportation and carriage to the site of installation may cause misalignment which will be noticed only after lowering of the unit. Misalignment may cause vibrations leading to damage to motor and pump parts, and overloading of motor resulting in the burning of the windings. The motor and pumps should be assembled and checked for free movement in the shop, and packed in wooden containers of six matching the equipment. The box should be carried carefully to the site and should be opened only at the time of lowering.

b) Heavy fine-Sand Pumping:

Submersible pump will provide long service life if the sand content of the water is limited to 28- 40 ppm. With sand pumping, the service life of the pump is reduced drastically. Sand in water damaged the rubbing surface of the neck ring and impeller and cause more clearance. Too high a clearance result in high vibrations which reduce the discharge and overload the motor. Vibrations disturb the motor alignment and ultimately burn the motor.

c) Loose and Electrical Column pipe:

A loosely bolted and non-rigid column pipe to which a submersible pump is attached can cause vibrations in the whole system. These vibrations will ultimately damage the pump due to misalignment and lead to the breaking of motor or its burning.

Flanges and other types of joints must be properly matched and tightened with an ordinary nut and a check nut. The pipe should be kept at the center of the housing

and on one side.

d) Fallen Pumps and Motors:

The falling down of pumps and motors is due to vibrations, and faulty repair, i.e. non-replacement of worn studs and water hammer. Fishing is easier with a fallen pump than a detached motor. For fishing the fallen motor, the manufacturer should be asked to provide a mechanical clamp from the bottom of the motor to the discharge nipple over the non-return valve, which can be attached to a wire rope. This wire rope should be brought up to the top of the well so that in case of an accidental fall, the motor can be easily pulled out. This will not only save the motor but well itself because, many a time, the well is abandoned because of the failure to fish out the motor.

e) Seizure of Pump or Motor Bearing

Seizure of the pump bearing can result when the pump runs dry. This can happen due to a fall in water level during summer or over pumping of the tube well. The pump can be safeguarded from dry running by installing a pneumatic water level indicator, observing it periodically and extending the column pipes to cater to situation of falling water, if required.

3.8 DO'S AND DONT'S FOR SUBMERSIBLE PUMP

DO's:

Do'

1. Do ensure that motor is filled with adequate quantity of clear, cold water before coupling to the pump.
2. Do ensure that no air is trapped while filling water in the motor.
3. Do avoid sharp bend to cable.
4. Do ensure that pump set never touches the bore well bottom.
5. Do ensure that the pump set is at least 3m above the mud accumulated in well.
6. Do ensure that in case of extreme urgencies, disassembly should be carried out only by trained mechanic with proper tools.

DON'T'S:

1. Do not fill distilled water in the pump.
2. Do not connect water filling plug to tap.
3. Do not run motor without water even for short time.
4. Do not pull power cable.
5. Do not use any gasket between pump and motor.

6. Do not tamper with important assembly setting like axial play of pump and motor.

7. Do not use vice to hold the motor, use 'V' shaped wooden hooks.

The Checking and maintenance against this item shall be carried out in line with Maintenance Manual/Approved drawings/Specifications of DFCCILs with its latest correction slips if any as per instruction of DFCCIL representative.

J. Maintenance of RO with water cooler

R.O. System 25 LPH output capacity - All in all repair & maintenance of Reverse Osmosis system including replacement of all components/parts e.g. Pump, Membrane, Filters, Power Supply, S.V., F.R., Housings, PVC connecting pipes, Water sensors, UV lamps and any other parts of Machine etc. as required. The job includes servicing of all the machines quarterly and also as and when required on receiving the complaints or as directed by Engineer in charge.

1. Daily check & operation of water cooler.
2. Cleaning of water tank once in a month.
3. Checking of water leakage from water cooler & if there is water leakage rectify the same.
4. Check & ensure proper working of water cooler daily.
5. Maintain record & submit to concern Engineer In charge.

The Checking and maintenance against this item shall be carried out in line with Maintenance Manual/Approved drawings/Specifications of DFCCILs with its latest correction slips if any as per instruction of DFCCIL representative.

Please refer OEM manual/Catalogue

K. Maintenance of Solar panels

Once a fortnight the surface of the panels should be wiped clean with wet rag to remove dust, fallen leaves & bird dropping etc. Only water to be used and no other cleaning agent for cleaning. In addition, maintenance of Secondary battery of Solar Panel is required on discretion of Engineer in-charge. Still general periodical maintenance of battery should be carried out. For efficient working of SPV system certain precautions are to be observed as given below.

1. Precautions and Preventive Steps Please ensure that:
 - a) SPV Modules are connected in parallel and SPV Panel output voltage is less than 25Volts under normal sunshine condition (for 12 V System/Module).
 - b) All connections are properly made tight and neat using the crimped Red (for +ve) and Black (for -ve) wires supplied by the manufacturer in order to avoid reverse connection.
 - c) The rating of the fuse in the charge controller is not changed.
 - c) The SPV Panel is installed facing SOUTH and with the correct 'Angle of tilt'.
 - d) There is no shadow on any part of the SPV Panel at any time of the day, to

- get maximum power.
- e) SPV Modules are protected against any act of vandalism and accidental strike or hit by heavy objects, like stone, hammer etc. If the SPV Panel is installed on ground, it must be fenced properly to protect it from cattle and to prevent from any damage/theft. Fencing should be made in such a way that no shadow should fall on SPV Panel at any time of the day.
 - f) Battery Bank is placed on a rack or platform insulated from ground and located in a well-ventilated room and also sufficient clearance is there over the battery.
 - g) First the Battery Bank, then SPV Panel and then Load is connected to SPV Charge Control Unit and for disconnection reverse sequence is adopted.
 - h) Battery terminals are never shorted even momentarily as shorting will result in heavy spark and fire. (To avoid the same, connect the cable at Charge Controller end 'First' and then Battery end.)
 - i) Never connect the Load directly to the SPV Panel as SPV Panel may give higher/lower voltage than required by the Load Equipment and hence the equipment may be damaged permanently.
 - j) Blocking diode is provided at the array output for protection against reverse polarity.
 - k) Make sure that the Solar PV module gets direct sunlight throughout the day where you install it.
 - l) The Green indicator on Charge controller is only an indication for charging. It will glow even at small amount of charging. So to ensure efficient charging, the availability of direct sunlight over the Solar PV module for the maximum hours of the day should be ensured.
 - m) It is not heat but light that produces energy. So let direct sunlight to fall on the module surface without shades.
 - n) The staff shall maintain a register to maintain record of Solar energy generated on daily basis and net metering data as decided by DFCCIL.
 - o) Staff may be used for maintenance of any future Solar installations as required by DFCCIL.

The Checking and maintenance against this item shall be carried out in line with Maintenance Manual/Approved drawings/Specifications of DFCCILs with its latest correction slips if any as per instruction of DFCCIL representative.

L. Fire alarm system

This section covers the General inspection, testing and maintenance schedule for Fire Alarm system installed at stations, sections as required by DFCCIL Engineer . For details refer Annexure 8 of E& M manual.

M. Outdoor Earthing and Bonding [Conventional & Maintenance free earthing]:

The staff shall carry out necessary maintenance works viz measurement of ER value, painting of the same , General cleaning of pits, cleaning of connection by emery paper/application of conducting grease, treatment of earth station as required. The work shall be carried out periodically as per directive of DFCCIL Engineer.

N. Lightning protection system:

The staff shall check lightning protection system i.e. on roof and underground flats, spikes etc for correct connection . Any broken/damaged connection shall be repaired immediately.

O. NTPS SCADA :

Staff may be used for general testing and upkeep of system. Staff shall check on daily basis for proper functioning of system. They must see the problems /alarms detected on OWS (Operator Work station) Monitor installed at panel room and take suitable action to remedy same. They must check and protect OFC cable laid for communication.

P. Maintenance of other E&M items:

In addition to above listed items, any other E&M Electrical items required for maintenance as and when required or on discretion of Engineer in-charge at the mentioned locations.

Explanatory notes for various items of work are mentioned below. This shall be read in conjunction with latest standards/Guidelines /Rules/Instructions/ Codes/ Technical specification issued by DFCCIL/RDSO/ Railway Board/ CORE/Zonal Railway/RVNL/Other statutory body like BIS, CPWD, Electricity act 2003, CEA rules/regulations/safety measures, CERC rules, National Grid Code/MNRE etc.

Item-01: Providing services for day to day running operation, routine maintenance & Preventive maintenance of pump sets, DG Sets, all electrical installations such as light points, fans points, exhaust fan points, call bell points, light/ power plug points, all electrical fittings & fixtures i/c Sub- Station with associated accessories and equipment's, HT/LT panels , Transformers ,control panel, EDBs/ SDBs, feeder pillar, compound lights, High mast lights,RORO/RIRO lights,station yard /siding lights, charging points ,Solar PV system,UPS ,stabilizers, UG cables, NTPS SCADA, Air handling units, Split AC/VRV type AC,Fire alarm system , Fire Extinguishers , repairing of defective parts of above installation and cleaning, oiling greasing i/c rectification of faults i/c connections, interconnections i/c carrying out preventive maintenance i.e. insulation test, earth test, polarity tests, checking and filling of distilled water etc. of complete installation and keeping the all installation neat and clean always and maintaining all relevant log books for each system etc. as reqd. on all working days i/c Sunday & Holidays by providing following minimum multi disciplined E&M staff /workman as per duty chart prepared by site incharge and as per terms & conditions. (1 nos highly skilled +1 nos skilled +2 nos semi-skilled + 2 nos Unskilled) persons with weekly rest required at each station in as per required shifts of eight hours) (Availability of staff as requirement is for 24x7 hour).

Eligibility Condition for various categories of Workmen

1. **E&M Maintenance Party** with all necessary working tools for attending maintenance work -
 - a) Highly skilled / overall in-charge for supervising in day shift at every station for different E&M activities should be diploma in electrical with one year experience in similar field.
 - b) Skilled Person for executing different E&M should be ITI in electrical trade with one year experience in similar field.
 - c) Semi-Skilled Person for executing different E&M activities should be Tenth passed with one year experience in similar field.
 - d) Unskilled Person for executing different E&M activities should be Eighth passed.
2. A skilled person and semi-skilled person who have requisite knowledge of execution/maintenance of any electrical work related to HT/LT installation for executing different E&M activities.

Note:

- A) Besides the categories mentioned above, DFCCIL may asked the Service Provider to provide other categories of staff also on hiring basis. The essential

qualifications/pay structure for such categories shall be decided by mutual agreement and the services will be provided at the agreed commission.

- B) Police verification for background check of outsource staff is required to be done by the agency and same should be submitted to DFCCIL.

SUB HEAD-2: Providing of Material

During maintenance contract , there may be need to supply of various electrical accessories/items suitable for existing different type of fittings/switch box,cables, lugs, terminal blocks, contactors,MCB/MCCB etc. The contractor shall supply such items in required quantity as per directive of DFCCIL Engineer at specific location as and when need arises . Labour is already taken in SUBHEAD -1 or SUBHEAD -3 as required for these Materials.

The rates payable for supply of items under this subhead will be as given in this sub head.

The Contractor shall promptly supply required item and quantity as and when summoned by DFCCIL

The supplied material shall confirm to relevant IS/IEC/DFCCIL specification and shall be of DFCCIL approved make.

SUB HEAD - 3- Any item of CPWD Delhi Schedule of rates (E&M-2022) as per requirement of DFCCIL

During maintenance contract , there may be need to operate any item as per CPWD DELHI SCHEDULE OF RATES (E & M) 2022 .The contractor shall execute such items in required quantity as per directive of DFCCIL Engineer at specific location as and when need arises .

The rates payable for such items under this subhead will be as given CPWD DELHI SCHEDULE OF RATES (E & M) 2022

The Contractor shall promptly execute such items in required quantity as and when summoned by DFCCIL

The executed work shall confirm to relevant CPWD specification .

The payable rates considered for this head will be 8.9 % below of the Base rate of CPWD DELHI SCHEDULE OF RATES (E & M) 2022 and same to taken care by the Contractor before quoting this Head.

Work should be executed as per CPWD latest specifications.

SUB HEAD - 4 Fire Extinguisher:

The Contractor shall arrange to check each fire extinguishers unit periodically as instructed by DFCCIL to ensure that they are ready to operate properly and safely and give reasonable assurance in a form of certificate that the fire extinguisher is fully charged & fit for use for next one year from date of testing . Contractor shall arrange to verify the same to Engineer in-charge of DFCCIL that it is in its designated place,

that it has not been actuated or tampered with, and that there is no obvious physical damage or condition to prevent its operation. Clean extinguisher to remove dirt, grease or foreign material. Check to make sure that the instruction nameplate is securely attached and legible. Inspect the cylinders for corrosion, abrasion, dents or weld damage.

Note: When cleaning, avoid use of solvents around the pressure gauge. They could seriously damage the plastic gauge face.

1. Remove and check ring (safety) pin for freedom of movement. Replacement if bent or if removal appears difficult.
2. Visually inspect the pressure gauge:
 - a. If bent, damaged or improper gauge, depressurize and replace.
 - b. If pressure is low or high and temperature/pressure relationship has been ruled out
 - c. If pressure is low, check for leaks.
 - d. If over pressurized (overcharged), depressurize the extinguisher and follow recharge instructions.
3. Inspect discharge lever for any dirt or corrosion which might impair freedom of movement.
4. Inspect carrying handle for proper installation. If lever, handle or rivets are damaged, replace with proper part(s).
5. Check weight of extinguisher and compare to proper weight specified on extinguisher name plate. If discrepancy is noted, remove nozzle or hose assembly and follow Complete Maintenance/Recharge Procedure for recharging.
6. Replace the extinguisher on the wall hanger making sure that it fits the bracket properly – replace the bracket if necessary.
7. Paint the fire extinguishers body as required during extension of validity.

The Checking and maintenance against this item shall be carried out in line with Maintenance Manual/Approved drawings/Specifications of DFCCILs with its latest correction slips if any as per instruction of DFCCIL representative or OEM guidelines.

The activities as mentioned above shall be carried by Staff supplied by contractor under item No -01 above through expert and authorized agency for fire safety. For normal periodic checking, which does not require refilling/repair & not due for inspection, no rates would be payable under this subhead.

This item under this subhead shall be operated and paid in respect of each fire extinguisher in the event of :

- i. Date of validity to keep in service is expired or nearing expiry.
- ii. Extinguisher has been used or gas leaked or other damage forcing it out of service and require refilling/repair.

In case of date of validity nearing expiry/expired and refilling needed or Refilling is required due to any other reason/other damage forcing it out of service , same shall be got done by the contractor staff from any reputed and authorized agency near to place of keeping fire extinguishers. The refilling/repair dates shall be painted on FE body and also sticker shall be provided by authorized agency. Transportation cost of fire extinguishers from site to agency and back shall be born by Contractor.

SUB HEAD -5 Pump House Maintenance

Under this subhead, specific item of works of repair , Supply, erection, testing & commissioning, other activity, only supply of items related to pumping system have been kept. Contractor may be summoned to carry out any item of this subhead at rates given in this subhead at any location by authorized DFCCIL Engineer. The contractor shall carry out that particular work including supply of materials, required staff, T&P/M&P as required as per site condition. The Contractor shall be responsible for successful repair/replacement/ commissioning as required. The items supplied shall be confirming to relevant IS/IEC/DFCCIL specification. The works carried out under this schedule shall be guaranteed against any failure due to bad workmanship or poor quality of material for a period of 06 Months.

SUB HEAD - 6 -STREET LIGHT/ HIGH MAST LIGHT/ INDOOR LIGHT-
Work shall be executed as per Direction of Engineer In-charge.

Under this subhead, specific item of works of Supply, installation , testing & commissioning, other activity, only supply of items related to street light/high mast light/indoor/outdoor lighting system have been kept. Contractor may be summoned to supply/install any item of this subhead at rates given in this subhead at any location by authorized DFCCIL Engineer. The contractor shall carry out that particular work including supply of materials, required staff, T&P/M&P as required as per site condition. The Contractor shall be responsible for successful repair/replacement/ commissioning as required. The works carried out under this schedule shall be guaranteed against any failure due to bad workmanship or poor quality of material for a period of 06 Months. The items supplied shall be confirming to relevant IS/IEC/DFCCIL specification.

SUB HEAD - 7 - DG SET Maintenance

All the items under this schedule shall be carried out by engaging **OEM i.e. CUMMINS INDIA PRIVATE LIMITED (Cummins Diesel Sales and Service private Limited) or his authorized dealer only**. All materials,T&P and manpower shall be provided of M/S Cummins or his authorized dealer.

Item wise explanatory note and scope of work is as under:-

1. Quarterly visit: -

- a. Service engineer will carry scheduled preventative maintenance checks on Diesel
- b. Generating Set on bi monthly basis.
- c. Service engineer will check the DG set thoroughly and will submit the observation report along with his necessary recommendation and suggestions for improvement in performance of DG set
- d. Check coolant level in radiator. If required top up.
- e. Check belt tension.
- f. Clean breather on fuel tank.
- g. Check all joints of fuel line are tightened.
- h. Check sealing's of air filter element.

- n. Service Engineer will submit the list of recommended parts / sub-assemblies for respective DG set.
- o. Service engineer will give training to customer's representative on site for Operation and Maintenance of DG sets.

2. B-Check charges without coolant and Radiwash of each engine:-

The "B" Check will be carry out at every 475-500 hours of operation of an Engine or 12 Months, whichever is earlier or as per latest available OEM recommendations. The works to be done in "B" check shall include following activities: -

- a. All The activities covered in Quarterly visit.
- b. Change Lube oil.
- c. Change lube oil filter.
- d. Change fuel filter and fuel water separator.
- e. Replacement of air filter.
- f. Replacement of engine lube oil.

3. B-Check charges with coolant and Radiwash of each engine: -

The "B" Check will be carry out at every 475-500 hours of operation of an Engine or 12 Months, whichever is earlier or as per latest available OEM recommendations. In the schedule all the "B" check activities and flushing of cooling system by Radiwash and Replacement of complete coolant of engine will be included. Works to be done in this check shall include following activities:-

- a. All the activities covered in Quarterly visit.
- b. Carry out all jobs of B check.
- c. Flushing of cooling system by Radiwash.
- d. Replacement of complete coolant of engine.

Note:

- 1. It is mentioned that "B" check under item no 01 & 02 shall be done in alternate years i.e. where 'B' check under item no. 01 is done after 475-500 hours of operations or 12 months (whichever is earlier) in first year, 'B' check under item no. 02 shall be done after next 475-500 hours of operations or 12 months (whichever is earlier) i.e. in 2nd year and vice-versa.**
- 2. The 'B' check shall guarantee for trouble free service for DG set for 06 months in normal working conditions**

4. The breakdown visits charges: -

In case of any breakdown/outage of diesel engine of any station, DFCCIL will call upon the contractor to deploy its expert staff with necessary tools/tackles and parts needed for rectification of failure.

The cost shall include all expenses including manpower, material, tools & tackles for rectification of fault to bring the diesel engine in good working order.

The contractor shall attend the site of breakdown/failure within 12 hours of reporting failure. The failure intimation may be given by DFCCIL staff not below DPM/Electrical through e-mail, phone call or message etc.

A Joint note will be prepared after inspection of failed Diesel Engine with DFCCIL clearly bringing out detailed reasons of failures and repair planning. In case any item is needed which is not covered in this contract, same will be provided by contractor at agreed rates/cost for which payment will be made by DFCCIL separately. The rates of CDSSL items shall be as per prevailing rates of CDSSL.

The cost shall include transportation, logistics etc. for transporting manpower & T&P/material from contractor's premises to work site at any of DFCCIL station.

In case contractor fails to attained the breakdown site within 12 hours a penalty of Rs. 1000 per day will be charged.

5. Supply of Battery, Pulse Lite 12V 65AH: -

Under this item, battery should be supplied, erected and commissioned at specific location as and when demanded by DFCCIL.

It is anticipated that batteries shall be in good order with required maintenance attention under this contract & also by DFCCIL under guidance of contractor.

In case of any additional part requirement apart from B check and Radiwash with Coolant (list mentioned in this offer), then the same shall be supplied under the provision of lump sum amount of Rs five lacs and will be charged as per the OEM current applicable price list prevailing at that time with applicable GST.

The confirmation of parts supply will be given by DFCCIL against the quote submission by OEM.

SUB HEAD – 8- ELECTRICAL SUB STATION (ESS): Work shall be executed as per Direction of Engineer In-charge and as per OEM recommendations.

Under this subhead, specific item of works of repair , Supply, erection, testing & commissioning, other activity, only supply of items related to 11 KV/440 Volt Electrical sub station (ESS) have

been kept. Contractor may be summoned to carry out any item of this subhead at rates given in this subhead at any location by authorized DFCCIL Engineer. The contractor shall carry out that particular work including supply of materials, required staff, T&P/M&P as required as per site condition. The Contractor shall be responsible for successful repair/replacement/commissioning as required. Items shall be supplied from OEM with model No as given for specific item.

The works carried out under this schedule shall be guaranteed against any failure due to bad workmanship or poor quality of material for a period of 06 Months.

SUB HEAD - 9 - ADDITIONAL MISCELLANOUS ITEMS- Work shall be executed as per Direction of Engineer In-charge.

Under this subhead, special item of repair, Supply, erection, testing & commissioning, other activity, only supply of items related to Non traction Electrical power supply system have been kept. Contractor may be summoned to carry out any item of this subhead at rates given in this subhead at any location by authorized DFCCIL Engineer. The contractor shall carry out that particular work including supply of materials, required staff, T&P/M&P as required as per site condition. The Contractor shall be responsible for successful repair/replacement/commissioning as required. Items shall be supplied from OEM with model No as given for specific item.

The works carried out under this schedule shall be guaranteed against any failure due to bad workmanship or poor quality of material for a period of 06 Months.

The items supplied shall be confirming to relevant IS/IEC/DFCCIL specification.

This pre-bid pre-contract Agreement (herein after called the Integrity Pact) is made on-----day of the month of-----, between, on one hand, the DFCCIL acting through Shri ----- Designation of the officer, (hereinafter called the CLIENT, which expression shall mean and include, unless the context otherwise requires, his successors in office and assigns) of the First Part and M/s-----represented by Shri-----Chief Executive Officer (hereinafter called the "BIDDER/SELLER" which expression shall mean and include, unless the context otherwise requires, his successors and permitted assigns) of the Second part.

WHEREAS the CLIENT proposes to procure (Name of the Stores/Equipment/Item, Name of the Consultancy Service, Name of Works Contract, Name of Services) and the BIDDER is willing to Offer/has offered for stores or works.

WHEREAS the BIDDER is a private company/ public company/ Government undertaking/ partnership/ registered export agency, constituted in accordance with the relevant law in the matter and the CLIENT is a PSU performing its functions or behalf of the President of India.

NOW, THEREFOR,

To avoid all forms of corruption by following a system that is fair, transparent and free from any influence/prejudiced dealings prior to, during and subsequent to the currency of the contract to be entered into with a view to:-

Enabling the CLIENT to obtain the desired said (Name of the Stores/Equipment/Item, Name of the Consultancy Service, Name of Works Contract, Name of Services) at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement, and

Enabling BIDDERS to abstain from bribing or indulging in any corrupt practice in order to secure Contract by providing assurance to them that their competitors will also abstain from bribing and other corrupt practices and the CLIENT will commit to prevent corruption, in any form, by its Officials by following transparent procedures.

The parties hereto hereby agree to enter into this Integrity Pact and agree as follows:

Commitments of the CLIENT

- 1.0 The CLIENT undertakes that no official of the CLIENT, connected directly or indirectly with the Contract, will demand, take a promise for or accept, directly or through intermediaries, any bribe, consideration, gift, reward, favour or any material or immaterial benefit or any other advantage from the BIDDER either for themselves or for any person, organization or third party related to the Contract, in exchange for an advantage in the bidding process, bid evaluation, contracting or implementation process related to the Contract.
- 1.1 The CLIENT will, during the pre-contract stage, treat all BIDDERS alike, and will

provide to all BIDDERS the same information and will not provide any such information to any particular BIDDER which could afford an advantage to that particular BIDDER in comparison to other BIDDERS.

- 1.2 All the officials of the CLIENT will report to the appropriate Government office any attempted or completed breaches of the above commitments as well as any substantial suspicion of such breach.
2. In case any such preceding misconduct on the part of such official(s) is reported by the BIDDER to the CLIENT with full, and verifiable facts and the same is prima facie found to be correct by the CLIENT, necessary disciplinary proceedings, or any other action as deemed fit, including criminal proceedings may be initiated by the CLIENT and such a person shall be debarred from further dealings related to the Contract process. In such a case while an enquiry is being conducted by the CLIENT the proceedings under the Contract would not be stalled.

Commitments of BIDDERS

3. The BIDDER commits itself to take all measures necessary to prevent corrupt practices, unfair means and illegal activities during any stage of its bid or during any pre-contract or post- contract stage) in order to secure the Contract or in furtherance to secure it and in particular commit itself to the following:-
 - 3.1 The BIDDER will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission fees, brokerage or inducement to any official of the CLIENT, connected directly or indirectly with the bidding process, or to any person, organization or third party related to the (B) in exchange for any advantage in the bidding, evaluation, contracting and implementation of the Contract.
 - 3.2 The BIDDER further undertakes that it has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favour, any Material or immaterial benefit or other advantage, commission, fees, brokerage or inducement to any official of the CLIENT or otherwise in procuring the Contract or forbearing to do or having done any act in relation to the obtaining or execution of the Contractor any other Contract with the Government for showing or for bearing to show favour or disfavour to any person in relation to the Contract or any other Contract with the Government.
 - 3.3 *BIDDER shall disclose the name and address of agents and representatives and Indian BIDDER shall disclose their foreign principals or associates.
 - 3.4 * BIDDER shall disclose the payments to be made by them to agents/brokers or any other intermediary, in connection with this bid/contract.
 - 3.5 The BIDDER further confirms and declares to the CLIENT that the BIDDER is the original manufacturer/ integrator/ authorized government sponsored export entity of the defense stores and has not engaged any individual or firm or company whether Indian or foreign to intercede, facilitate or in any way to recommend to the CLIENT or any of its functionaries, whether officially or unofficially to the award of the Contract to the BIDDER nor has any amount been paid, promised or intended to be paid to any such individual, firm or company in respect of any such intercession, facilitation or recommendation.
 - 3.6 The BIDDER either while presenting the bid or during pre-contract negotiations or

before signing the Contract shall disclose any payments he has made, is committed to or intends to make to officials of the CLIENT or their family members, agents, brokers or any other intermediaries in connection with the Contract and the details of services agreed upon for such payments.

- 3.7 The BIDDER will not collude with other parties interested in the Contract to impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the Contract.
- 3.8 The BIDDER will not accept any advantage in exchange for any corrupt practice, unfair means and illegal activities.
- 3.9 The BIDDER shall not use improperly, for purposes of competition or personal gain, or pass on to others, any information provided by the CLIENT as part of the business relationship, regarding plans, technical proposals and business details, including information contained in any electronic data carrier. The BIDDER also undertakes to exercise due and adequate care lest any such information is divulged.
- 3.10 The BIDDER commits to refrain from giving any complaint directly or through any other manner without supporting it with full and verifiable facts.
- 3.11 The BIDDER shall not instigate or cause to instigate any third person to commit any of the actions mentioned above.
- 3.12 If the, BIDDER or any employee of the BIDDER or any person acting on behalf of the BIDDER, either directly or Indirectly, is a relative of any of the officers of the CLIENT, or alternatively, if any relative of an officer of the CLIENT has financial Interest/stake in the Bidder's firm, the same shall be disclosed by the BIDDER at the time of filling of tender.
The term 'relative' for this purpose would be as defined in section 6 of the companies' act 1956.
- 3.13 The BIDDER shall not lend to or borrow any money from or enter into any monetary dealing so transactions, directly or indirectly, with any employee of the CLIENT.

4. Previous Transaction

- 4.1 The BIDDER declares that no previous transgression occurred in the last three years immediately before signing of this integrity Pact, with any other company in any country in respect of any corrupt practices envisaged hereunder or with any public sector enterprise in India or any Government department in India that could justify BIDDER's from the tender process.
- 4.2 The BIDDER agrees that if it makes incorrect statement on this subject, BIDDER can be disqualified from the tender process or the contract, if already awarded, can be terminated for such reason.

5. Earnest Money (Security Deposit)

- 5.1 While submitting commercial bid, the BIDDER shall deposit an amount (to be specified in RFP) as Earnest Money/Security Deposit, with the CLIENT through any of the following instruments:-

- i. Bank draft or a pay order in favour of_____.
 - ii. A confirmed guarantee by an Indian nationalized bank, promising payment of the guaranteed sum to the CLIENT on demand within three working days without any demur whatsoever and without seeking any reasons whatsoever. The demand for payment by the CLIENT shall be treated as conclusive proof or payment.
 - iii. Any other mode or through any other instrument (to be specified in the RFP).
- 5.2 The earnest money/Security deposit shall be valid up to a period of five years or the contractual obligations to the complete satisfaction of both the BIDDER and the CLIENT, including warranty period, whichever is later.
- 5.3 In case of the successful BIDDER a clause would also be incorporated in the article pertaining to performance Guarantee in the Contract that the provisions of sanctions for violation shall be applicable for forfeiture of performance bond in case of a decision by client to forfeit the same without assigning any reason for imposing sanction for violation of this pact.
- 5.4 No interest shall be payable by CLIENT to the BIDDER on earnest Money/Security Deposit for the period of its currency.
6. Sanctions for Violations
- 6.1 Any breach of the aforesaid provisions by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER shall entitle the CLIENT to take all or any one of the following actions, wherever required:-
- (i) To immediately call off the pre-contract negotiations without assigning any reason or giving any compensation to the [A]. However, the proceedings with the other BIDDER(s) would continue.
 - (ii) The earnest money deposit (in pre-contract stage) and/or security Deposit/performance Bond (after the Contract is signed) shall stand forfeited fully and the CLIENT shall not be required to assign any reason therefore.
 - (iii) To immediately cancel the Contract, if already signed, without giving any compensation to the[A].
 - (iv) To recover all sums already paid by the CLIENT, and in case of an Indian [A] with interest thereon at 2% higher than the prevailing prime lending rate of state bank of India, while in case of a BIDDER from the country other than India with interest thereon at 2% higher than the LIBOR. If any outstanding payment is due to BIDDER from the CLIENT in connection with any other Contract, such outstanding payment could also be utilized to recover the aforesaid sum and interest.

6.2 The decision of the CLIENT to the effect that a breach of the provisions of this pact has been committed by the BIDDER shall be final and conclusive on the [A]. However, the BIDDER can approach the Independent Monitor(s) appointed for the purposes of this Pact.

7. Fall Clause

7.1 The BIDDER undertakes that it has not supplied/is not supplying similar product/systems or subsystems at a price lower than that offered in the present bid in respect of any other Ministry/Department of the Government of India or PSU and if it is found at any stage that similar product/system or subsystems way supplied by BIDDER to any other Ministry/Department of the Government of India or a PSU at a lower price, then that very price, with due allowance for elapsed time, will be applicable to the present case and the difference in the cost would be refunded by the BIDDER to the CLIENT, if the Contract has already been concluded.

8. Independent Monitors

8.1 The CLIENT has appointed Independent Monitors (hereinafter referred to as Monitors) for this pact in consultant with the central vigilance commission (Names and addresses of the Monitors to be given)

8.2 The task of the Monitors shall be to review independently and objectively, whether and to what extent the parties comply with the obligations under this pact.

8.3 The monitors shall not be subject to instructions by the representatives of the parties and perform their functions neutrally and independently.

8.4 Both the parties accept that the Monitors have the right to access all the documents relating to the project/procurement, including minutes of meetings.

8.5 As soon as the Monitor notices, or has reason to believe, a violation of this Pact,

- he will so inform the Authority designated by the CLIENT
- 8.6 The BIDDER(s) accepts that the Monitor has the right to access without restriction to all Project documentation of the CLIENT including that provided by the BIDOER. The BIDDER will also grant the Monitor, upon his request and demonstration of a valid Interest, unrestricted and unconditional access to his project documentation.
