

Addendum/Corrigendum No.1 dated 17.09.2014

The following Addendums/Corrigendum are incorporated in the tender for hiring of vehicles with the name “Empanelment of Transporters/Taxi Operator/Firms for hiring of vehicles for DFCCIL”.

- I. The last date for sale of tender form has been extended upto 1300 hrs on 07.10.14;
- II. The last date of receipt of bids has been extended upto 1500 hrs on 07.10.14;
- III. The date and time of opening of bids has been extended upto 1530 hrs on 07.10.14.
- IV. The following para is added to Special Conditions of Contract (Section-4)
11. In case of vehicles hired on a monthly basis are used for a part of the month, the prescribed monthly limit of 2200 kms/312 hrs shall be proportionately reduced for the purpose of payment to the contractor.
- V. The para no.4 (iv) {Eligibility Criteria to be fulfilled by the Bidders} of Instructions to the Bidders (Section-1) should be read as:-

“The bidder should have received payment against satisfactory execution of completed and ongoing works of all types during last three financial years i.e. current year and preceding 03 years as per current ITCC/audited balance sheet of not less than 150% of the advertised estimated cost of work for the segment(s). In case, a bidder applies for more than one segment, the estimated cost of work will be the sum total of estimated cost of work for the segments against which he has applied”.
- VI. In the para no.19 ii (Award of contract) in Instructions to the Bidders {Section-1}, the following para should be read as :-

“The work shall be awarded to two parties each for Segment No.2 and Segment No.3.

For Segment No.2 (Medium sized cars) & Segment No.3 (Economy Cars), DFCCIL will give approx. 60% of the quantum of work for L-1 and rest 40% of the work will be given to the next eligible bidder on the same rates of L-1 as per the following procedure:-

The counter offer at the same rates of L-1 shall be given to other eligible bidder(s) simultaneously and based on the response received from the these bidder(s) within 07 days of the issue of such counter offer, the remaining work of 40% work shall be awarded to only one tenderer i.e L-2/L-3/L-4 etc.. In case L-2 refuses, the work will be awarded to L-3. If L-3 refuses, the work would be awarded to L-4 and so on”.

- VII. The following rates in the Financial Bid for Segment -2 and Segment-3 stands revised:-

Segment-2 (Medium Segment)

Daily hired vehicles

Rate /km/vehicle for additional kms beyond 100 kms stands revised from Rs.14.70/- to Rs.14.20/-

Segment-3 (Economy segment)

Monthly hired vehicles

Rate /km/vehicle for additional kms beyond 2200 kms stands revised from Rs.12.90/- to Rs.12.30/-.
