EMPANELMENT OF ARBITRATORS/ CONCILIATORS FOR EARNING CONTRACTS IN DFCCIL

Dedicated Freight Corridor Corporation of India (A PSU under Ministry of Railways) invites applications from retired Railway Officers /CPSUS for empanelment of Arbitrators for Commercial/Earning contracts in DFCCIL. Retired Railway Officers /CPSUS meeting the qualification and experience mentioned here under may submit their application to General Manager – Contract Management. Applications complete in all respects may be submitted to this office through post/email.

A) QUALIFICATION AND EXPERIENCE REQUIREMENTS:

1. The person applying for empanelment should be physically and mentally fit (Medical certificate form registered medical practitioner should be submitted).
2. The person should have a minimum age of 50 years and a maximum age of 70 years (Age Proof must be submitted).
3. The person should have experience in dealing with contract matters/disputes for a minimum period of 5 years (Supporting documents should be submitted).
4. The person should be with impeccable reputation and should have cleared from vigilance angle.
5. Persons having experience of Freight Terminal Management, working with multilateral funding agencies and EPC/ PPP Contracts shall be preferred while empanelment.
6. **(a) For Railway Officers:**
 - (i) The person should be retired from Indian Railway Traffic Service and Indian Railway Account Services in Senior Administrative Grade. (Relevant supporting documents should be submitted).
 - (ii) The person should have handled Railway commercial contracts and claims for a minimum period of 5 years in official capacity at Senior Administrative Grade or above (Self-attested CV containing required details must be submitted).
- (b) For CPSUs (such as CONCOR/CRIS/RITES etc.) officers:**
 - (i) The person should have retired from Central Public Sector undertaking in E-8 or above.
 - (ii) Should have worked as GM/Director/MD/CMD of a Schedule 'A' or 'B' CPSU.
 - (iii) Should have handled commercial contracts and claims relating to railways in E-8 Scale or equivalent or above in the CPSUs.

B) DOCUMENTS REQUIRED:

Kindly submit the following documents to apply for Empanelment.

- i) C.V. (Curriculum Vitae)
- ii) Medical Certificate from the registered Medical Practitioner
- iii) Copy of Aadhar Card.
- iv.) Date of Birth with Documentary proof.
- v.) Copy of Pension Payment Order.

C) GENERAL:

1. Applicant will be solely responsible for accuracy of the information furnished by him, for his empanelment as Arbitrators/Conciliator. If at any stage it is found that information furnished applicant is false, DFCCIL will be at liberty to remove his name from the panel of Arbitrators/Conciliator.
