Dedicated Freight Corridor Corporation of India (DFCCIL) is a Special Purpose Vehicle set up under the administrative control of Ministry of Railways to undertake planning & development, mobilization of financial resources and construction, maintenance and operation of the Dedicated Freight Corridors. DFCCIL was incorporated in October 2006 under Indian Companies Act 1956.

In the first phase, DFCCIL will be constructing two corridors- the Western DFC and Eastern DFC- spanning a total length of about 3300 route km. The Eastern Corridor, starting from Ludhiana in Punjab will pass through the states of Haryana, Uttar Pradesh, Bihar and terminate at Dankuni in West Bengal. The Western Corridor will traverse the distance from Dadri to Mumbai, Passing through the states of Delhi, Haryana, Rajasthan, Gujarat and Maharashtra.

DFCCIL will carry out the work including land acquisition.

DFCCIL is desirous to form Panel of Advocates/Law firms at various levels of courts i.e. District Court, High Court, Supreme Court and before Arbitrators comprising of Practicing Advocates and Law Firms to deal with legal issues arises in the organisation.

#### 1. Eligibility:

#### a) Essential:

- i. Lawyers or Legal Firms shall have independent experience as indicated in "Annexure-B" in handling the cases relating to Land matters/Revenue matters/Contractual matters/ Arbitration matters/ Service matters/Company Law matters/Taxation/Labour laws company laws, civil suits, writ matters and constitutional laws in the court applying for.
- ii. They should be currently practicing in the relevant fields.
- iii. They should have independent office set up with library, and clerical staff,
- iv. Copy of Income Tax Returns (ITR) filed for the last three years to be attached.

#### b) Desirable:

- i) Experience of dealing with similar matters preferably in Railways, other Central or State Government Departments, PSU's Local Bodies etc.
- ii) Knowledge of State Laws pertaining to land and revenue.
- iii) Knowledge of translation of documents from Local Language to English.

#### 2. Term:

- i) The currency of the panel will be two years from the date of notification of penal.
- ii) The term can be terminated by giving one month's notice by either side.
- iii) The term can be extended for one year on the basis of satisfactory Performance of the counsel/Firm.

#### 3. Nature of Work:

- The Lawyers or Legal Firms will be required to handle cases in the courts.
- ii) Giving oral and written opinion on issues relating to the transaction of business of DFCCIL and referred to them.
- iii) Legal Vetting of tenders, contracts, documents related to the transaction of business of DFCCIL and referred to them by the DFCCIL.
- iv) Drafting of Legal documents in connection with the business of DFCCIL.
- v) Participation in discussion/conference on behalf of DFCCIL and with their clients.

#### 4. Maintaining Professional Ethics

During the Term of Empanelment and thereafter, the Law Firm/Advocate shall maintain strict confidentiality of the matters pertaining to the DFCCIL. They shall not accept any case against the DFCCIL organization during the terms.

#### 5. Mode of Empanelment.

#### 7) TERMS AND CONDITIONS FOR APPOINTMENT OF ADVOCATES ON DFCCIL PANEL.

- 7.1 Fee for ASGI/AGI and Senior Advocates designated by High/Supreme Courts are not being stipulated as they are engaged in very few important cases only through DFCCIL's panel Advocates and their fee varies from case to case depending upon the importance and question of law etc. of the matter as per the memo raised by them. Fees for such cases may be decided by the MD/Director as per delegation in SOP depending on the merit of each such case.
- 7.2 Clerkage shall be paid at the rate of 10% in addition to fee and same shall not be paid on the charges like misc. expenses, Photostat exp., conveyance/meal expenses and transportation expenses. The final fee bill will be cleared only after receipt of the judgement/decree/final order in the case
- 7.3 Reimbursement of misc. expenses up to Rs. 500/- shall be reimbursed to the counsel without production of details. In case of expenses exceeds Rs. 500/- the counsel shall be required to produce details thereof.
- 7.4 When two or more cases together involve, substantially identical question of law/or fact, one of such cases will be treated as the main case and the other as connected case and the fees in such will be regulated as under, provided the cases are heard together:
  - a. Full fee would be admissible for appearance in the main case and 20% in each of the connected case.
  - b. If substantially identical affidavit, counter-affidavits, plaints, written statement, ground of appeals applications and other pleadings are drafted in connected cases or drafting fee will be admissible in the main case and only 20% separate drafting fee per case will be admissible in connected case, subject to limit of cases as mentioned hereinabove.
- 7.5 For the purpose of payment of fees as per the schedule, the Advocates shall be treated as:

**Senior Advocates:** The panel Advocates having minimum 25 years of practice in the court after the date of enrolment with Bar Council of India as an Advocate and are Income-Tax payee for at least 3 previous financial years shall be treated as Senior Advocates.

**Junior Advocates:** The panel Advocates having minimum 2 years of practice in the court after the date of enrolment with Bar Council of India as an Advocate shall be treated as Senior Advocates.

- 7.6 The conference fee in the fee-schedule shall be subject to the following:
  - a. In general, the conference between the Sr. Advocate and Jr. Advocate Counsel (wherever nominated specially for a case) and between Counsel and DFCC official maximum number of Five (5) such conference will be allowed, comprising two (2) for settlement of pleadings and three (3) during the course of proceedings in a single side.
  - b. However, the high stake/policy matters the number of conference may be increased with the approval of GM/Law.
  - c. In case of conference/briefing of a senior designated Advocate by a DFCCIL empanelled Advocate, the DFCCIL empanelled Advocate shall be paid Conference fee equivalent to the amount of fee for one effective hearing as per the fee-schedule applicable to High Court cases.

- d. Conference fee will be payable only in case of face discussion and not for telephonic conversation/discussion.
- 7.7 Effective Hearing: the effective hearing means, a hearing which either one or both parties involved in a case are heard by the Courts/argues by the Counsel of the parties, Examination-in-Chief and/Cross-Examination is held, issues/charges have been framed, and in addition to above, effective hearing are according to the High Court rules.
- 7.8 Non-effective Hearing: the non-effective hearing means all other hearing other than the ones mentioned in the effective hearing.
- 7.9 The empanelled Advocates shall not accept any engagement against DFCCIL and DFCCIL shall have sole right to use their name as an Advocate.
- 7.10 DFCCIL reserves the right for allotment of legal work, court cases to any empanelled advocate and no claim of any nature will be entertained in this regard. The decision of GM/Law in respect of batch/bunch petitions and settlement of fee will be final and binding and no claim/correspondence of any nature will be entertained in this regard. GM/Law shall be the sole nodal officer for all the purposes/correspondence.
- 7.11 The day-to-day proceedings in the cases assigned to the empanelled advocate shall be intimated in writing or by e-mail to GM/Law.
- 7.12 The advocate shall attend the offices of DFCCIL and Sr. designated Advocates as and when required and shall make their own arrangements for collection of petitions or delivering documents to the Legal Department of DFCCIL.
- 7.13 The performance of empanelled Advocates shall be continuously monitored and examined by the GM/Law and their continuance with DFCCIL shall depend on their performance.
- 7.14 DFCCIL reserves the right to cancel the name of any empanelled Advocate without assigning reason thereof.
- 7.15 These terms and conditions will not be applicable in criminal cases.
- 7.16 GST to be payable shall be borne by DFCCIL subject to rules applicable from time to time.
- 7.17 After completion of case or expiry of tenure or de-panelment of Advocate or decision to withdrawn the case from the Advocate, either on its completion or in between, all such cases/files in the custody of the Advocate will be returned to DFCCIL without any demur and final payment, if any, any will be made after receipt of the relevant documents/files.
